## LEGAL NOTICE

IN EXERCISE of the powers conferred upon the Council of Ministers by Section 140 of the East African Community Customs Management Act 2004 and Regulations 3 and 6 of the East African Community Customs Management (Duty Remission) Regulations, 2008, the Council of Ministers issues this Notice.

**1. Duty remission on inputs used in livestock and poultry farming for Tanzania**
