# **MEMORANDUM**

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. In recent years the volume of work in the High Court has increased with the growth of the population. As the law is at present, not more than two puisne judges can be appointed to the High Court bench. This number is inadequate to cope with the increased volume of work.

3. The object of the Bill is therefore to amend the High Court Act (Cap. 04:02) to enable more judges to be appointed. To avoid constant amendment to the Act in this connexion, it is proposed that the President be empowered to appoint such number of puisne judges as he may consider necessary.

3. The High Court shall consist of the Chief Justice and such number of puisne judges as the President may consider necessary to appoint.".
