

TENDERS ARE invited for the construction, completion and maintenance of a new sewerage reticulation system for the Prisons and Police Housing areas in Francistown.

The work consists of constructing new sewer lines and manholes and connecting the existing buildings into this new system. The whole will then be connected into an existing outfall sewerage system. It will also be necessary to carry out demolition of existing manholes and septic tanks.
