#### **Issue of Commission of Inquiry**

IN ACCORDANCE with the provisions of section 2 of the Commissions of Inquiry Act, it is hereby notified that the President has issued a Commission of Inquiry which shall be composed of —

The Commission shall inquire into the supply of school books and materials to primary schools for the 1990 school year, with particular reference to the selection and performance of IPM (Pty) Ltd as consultants, the selection and effectiveness of successful tenderers, fees paid to and claimed by IPM (Pty) Ltd, whether Government received value for money on this consultancy, and generally to ascertain whether any fault, defect or irregularity was attributable to any person or persons relating to the award or performance of the consultancy contract or of the contracts for the supply of school books and materials as aforesaid.

Public hearings of the Commission shall be held in Gaborone on dates to be announced.

# MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. The purpose of this Bill is to re-enact the Judges (Miscellaneous Provisions) Act by incorporating in the proposed enactment the new salary structure approved by the Government and also to reflect the changes effected when the Constitution was amended to raise the retiring age of judges to 65. The opportunity has also been taken to clarify the provisions of the First Schedule which were rather obscure.

# FIRST SCHEDULE (Section 4(c) and 5(c)

1. The gratuity shall be calculated on the basis of the total emoluments payable to the judge (which expression shall hereinafter include the Chief Justice) in accordance with section 4(a) or section 5(a), as the case may be.

2. The gratuity shall be payable at the rate of 25 per cent for the first tour of the judge's service, 27,5 per cent for the second tour, and 30 per cent for the third and any subsequent tour.

- 3. The gratuity shall accrue and be payable ---
- (a) at the end of each tour of service;
- (b) periodically at such period, being not less than two years, from a date beginning with his assumption of office, or since the last payment of gratuity, as the judge may nominate;
- (c) upon vacation of office by the judge consequent upon reaching the retiring age for judges;
- (d) upon vacation of office by the judge on medical grounds; or
- (e) upon the death of the judge whilst holding office.
