**ROAD TRAFFIC ACT**  
(Cap. 69:01)

**ROAD TRAFFIC (LICENCE EXTENSION) REGULATIONS, 1991**  
(*Published on 4th October, 1991*)

IN EXERCISE of the powers conferred by section 128 of the Road Traffic Act, the Minister of Works, Transport and Communications hereby makes the following Regulations —

1. These Regulations may be cited as the Road Traffic (Licence Extension) Regulations, 1991, and shall be deemed to have come into operation on the 1st October, 1991. Citation and commencement

2. Notwithstanding the provisions of regulation 7 (*d*) of the Road Traffic Regulations, a vehicle licence issued to commence between the 1st October and the 31st December in 1990 shall be valid until the 31st October, 1991. Extension of certain licences
