

A draft of the above Bill, which it is proposed to present to the National Assembly is set out below.

The first amendment is to section 19 of the Act, to remove the entitlement to a refund on the surrender of a motor vehicle licence to the Registrar for cancellation. The second amendment is to enable the Minister, by regulation, to require all vehicles to be re-registered and allocated new registration numbers. This is to enable the introduction of a new style of numbering and new numbers with the aim of countering the high incidence of thefts and the use of forged or false number plates.
