In accordance with the Terms of Reference, evaluation of the technical proposal will be carried out on the basis of the three major criteria namely: relevant experience on similar project of the firm, qualification and experience of the proposed professionals, and their proposed approach and methodology.

The Terms of Reference also specified that the first three technically best ranked consulting firms will be selected and their Cost Proposal will be opened for cost evaluation which will be based on the necessity of various cost elements and reasonableness of the amounts.

After the proposed cots have been evaluated, the final selection of the Consultant will be made based on the lowest evaluated bid.

In view of the foregoing, we feel that a thorough evaluation of the technical proposal for the purpose of ranking is no longer necessary in this particular case and we therefore request the Board to open the Cost Proposal from these three Consulting firms for our further evaluation.

Meanwhile, to ensure that each technical proposal satisfies our prescribed schedule of requirements senior staff of Roads Department will carry out the assessment of the three technical proposals in terms of the quality and sufficiency of the proposed team members in proportion with their man-month input, adequacy of the supporting staff and facilities, task allocation schedule, conformity of their work programme, etc. This exercise will also enable us to identify various elements of the proposals that may require negotiation.
