

**DECLARATION OF ASSETS AND LIABILITIES OF  
MEMBERS OF PARLIAMENT BILL, 1998**

*(Published on 18th December, 1998)*

**MEMORANDUM**

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

On 22nd March, 1996, Parliament passed a resolution to the effect that all Members of Parliament shall, in future, declare their business and financial interests including farming interests and fixed assets.

The object of this Bill is, therefore, to give effect to that resolution passed by Parliament on 22nd March, 1996. And this is being done in the interests of transparency and accountability.

The Bill provides that every Member of Parliament shall make a written declaration of all his or her assets and liabilities and those of his or her spouse and dependent children. The written declaration is to be lodged with the Clerk of the National Assembly who shall be the Registrar of Members' Interests. On receipt of the written declaration, the Registrar is required to enter it into a register to be established as the Register of Members' Interests.

The declaration of assets and liabilities shall be made within 90 days of the coming into force of the Act and subsequently within 90 days of taking and subscribing the oath of allegiance on being elected as a Member of Parliament. Failure to declare or knowingly making false declaration would constitute contempt of Parliament.

The Bill also provides for the appointment by the Committee of Selection of Parliament of a Committee to be called the Committee of Members' Interests. The Registrar of Members' Interest will act as Secretary to the Committee. The Committee will be responsible for ensuring that Members of Parliament comply with the provisions of the Act. It is empowered to investigate any allegation of contravention of any provision of the Act. A contravention of any provision of the Act by a Member of Parliament shall constitute contempt of Parliament.

Short title and commencement

1. This Act may be cited as the Declaration of Assets and Liabilities of Members of Parliament Act, 1998, and shall come into operation on such day as the Minister may by order made by statutory instrument appoint.

Interpretation

2. In this Act, unless the context otherwise requires —  
 “assets” includes any property, moveable and immovable, incomes present and contingent, owned by a Member of Parliament;  
 “child” includes a stepchild and a lawfully adopted child;  
 “the Fund” has the meaning assigned to it under section 12;  
 “liabilities” includes responsibility according to law to satisfy a debt, duty or obligation quantifiable in monetary value, present and contingent;  
 “the Registrar” means the Clerk of the National Assembly appointed under section 6 as the Registrar of Members' Interests.

Declaration of assets and liabilities

3. (1) Every Member of Parliament, that is to say, the President, the Elected and Specially Elected Members of the National Assembly including the Speaker of the National Assembly shall submit to the Registrar a written declaration of his or her assets and liabilities and those of his or her spouse and any unmarried child under the age of 18 years —

- (a) within 90 days after the coming into force of this Act; and thereafter,
- (b) within 90 days of taking and subscribing the oath of allegiance on being elected as a Member of Parliament.

(2) Any subsequent assets acquired or any liabilities incurred by a Member of Parliament shall be declared within 90 days of the acquisition of the assets or incurring of the liabilities, as the case may be, and the Register of Members' Interests shall accordingly be amended.

4. Any Member of Parliament who fails to make a declaration or knowingly makes a false declaration shall be guilty of contempt of Parliament.

Failure to make declaration

5. (1) The Committee of Selection of Parliament shall, at the commencement of the first session of each Parliament, appoint a Standing Committee on Members' Interests (in this Act referred to as "the Committee").

Appointment of Committee of Members' Interests

(2) The Deputy Speaker shall be the Chairman of the Committee.

(3) The members of the Committee shall hold office for the life of the Parliament.

6. The Clerk of the National Assembly shall be appointed as the Registrar of Members' Interests and shall act as Secretary to the Committee.

Appointment of Registrar

7. (1) The Committee shall be responsible for the enforcement of the provisions of this Act.

Functions of Committee

(2) Any allegation that a Member of Parliament has contravened or failed to comply with any provision of this Act shall be made to the Committee which may investigate such allegation.

(3) If the Committee, after considering the allegation, is of the opinion that the Member has contravened any provision of this Act; such contravention shall be deemed to constitute contempt of Parliament.

8. (1) There is hereby established a Register of Members' Interests (in this Act referred to as "the Register") as set out in the Schedule.

Register of Members' Interests

(2) The Registrar shall be responsible for the management and maintenance of the Register.

(3) The Register shall, in respect of a person who ceases to be a Member of Parliament, be closed.

9. (1) The Registrar shall, on receipt of any written declaration made under section 3, enter such declaration in the Register.

Entry of declaration in Register

(2) The Register may be inspected by the Committee upon receipt of a complaint from a member of the public.

10. (1) The Committee may impose any of the following penalties specified in this section on any Member of Parliament who is in contempt of Parliament or has been adjudged to be in contempt of Parliament or has contravened any provisions of this Act, namely —

Penalty

(a) warn or reprimand the Member;

(b) suspend the Member for a period not exceeding 30 sitting days of the National Assembly; or

(c) impose a fine of not more than P1,000.

(2) Where a fine imposed under this section is not paid within 14 days from the date of imposition, the Speaker shall order that the amount be deducted from the Member's emoluments.

11. (1) There shall be established an Appeal Committee which shall consist of the following Members of the National Assembly, namely —

Appeal

- (a) the Speaker of the National Assembly;
- (b) the Leader of the House; and
- (c) the Leader of the Opposition in the National Assembly.

(2) Any Member of the National Assembly aggrieved by a decision of the Committee on Members' Interests may appeal to the Appeal Committee whose decision thereon shall be final.

Establishment  
of Fund

12. (1) There shall be established a Fund to be called the National Assembly Fines Fund (in this Act referred to as "the Fund") which shall be under the control and management of the Speaker.

(2) All fines imposed in terms of section 10 shall, when collected, be paid into the Fund.

(3) The moneys accruing to the Fund shall be disbursed in such manner as may be determined from time to time by the Members of the National Assembly.

**UNWROUGHT PRECIOUS METALS (AMENDMENT) BILL, 1998**

(Published on 18th December, 1998)

MEMORANDUM

A draft of the above Bill, which it is intended to present to the National Assembly, is set out below.

The object of the Bill is to amend the Unwrought Precious Metals Act so as to facilitate the growth of the jewellery manufacturing and jewellery repairing industries and to transfer the President's powers under the Act to the Minister of Minerals, Energy and Water Affairs. The Bill also seeks to remove the provisions creating offences under the Act which are considered unnecessary because similar provisions exist under the Penal Code.

Clause 2 of the Bill seeks to remove the restriction on the amount of unwrought precious metal which a person may have in his possession by allowing jewellery manufacturers and jewellery repairers to be in possession of unwrought precious metal if they have been authorised to do so by the Minister. The clause also seeks to increase the fines which may be imposed for being in possession of any unwrought precious metal unlawfully.

Clause 3 of the Bill seeks to remove the prohibition under the Act against the delivery of unwrought precious metals in payment of a debt, as well as the prohibition against maliciously placing unwrought precious metal in the possession of another. The clause also seeks to remove the provisions regarding accessories after the fact to any offence and attempts to commit any offence.
