PARAGRAPH

1. Citation
2. Prevention of introduction of Covid-19 into Botswana

IN RECOGNITION of the risk posed by the COVID-19 pandemic and in exercise of the powers conferred on the Minister of Health and Wellness by section 80 (1) of the Public Health Act, the following Order is hereby made —

1. This Order may be cited as the Public Health (Prevention of Introduction of Covid-19 into Botswana) Order, 2020. Citation
2. For purposes of preventing the introduction of COVID-19 into Botswana, the provisions of section 80 (1) (c) shall apply with the necessary modifications to citizens and non-citizens resident in Botswana upon entering into Botswana. Prevention of introduction of Covid-19 into Botswana

ARRANGEMENT OF PARAGRAPHS

PARAGRAPH

IN RECOGNITION of the risk posed by the COVID-19 pandemic and in exercise of the powers conferred on the Minister of Health and Wellness by section 80 (1) (a) of the Public Health Act, the following Order is hereby made —

Citation **1.** This Order may be cited as the Public Health (Prohibition of Entry into Botswana) Order, 2020.

Prohibition of entry into Botswana **2.** Any person other than a citizen or a non-citizen resident in Botswana from the countries listed below or any other country that may be added by the World Health Organisation is restricted or prohibited to enter Botswana, at its borders or any specified part of Botswana until further notice —

- (a) Austria;
- (b) Australia;
- (c) Belgium;
- (d) Canada;
- (e) Chechnya;
- (f) China;
- (g) Denmark;
- (h) United Kingdom;
- (i) South Korea;
- (j) France;
- (k) Japan;
- (l) Iran;
- (m) United States of America;
- (n) Germany;
- (o) Italy;
- (p) Netherlands;
- (q) Norway;
- (r) Portugal;
- (s) Spain;
- (t) Sweden;
- (u) Switzerland; and
- (v) India.

Revocation of S.I. No. 31 of 2020 **3.** The Public Health (Prohibition of Entry into Botswana) Order, S.I. No. 31 of 2020 is hereby revoked.
