**DECISIONS AND DIRECTIVES OF THE 9<sup>TH</sup> EXTRAORDINARY SUMMIT OF THE HEADS OF STATE****1.0 APPOINTMENT OF NEW MEMBERS OF STAFF****2.1 Appointment of New Secretary General**

The Summit, in pursuance of the provisions of Article 67 of the Treaty, appointed Amb. Dr. Richard Sezibera Secretary General of the East African Community with effect from 25th April 2011.

*(EAC/SHS EX 9/Decision 01)*

**2.2 Appointment of a New Deputy Secretary General from The United Republic of Tanzania**

The Summit, in pursuance of the provisions of Article 68 of the Treaty, appointed Dr. Enos Bukuku, Deputy Secretary General of the East African Community with effect from 25<sup>th</sup> April 2011.

*(EAC/SHS EX 9/Decision 02)*

**2.3 Appointment of a New Judge of the East African Court of Justice (First Instance Division)**

The Summit pursuant to Article 24(1) of the Treaty, appointed Hon. Mr. Justice Isaac Lenaola, Judge of the East African Court of Justice (First Instance Division) with effect from 1<sup>st</sup> July 2011.

**2.0 CONSIDERATION OF THE REPORT OF THE COUNCIL OF MINISTERS ON THE PROPOSED EAST AFRICAN COMMUNITY SINGLE CUSTOMS TERRITORY**

The Summit directed the Council to table concrete proposals on this matter at the 13<sup>th</sup> Ordinary Summit in November this year.

*(EAC/SHS EX 9/Directive 01)*

**3.0 CONSIDERATION OF THE WAY FORWARD ON THE POLITICAL FEDERATION**

The Summit directed the Council to:

- (a) direct The Team of Experts, (which may be re-constituted as necessary by the Partner States) to formulate concrete and definite proposals on how to address the Fears, Concerns and Challenges on the Political Federation;
- (b) table a Report on this subject at the 13th Summit on November 2011.

**4.0 CONSIDERATION OF THE REPORT OF COUNCIL OF MINISTERS ON THE IMPLEMENTATION OF THE EAC FOOD SECURITY ACTION PLAN (2010-2015) AND THE EAC CLIMATE CHANGE POLICY**

The Summit approved:-

- (a) The East African Food Security Action Plan (2011-2015); and
- (b) The East African Community Climate Change Policy, for implementation by the Council.

**5.0 CONSIDERATION OF A REPORT OF THE COUNCIL OF MINISTERS ON THE EAST AFRICAN DEVELOPMENT BANK**

The Summit directed that a comprehensive brief of the case against the Bank covering the whole period from the onset of the case against the Bank be forwarded to the Secretary General of the East African Community by the East African Development Bank for onward transmission to the Heads of State for consideration.

## 6.0 KEY EMERGING ISSUES

Although this was an Extraordinary Summit, the Summit allowed the Council to report on the following key emerging issues whose implementation is based on decisions/directives taken at the 12<sup>th</sup> Summit held on 3<sup>rd</sup> December 2010.

### 7.1 The Somali Question and Piracy

The Summit:-

- (a) commended the EAC Partner States of Burundi and Uganda for the sacrifices borne out of their efforts to restore stability in Somalia; and
- (b) expressed support for The African Union and IGAD position for a one year extension for the Transitional Federal Government of Somalia to enable that Government to draft a new constitution and intensify its war against the Al-Shabaab terrorist insurgency.

### 7.2 Economic Partnership Agreement (EPA) Negotiations with the European Union

The Summit directed the East African Community Secretariat to negotiate with SIDA to allow a transfer of funds to the Partner States in order to immediately reactivate the EPA Negotiations.

### 7.3 Nile Basin Initiative Question

**The Summit reiterated its readiness to host a Special Summit to advance the negotiations on the Nile Water question with a view to realizing a mutually acceptable solution among all the Riparian States.**

## 8.0 STATEMENT BY THE CHAIRPERSON OF THE SUMMIT

The Chairperson of the Summit congratulated the Partner States for the progress they are making in socio-economic and political development singling out the successful holding of elections in the Republic of Uganda and the continued implementation of a new Constitution in the Republic of Kenya. He also observed the significance of the successful holding of a Referendum on Southern Sudan.

While making an overview of the items on the agenda, the Chairperson, on behalf of the Summit, congratulated the outgoing Secretary General upon his and the East African Community's tremendous achievements during the last five years of regional integration. He assured the incoming Secretary General of the Summit's support as he discharges his responsibilities; he also welcomed the newly appointed Deputy Secretary General (Planning and Infrastructure) and the newly appointed Judge. He further urged the Summit to sustain its role in giving impetus to the further development of the Customs Union and the Common Market; the negotiations on the establishment of a Monetary Union; the implementation of the EAC Food Security and Action Plan (2011-2015) and the EAC Climate Change Policy; and the continued articulation all pertinent issues on the establishment of an EAC/COMESA/SADC Grand Free Trade Area.

The Chairperson invited the Summit to hold the 13th Summit scheduled for November 2011 in Bujumbura, Burundi. The invitation was accepted by the other Heads of State.

The Summit decided to hold the 13th Ordinary Summit scheduled for November 2011 in Bujumbura, Burundi.

EAST AFRICAN COMMUNITY

**DECLARATION OF THE  
9<sup>TH</sup> EXTRAORDINARY SUMMIT OF HEADS OF STATE ON FOOD SECURITY  
AND CLIMATE CHANGE**

**WHEREAS** climate variability and change is a serious global concern and is increasingly impacting negatively the EAC region's ecosystems, the natural resources productivity, people's livelihoods and indeed all development efforts;

**AND WHEREAS** Article 105 of the Treaty for the Establishment of the EAC obligates Partner States to cooperate in the agriculture sector to achieve food security and rational agricultural production including crops, livestock and fisheries within the Community;

**CONSCIOUS OF THE** adverse impacts of Climate Change especially on environment, agriculture and food security in the region;

**CONSIDERING** that the socio-economic development of the region is currently and will for the foreseeable future remain predominantly dependent on our natural resources;

**AWARE** that agricultural production in the region is predominantly rain fed and irrigated accounts only 2.6 % of the arable land in the region;

**CONSIDERING** that over (40% country figures) of total land in the EAC region is occupied with pastoralists and agro-pastoralists, is an arid or semi-arid fragile environment and extremely vulnerable to impacts of climate;

**AWARE** that nutritional status in the region is low with high prevalence of the underweight at 16 % in Uganda, 31 % in Kenya, 33 % in Rwanda, 44 % in Tanzania and 66 % in Burundi and the limited knowledge on good nutrition;

**CONCERNED** that there are high post harvest losses in the food value chain due to inadequate preservation and processing

**COGNIZANT** of the need to enhance the development and implementation of programmes and activities relating to building resilience of communities and their preparedness to respond to the impacts of Climate Change;

**APPRECIATING** the importance of addressing adaptation needs in various sectors which affect the sustainable livelihood of all citizens and development in the region;

**ACKNOWLEDGING THAT**, for the East African Common Market to provide opportunities and benefits to the EAC citizens, it must give priority to the food sub-sector because the majority (70% to 80%) of the people of East Africa are employed in the production, processing and marketing of food commodities and products.

**NOW THEREFORE** we the Heads of State of the Partner States of the East African Community (herein after referred to as EAC) assembled in Dar es Salaam, Tanzania, on this 19<sup>th</sup> day of April, 2011 declare as follows;

**Partner States should:**

**A: Food Security**

1. Immediately implement the EAC Food Security Action Plan.
2. Fast track the:

- (i) development of regional policy for food security;
  - (ii) finalization, adoption and implementation of regional legal, regulatory and institutional framework for standards and Sanitary and Phytosanitary measures (SPS); and
  - (iii) Institutionalization of structured food trading system including contract farming, out-grower schemes, warehouse receipt system and food commodities exchanges.
3. Increase the budget allocation to the agriculture sector to a minimum of 10% of national budgets by 2015 as per the Maputo Declaration directing them to priority programmes and projects for enhancing food security and poverty reduction.
  4. Establish finance and insurance instruments for agriculture development especially for small and medium scale farmers and entrepreneurs.
  5. Immediately invest and develop agro-industries for value-addition of food produce from the EAC region.
  6. Ensure that all food security strategies and actions have in-built resilience to weather variability and adaptation to Climate Change
  7. Ensure development of emergency preparedness and response plans
  8. Ensure that all food security strategies and actions have in-built gender and HIV/AIDS considerations.
  9. Promote development of the dietary guideline among the Partner States.

**B: Climate Change**

1. Adopt a Regional Climate Change Policy to guide Climate Change actions in the EAC region.
2. Strengthen their meteorological and hydrological services.
3. Endorse the establishment of the EAC Climate Change Fund to specifically support adaptation and mitigation activities, including supporting research institutions of excellence in the area of technology development and demand-driven studies especially for Climate Change Adaptation.
4. Develop a mechanism for managing the Climate Change fund and report by the next Summit.
5. Undertake actions to increase funding for Climate Change adaptation.
6. Strengthen the emergency preparedness of the Health Systems to deal with the health impacts of Climate Change.
7. Create special institutional arrangements in the short to medium term, flexible enough to coordinate Climate Change actions by different players.
8. Fast track the ratification of the Protocol on Environment and Natural Resources.
9. Finalize the EAC Climate Change Master Plan within six months and ensures its immediate implementation thereafter.
10. Mainstream Climate Change in all the National Development processes.
11. Ensure that education and public awareness are up-scaled to enhance knowledge on the causes and impacts of Climate Change.

**In order to realize the above objectives we further declare that Partner States should:**

1. Establish funding mechanisms to mobilize adequate resources for the investment and working capital required to meet the objectives set in this declaration and invite all stakeholders including development partners to support the operationalization of the decisions under this declaration;
2. Follow up on the implementation of this declaration and report progress and outcomes to the Summit of Heads of State, annually.
