This invitation for prequalification follows the general procurement notice for this project that appeared in Development Business No. 524 of 16th December, 1999.

The Government of Ghana has received a credit from the International Development Association (IDA) toward the cost of the Takoradi Thermal Plant Project, and it intends to apply part of the proceeds of this credit to payments under the contract for the Prestea-Obuasi Transmission Line Project—Contract TK. The Volta River Authority (VRA) now intends to prequalify contractors and/or firms for design, manufacture, testing, delivery to site, erection and commissioning of the following:

- (a) a 120km 161kV transmission line between Prestea and Obuasi.
- (b) expansion of the Prestea and Obuasi substations to accommodate line terminations.

It is expected that invitations to bid will be made on January 3, 2000.

Prequalification will be conducted through prequalification procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, January 1995 (revised January and August 1996 and September 1997), and is open to all bidders from eligible source countries, as defined in the guidelines.
