#### ENVIRONMENTAL PERMIT FOR GHACEM LTD. (EPA/EIA/0016)

(Bulk Cement Transfer Project in Western Region)

In accordance with the EPA Act, 1994 (Act 490) and the EIA Regulations, L.I. 1652 of 1999, the Environmental Protection Agency (EPA) issued an Environmental Permit on the 7th day of January 2000, authorizing GHACEM Ltd. to commence a proposed Bulk Cement Transfer Project in the Western Region.

**Conditions of Permit**

## 1. Ghacem is to:

- (a) Comply with all mitigation, monitoring and other environmental management provisions in the Project Environmental Assessment Report.
- (b) Comply with the Factories, Offices and Shops Act, 1970.
- (c) Notify EPA on the commencement of the development.
- (d) Notify EPA of any major changes in the planned project development and operation contrary to what is provided in the Project Environmental Assessment.
- (e) Provide an alternative source of drinking water for the Kakuase Community by March 31, 2000. (The community must be involved in the selection of the site).
- (f) Submit an Emergency Response Plan for cement spillage within 3 months (i.e. before March 31, 2000).
- (g) Submit an Annual Environmental Report on the Cement Transfer operations in accordance with Regulations 25 of L.I. 1652.

(2) Notwithstanding this Permit, the project is further subject to other relevant regulations and permits pertaining to the sector and must be observed.

(3) An Environmental Certificate must be obtained after a year's satisfactory performance and compliance with relevant permit conditions, in accordance with Regulation 22 of L.I. 1652.

Failure to comply with or observe all the permit conditions above will render the Environmental Permit invalid.

**PUBLIC NOTICE**  
**ENVIRONMENTAL PERMIT FOR COCA-COLA BOTTLING**  
**COMPANY (GH) LTD. (EPA/EIA/0009)**

In accordance with the EPA Act, 1994 (Act 490) and EIA Regulations, L.I. 1652 of 1999 the Environmental Protection Agency (EPA) issued an Environmental Permit on the 19th day of November, 1999 authorising Coca-Cola Bottling Co. (GH) Ltd. to commence a proposed Bottling Plant expansion in Accra-Tema motorway Industrial Area, Greater Accra Region.

**Conditions of Permit**

## 1. Coca-Cola Bottling is to:

- (a) Comply with all mitigation, monitoring and other Environmental management provisions made in the Project Environmental Impact Statement, including the following:
  - The treatment plant will be lined with a 20 mm reinforced concrete and to prevent effluent pollution of groundwater.
  - process waste water should be treated to meet the stipulated specified limits in particular and EPA guidelines/Standards before discharging into surface waters.
- (b) Comply with the Factories, Offices and Shops Act of 1970.
- (c) Notify EPA on the completion of the expansion phase (i.e. before operation of the expansion plant).
- (d) An intensive monitoring of effluent discharge would be undertaken for an initial period of 30 days, which will be regarded as a trial period after conclusion of the expansion phase of which the treatment plant is an integral part. The trial period would coincide with the commencement of the operation of the expansion programme.
- (e) Submit a comprehensive monitoring and implementation plan for effluent treatment within three months (i.e. before February 29, 2000).
- (f) Submit the company's Environmental Management Plans in accordance with (Regulation 24 of L.I. 1652) within 12 months of permitting.
- (g) Submit an Annual Environmental Report on the Company's operations in accordance with Regulation 25 of L.I. 1652.

(h) The memorandum of understanding between The Coca-Cola and The Wildlife Dept. for the protection of the Sakumono Ramsar Site (i.e. Sakumono Lagoon water quality and sediment control, etc.) against effluent discharges must be submitted before December 31, 1999.

2. Notwithstanding this permit, the Project is further subject to other relevant regulations and permits pertaining to the sector and must be observed.

3. An Environmental Certificate must be obtained after a year's satisfactory performance and compliance with relevant permit conditions, in accordance with Regulation 22 of L.I. 1652.

Failure to Comply with or Observe all the permit condition will render the Environmental Permit invalid.

**(EPA/EIA/0010)**

In accordance with the EPA Act, 1994 (Act 490) and the EIA Regulations, L.I. 1652 of 1999, the Environmental Protection Agency (EPA) issued an Environmental Permit on the 8th day of December 1999 authorising Savanna Cement Co. Ltd. to carry out its proposed Clinker/Cement Production Buipe in the Northern Region.

**Conditions of Permit**

1. Savanna Cement Co. Ltd. is to:

- (a) Comply with all mitigating monitoring and other environmental management provisions made in the Project Environmental Impact Statement (EIS).
- (b) Comply with the Factories, Offices and Shops Act, 1970.
- (c) Notify EPA of any major changes in the planned project development contrary to what is provided in the project EIS.
- (d) The Mining Component must be carried out in accordance with Ghana's Mining and Environment Guidelines, particularly with regard to site reclamation.
- (e) Submit a storm water drainage and retention design/plan within six (6) months (i.e. before June 30, 2000).
- (f) Submit a clear time-bound commitment on the plan to replace and replant the 2km<sup>2</sup> portion of the reserve concession as agreed with the Forestry Department within six months (i.e. before June 30, 2000).
- (g) Submit an Annual Environmental Report on it company's operation in accordance with Regulations 25 of L.I. 1652.
- (h) Submit the Company's Environmental Management Plan in accordance with regulation 24 of L.I. 1652.

2. Notwithstanding this permit, the project is further subject to other relevant regulations and permits pertaining to the sector and must be observed.
