IN THE SUPERIOR COURT OF JUDICATURE IN THE HIGH COURT OF JUSTICE KUMASI ASHANTI

IN THE MATTER OF THE STATUTORY DECLARATIONS ACT, 1971, ACT 389

AND

IN THE MATTER OF A STATUTORY DECLARATION BY NANA AMOA ATURU NKONKONKYIA II, OMANHENE OF MPUASU-JAPEKROM TRADITIONAL AREA AS TO CHANGE OF NAME OF A GEOGRAPHICAL AREA ON MPUASU-JAPEKROM STOOL LAND KNOWN AS "NEW DROBO OR DROBO" TO "JAPEKROM".

I, NANA AMOA ATURU NKONKONKYIA II, the Paramount Chief of Mpuasu-Japekrom Traditional Area in the Jaman South District of the Brong-Ahafo Region of the Republic of Ghana, do hereby solemnly and sincerely declare as follows:

- 1. That I am the declarant herein.
- 2. That I am the Omanhene of Mpuasu-Japekrom Traditional Area and President of the Japekrom Traditional Council.
- 3. That the Capital of the Mpuasu-Japekrom Traditional Area is Japekrom.
- 4. That Nana Bosea Gyinantwi IV, the Paramount Chief of Drobo, a town which is located at the Jaman North District of the Brong-Ahafo Region and situated 32 miles north of Japekrom on the Japekrom-Sampa Road unilaterally and arbitrarily built a settlement at Japekrom on Japekrom Stool land without my consent and initially named same "New Drobo", subsequently dropping the prefix "New" and calling the new settlement "Drobo".
- 5. That this settlement is completely merged with and wholly part of Japekrom.
- 6. That Nana Bosea Gyinantwi IV litigated on behalf of the Drobo Stool with me with the view to claiming title and possession of not only my traditional capital but also all lands forming part of the Mpuasu-Japekrom Traditional Area.
- 7. That in a suit (SUIT NO. LS. 28/96) initiated by the grantor of the Drobo Stool; namely the Assemblies of God Church against a subject of the Mpuasu-Japekrom Stool in 1996 at the High Court, Sunyani to which action the Drobo Stool joined as co-plaintiff and Japekrom Stool joined as co-defendant, the Drobo Stool took over the prosecution of the suit and, through reliefs, claimed against my Stool, that is the Mpuasu-Japekrom Stool, for the following lands:

"...having common boundaries with the Dormaa Paramount Stool, the Berekum Paramount Stool, La Republique de la Cote D'Ivoire and the Stool lands of the Asantehene presently occupied by the Suma and Kwatwoma Paramount Stools..."

- 8. That this claim encompasses the entirety of my Traditional Area including my Traditional Capital, Japekrom.
- 9. That my Stool counterclaimed for:

"...all that piece and parcel of land at Gyaman including the townships of Japekrom, New Drobo and Kwasibourkrom, sharing boundaries with Berekum Stool lands in the South at Nkwadusuam; Dormaa Stool lands in the South-West; Awasu-Dwenem Stool lands in the North-East; Awasu-Dwenem Stool lands in the East; Kwatwoma Stool lands in the North at Adamsu and the La Republique de la Cote D'Ivoire in the North-West for denial by the Defendants of the Plaintiff's title..."

- 10. That the High Court, sitting at Sunyani, on 17th June, 2009, gave judgment in favour of the Japekrom Stool so however that what the High Court described as "New Drobo Township" be given to and retained by Drobo Stool as owner thereof. I attach hereto a copy of the High Court Judgment.
- 11. That being aggrieved and dissatisfied with that part of the judgment, the Japekrom Stool appealed to the Court of Appeal (Civil Appeal Case No.:H1/12/2011). On 27th July 2012, the Court of Appeal sitting at Kumasi unanimously allowed the appeal of the Plaintiff herein (co-Defendant in the Appeal) in the following terms:

"Accordingly we will set aside the part of the judgment which declared the Co-Plaintiff owner of New Drobo Township including the disputed Plot No. 42 Block C in view of the ample evidence that the land on which New Drobo is situated belong to Japekrom. We further set aside the declaration made in the disputed Plot No. 42 Block C in favour of the Plaintiff.

However, we would refuse to allow recovery of possession of New Drobo Township by the Co-Defendant in view of the long occupation of the Drobohene and citizens of Drobo based upon the licence granted the Drobohene by the Co-Defendant. Accordingly, we declare the ownership of the land described in relief 23(a) of the counterclaim in the Co-Defendant. We will however allow the alternative relief (b) and order that the Drobo Stool and all its subjects now in possession of any portion of the Mpuasu-Japekrom Stool Lands seek grants of their respective lands within the Mpuasu-Japekrom Traditional Area in their possession from the Co-Defendant Stool. Since the fortune of the Defendant is tied to the Co-Defendant, his counterclaim equally succeeds. To this extent the appeal of the Co-Defendant is hereby allowed and the cross-appeal of the Plaintiff and Co-Plaintiff refused." I attach hereto a copy of the Court of Appeal judgment.

- 12. That the Drobo Stool (Co-Plaintiff in that suit) being aggrieved and dissatisfied with the decision of the Court of Appeal, appealed to the Supreme Court (Civil Appeal No. J4/49/2015) and on 19th November, 2015, the Supreme Court unanimously dismissed the appeal of the Drobo Stool and affirmed the unanimous judgment of the Court of Appeal. I attach hereto a copy of the Supreme Court Judgment.
- 13. That as the undisputed owner of all lands within the boundaries stated in paragraph 9 above, which include the settlement built at Japekrom recently and arbitrarily by Nana Bosea Gyinantwi IV which he initially named "New Drobo" and later changed to "Drobo", it is my unquestioned prerogative to christen every part of the land as I deem fit.
- That I hereby declare that henceforth, all that settlement built at Japekrom and referred to as "New Drobo or Drobo" on Mpuasu-Japekrom Stool land is known as "JAPEKROM".

15. That henceforth, no part of the area of land declared by the Supreme Court of the Republic of Ghana to belong to the Japekrom Stool shall be known as "New Drobo or Drobo". All that area with the following geographical coordinates: (7°36'30"N, 2°48'20"W), (7°37'02"N, 2°46'36"W), (7°35'19"N, 2°45'56"W), (7°34'45"N, 2°47'25"W), inclusive of Japekrom Township shall be called "JAPEKROM"

 That henceforth, everybody, entity, statutory bodies, institutions, corporate bodies, local government bodies and all are to recognise and address the geographical area encompassing (7°36'30"N, 2°48'20"W), (7°37'02"N, 2°46'36"W), (7°35'19"N, 2°45'56"W), (7°34'45"N, 2°47'25"W), as "JAPEKROM".

17. That all formal documents bearing the name "New Drobo or Drobo" in the Mpuasu-Japekrom Traditional Area or on Mpuasu-Japekrom Stool Land prior to the date of this statutory declaration, however, still remain valid.

18. That the Ministry of Local Government and Rural Development, the Ministry of Planning, Ministry of Regional Re-Organization and Development, the Ministry of Chieftaincy and Religious Affairs, the Brong-Ahafo Regional Coordinating Council, the Regional Town and Country Planning Department, the Jaman South District Assembly and the Electoral Commission of Ghana are to take note and amend their records accordingly.

19. AND I make this declaration conscientiously believing the same to be true in accordance with the Statutory Declarations Act, 1971, Act 389.
