# EAST AFRICA PROTECTORATE.

The following Bill was read a first time at the meeting of the Legislative Council held at Nairobi on March 9th 1908.

> A Bill to provide for the establishment and working of a Savings Bank in connection with the Post Office.

> BE it enacted by the Governor of the East Africa Protectorate with the advice and consent of the Legislative Council thereof:—

1. This Ordinance may be cited as "The East Africa Post Office Savings Bank Ordinance 1908."

2. The Post Master General shall forthwith establish a Post Office Savings Bank at the General Post Office, and may, from time to time, with the approval of the Governor, open Branch Post Office Savings Banks at any Post Office in the Protectorate.

The Post Master General may with the like approval close any Branch Savings Bank.

3. The Post Office Savings Bank shall be under the management and control of the Post Master General, and shall be conducted by such Officer or Officers as the Post Master General may, with the approval of the Governor, from time to time appoint for that purpose.

4. No deposit shall be made or withdrawn of a less amount than one rupee, nor of any sum not a multiple of a rupee: Provided that any depositor may at any time withdraw and receive the whole amount deposited with the interest then due and payable thereon, or any sum that may be due and payable to him for interest upon his deposit, although such deposit and interest or interest may not amount to one rupee or be a multiple of a rupee.

5. It shall not be lawful for the Post Master General or any Officer of the Savings Bank to receive from any one Depositor any sum or sums of money making the amount to which such Depositor will be entitled, exceed the sum of Rupees seven thousand five hundred.

6. Whenever the sum standing in the name of any Depositor amounts with interest to more than Rupees seven thousand five hundred, interest shall be payable on the sum of Rupees seven thousand five hundred, but shall not be payable on the amount by which the sum standing in the name of such Depositor exceeds the sum of Rupees seven thousand five hundred.

7. A Pass Book shall be supplied to each Depositor free of charge. Every deposit received by any Officer appointed for that purpose shall be entered by him at the time of receiving the same in the Depositor's Book and such entry shall be attested by him, and the date stamp of his Office, and the amount of such deposit shall upon

the day of the receipt be reported by such Officer to the Post Master General and except as hereinafter mentioned, the acknowledgment of the Post Master General signified by the Officer whom he shall appoint for the purpose, shall be forthwith transmitted to the Depositor, and the said acknowledgment shall be primary evidence of the amount of such deposit and the date on which it was made. In the case of a deposit of less than ten Rupees, the entry in the Depositor's Book shall be conclusive evidence of title and it shall not be necessary to transmit any such acknowledgment in the case of such a deposit

8. On demand made upon the Post Master General by the Depositor or party legally authorised to claim on account of a deposit made in such form as shall be prescribed in that behalf for repayment of any deposit or any part thereof, the Depositor shall be absolutely entitled to repayment out of the monies in the Post Office of any sum that may be demanded by and due to him, within such period and subject to such formalities as may be

prescribed.

9 No person appointed to carry this Ordinance into effect shall disclose the name of any Depositor, or the amount which may be deposited or withdrawn by any Depositor, except to such person or persons as may be appointed to assist in carrying this Ordinance into operation, or except in pursuance of a direction by a Magistrate or Court of Justice in any proceeding before such Magistrate or Court, or by direction of the Governor, and any person so offending shall forfeit and pay a sum not

exceeding fifteen hundred rupees.

10. The interest payable to parties making such deposits shall be at a rate to be prescribed by the Governor from time to time by Notice published in the Gazette, provided that the said rate shall not exceed three per cent per annum or be less than two per cent per annum, but such interest shall not be calculated on any amount less than ten rupees, or some multiple thereof, and shall not commence until the first day of the calendar month next following the day of deposit, and shall cease on the first day of the calendar month in which such deposit shall be withdrawn or a warrant for withdrawal issued.

11. Interest on deposit shall be calculated to the 31st day of March in every year, and shall be added to

and become part of the principal money.

12. Whenever any Depositor shall make a declaration in such form as may be prescribed that he does not desire to receive interest on the money deposited by him, then in such case the provisions of this Ordinance in so far as they relate to the payment of interest on money deposited shall not apply to such depositor or to any monies deposited by him, and such depositor shall not be entitled to and shall not receive any interest on any monies deposited by him. Provided, however, if any such depositor shall at any time withdraw such declaration in such manner as may be prescribed, then the provisions of this Ordinance relating to the payment of interest upon money deposited shall thereafter apply to such depositor and to the money of the depositor then in the Post Office Savings Bank or thereafter deposited by him in such Bank, but so that interest on the money of the depositor in the said Bank at the time of such withdrawal shall not commence until the first day of the calendar month next following the day of such withdrawal of the aforesaid declaration.

Post Office under the authority of this Ordinance shall as far as practicable be invested in England or elsewhere in such one or more securities yielding interest respectively as His Majesty's Principal Secretary of State for the Colonies shall from time to time approve. Provided always that no part of such monies shall be applied in any way to the purposes of the Protectorate, or be invested in any loan of money raised or to be raised in the Protectorate for any purpose whatever. 14. It shall be lawful to raise any sum or sums of

The monies paid as aforesaid into the General

money that may from time to time be required for the repayment as aforesaid of any deposits made in pursuance of this Ordinance by the sale or sales of the whole or a part of any such securities aforesaid: Provided that if at any time or times the monies arising from such sale or sales shall be insufficient to pay the lawful claims of every such Depositor as aforesaid the Governor shall cause the deficiency to be paid out of the Revenues of the Protectorate.

The income arising from the said securities shall be placed to the credit of the East Africa Protectorate and be applied, so far as such income will permit, in the payment of interest as aforesaid on the deposits made under this Ordinance; and the profits (if any) that may from time to time arise in the execution of this Ordinance shall be carried to the credit of the Revenues of the Protectorate and be deemed part of such Revenue and be applied accordingly.

Deposits may be received from Minors under such conditions as may be prescribed by Rules under this Ordinance and any payment in respect of any deposit or interest thereon which may be made to any Minor in pursuance of any such Rule shall be deemed a valid payment and his receipt shall be deemed a valid receipt.

The Governor may make from time to 17. (1).time and when made may rescind and

alter rules:

for superintending, inspecting and regulating the mode of keeping and examining the accounts of Depositors,

(2)with respect to the making of deposits and to the withdrawal of deposits and

interest,

for determining the receipts which are (3)to be a good discharge to the Post Master General in the case of the payment or transfer of any sum,

providing for the transfer of deposits from one account to another account, whether an existing or a new account,

providing penalties for any breach of (5)the provisions of this Ordinance or of any rule made thereof,

(6)for all or any matters whatsoever connected with the conduct and management of the Savings Bank and

(7)for all other matters incidental to the carrying of this Ordinance into execution.

All such Rules shall be published in the Official Gazette and shall thereafter have the force of law.

An annual account of all deposits received and sums of money paid under the authority of this Ordinance, and of the expenses incurred during the year ended on the 31st day of March, together with a statement of

the total amount due at the close of the year to all Depositors, shall be rende ed by the Post Master General to the Treasurer of the Protectorate not later than the 31st of July ensuing in every year.

19. All expenses incurred in the execution of this Ordinance shall be paid out of the Revenue of the

Protectorate. 20.

In case any depositor shall die leaving any sum of money not exceeding seven hundred and fifty rupees exclusive of interest, deposited in the Savings Bank, and probate of his will, or Letters of Administration or the appointment of Wasi or other order of the Court, be not produced to the Post Master General, or if notice in writing of the existence of a will, and intention to prove the same or to take out Letters of Administration, be not given to the Post Master General at the General Post Office, within the period of three months from the death of the Depositor; or if such be given, but such will be not proved or Letters of Administration be not taken out, and the Probate or Letters of Administration (as the case may be) or other order of the Court produced to the Post Master General within the period of six months from the death of the Depositor, it shall be lawful for the Post Master General after such period of three months or six months (as the case may be), and with consent of the Administrator General (which consent the Administrator General is hereby authorised to give whenever the estate of such deceased Depositor does not appear to be insolvent) to pay and divide such money to and among the persons appearing to be entitled to succeed thereto in accordance with the law for the time being in force in the Protectorate relating to the distribution of intestates property.

(2)When any sum is so paid to or divided among any persons who at the time of such payment, appear to be entitled to succeed thereto, the payment of such sum of money shall be valid and effectual with respect to any demand of any other person against the Post Master General or the Government of the Protectorate.

- 21. In case any depositor shall die leaving any sum of money in the Savings Bank which (exclusive of interest) exceeds the sum of rupees seven hundred and fifty, the same shall only be paid to the Executor or Administrator on the production of the Probate of the Will, or Letters of Administration to the Estate or Effects of the deceased Depositor, or to some other person producing an order of the Court in the respect thereof to the Post Master General.
- If any Depositor shall become insane or otherwise incapacitated to act, and the same shall be proved to the satisfaction of the Post Master General, and if the Post Master General shall be satisfied of the urgency of the case, he may authorise payment, from time to time

No power, warrant or letter of attorney gran ted or to be granted by the Post Master General, or power, warrant or letter of attorney given by Depositor in the Savings Bank to any other person, authorising him to make any deposit of any sum of money in the said Bank on behalf of the said Depositor, or to sign any document or instrument required by the rules or regulations of the said Bank to be signed on making such deposit or to receive back any sum of money deposited in the said Bank, or the interest arising therefrom, nor any receipt nor any entry in any book or receipts for money deposited in the said Bank, nor for any money received by any Depositor, his executors or administrators, assigns, attornies or agents, from the funds thereof, nor any draft or order, nor any appointment of any agent, nor any certificate, or other instrument or document whatsoever required or authorised to be given, issued, signed, made, or produced in pursuance of this Ordinance, or of the rules thereunder shall be subject to or be charged with any stamp duty or duties whatsoever.
- 24. Any sum in the Savings Bank which may remain unclaimed for a period of five years after the date of last deposit or payment, shall be carried to a separate account and the Post Master General shall annually cause the name of the Depositor to be published in three successive issues of the "Gazette" during a period of three years from the first of such advertisement; and if such sum is not claimed within the said period, by any person showing a lawful right thereto the same shall lapse and accrue to the Public Revenues of the Protectorate.
- 25. Interest on any sum so carried to a separate account, shall cease to accrue and be payable as from the first day of the month in which such advertisement first appears.
- 26. In this Ordinance unless the context otherwise requires:
- "Post Master General" means the Officer for the time being lawfully performing the duties of the Post Master General of the Protectorate.
  - "Protectorate" means the East Africa Protectorate.
- "Prescribed" means Prescribed by rules under this Ordinance.
- 27. This Ordinance shall come into operation on such date as the Governor shall by notice in the "Gazette" appoint.

### No. 2 of 1908.

### Fumigation of Imported Plants.

IT is hereby enacted as follows:—

Short title.

This Ordinance may be cited as "The Importation of Plants Ordinance, 1908."

Interpretation of terms.

In this Ordinance the expressions hereinafter mentioned shall have the meanings respectively assigned to them as follows:—

"Plants" includes growing plants, cuttings, buds, and grafts, (a.)bulbs, roots and seeds, and also fruit and vegetables intended for propagation and not for consumption as food.

"Packages" includes boxes, coverings, wrappers or anything (b.)

whatever in which plants are imported.

"Port or place of entry" means any port or place in the (c.)Protectorate appointed by the Governor for the importation of plants.

"Fumigating station" means any port or place of entry at (d.)

which there is a fumigating apparatus.

"Botanical authority" means the officer in charge of the (e.)Botanical Department and includes every person acting in his aid or under his direction.

"Imported" means brought into the Protectorate by any  $(f_{\bullet})$ channel whatsoever.

"Importer" includes the owner and his agents and servants.

The Governor may by Proclamation appoint one or more ports or places

Port of entry.

as ports or places of entry for the importation of plants. Plants imported into the Protectorate, together with the packages in which they are contained, shall, subject to the discretion of the botanical authority, be

Place for impor-

tation.

Fumigating stations

Plants shall not be imported elsewhere than at a port or place of entry.

Suitable apparatus shall be provided at one or more ports or places of entry and such apparatus shall be under the care control and management of the botanical authority.

Process of fumigation.

7. The process of fumigation shall be carried out in such manner and under such conditions as the botanical authority may consider adequate for the destruction of any vegetable or insect pests which may possibly be on such plants, subject to any rules or regulations made by the Governor in that behalf.

Importation at port or place of entry which is a fumigating station.

8. Plants imported at a port or place of entry which is a fumigating station shall (unless section 11 shall apply thereto) be delivered up by the importer to the proper Customs Officer who shall cause them to be conveyed to the place of fumigation there to be dealt with by the botanical authority.

Importation at port or place of fumigating station.

9. Plants imported at a port or place of entry which is not a funigating entry which is not a station shall (unless section 11 shall apply thereto) be forthwith conveyed by the importer subject to such precautions and restrictions as the Governor may by Rules prescribe to the place of fumigating at a fumigating station there to be dealt with by the botanical authority.

Removal of plants after fumigation.

10. Plants imported shall (unless section 11 shall apply thereto) be removed by the owner from the place of fumigation after disinfection immediately upon his being required to do so by the botanical authority.

In the case of packages arriving by post which are declared to contain Importation by plants the post office shall deliver the same to the botanical authority at a fumigating station, and after fumigation the botanical authority shall redeliver the same at the post office and the same shall be forwarded without further postal charge to the addressee.

12. The botanical authority may require the importer to keep him inform-Disposal of plants ed as to the disposal of any plants after fumigation, and may visit and examine after fumigation. them at any time if necessary.

13. No liability shall be incurred by the Governor in respect of any Liability of

damage or loss caused by fumigation.

14. The Governor may make Rules providing for the passage of plants Rules fees and through the Protectorate in transit without fumigation and without passing charges may be made and fixed through a port or place of entry and generally for more effectually carrying the by Governor. provisions of this Ordinance into effect, and may by notice from time to time fix such reasonable fees or charges as he may think fit in respect to the conveyance to or removal from a place of fumigation and the fumigation of any plants or in respect to any matter contained in this Ordinance or any Rules made thereunder.

Any person who commits a breach of this Ordinance shall be liable to Penalties. a fine not exceeding one thousand rupees or imprisonment of either description not exceeding two months or to both. And the Governor may fix such penalties for the breach of any Rule made hereunder as he may think proper not exceeding the foregoing penalties, and where no penalty is imposed by the Rules, the breach or non-observance of any Rule shall be punishable to the extent aforesaid. Any plants imported contrary to the provisions of this Ordinance or any Rules made thereunder and the packages containing such plants shall be liable to be forfeited and may be dealt with as to the Governor shall seem fit.

# No. 3 of 1908.

# Extension of Judgments.

IT is hereby enacted as follows:—

Short title.

1. This Ordinance may be cited as "The Judgments Extension Ordinance 1908.".

Transfer and
Execution of
East Africa,
British Central
Africa and
Zanzibar Decrees
in Uganda

Where a decree has been obtained or entered up in His Majesty's High Court of East Africa or of British Central Africa or in His Britannic Majesty's Court for Zanzibar, or in any Court subordinate to any of such Courts for any debt, damages, or costs, and where it is desired that such decree shall for executed upon the person or property of the defendant in the Uganda Protectorate, such decree may be transferred to His Majesty's High Court of Uganda (hereinafter called the High Court) or to any of the Courts subordinate thereto (hereinafter called subordinate courts) for execution, and the provisions of Chapter XIX of the Indian Code of Civil Procedure for the transfer and execution of decrees shall apply in the same manner as if such decree had been obtained or entered up in one Court and were transferred for execution to another Court within the Jurisdiction of the High Court, and all proceedings shall, and may be, had and taken as if the decree had been a decree originally obtained in the High Court or a Subordinate Court and all the reasonable costs and charges with regard to the transfer and execution of such decree shall be recovered in like manner as if the same were part of the original judgment.

Execution of warrants of above Courts in Uganda.

3. When any warrant is issued by The High Court of East Africa or of British Central Africa or by His Britannic Majesty's Court for Zanzibar or by any Court subordinate to any such Court for the arrest of a defendant in a Civil Case either before or after judgment, a Judge of the High Court or a Subordinate Judge shall have power (a) to endorse and execute such warrant, or, (b) to issue before such indersement provisional warrant for the arrest of the defendance.

issue, before such indorsement, provisional warrant for the arrest of the defen-

dant, upon receipt of such telegraphic or other information and in such circumstances as would in his opinion justify the issue of a warrant in a civil case within his jurisdiction.

Provided that a person arrested under such provisional warrant shall be discharged unless the original warrant is produced and endorsed within such

reasonable time as may in the circumstances seem requisite:

Provided also that no such warrant shall be endorsed or executed and no such provisional warrant shall be issued unless the warrant or information from the Court desiring the arrest is accompanied by an intimation that such Court indemnifies the High Court or Subordinate Court against all costs charges and expenses to be incurred by the High Court or Subordinate Court.

Provided also that the provisions of the Civil Procedure Code for the arrest of defendants before and after judgment shall apply in the same manner as if the suit had been originally instituted in the High Court or a Subordinate Court and provided that all reasonable costs and expenses with regard to proceedings for such arrests shall be recoverable in like manner as if the same had been incurred in the Court in which the suit has actually been instituted.

4. A Judge of the High Court or of a Subordinate Court requesting the Security to be arrest of a defendant under any law similar to this Ordinance which may be taken from enacted in British East Africa, British Central Africa or Zanzibar, shall before to be indemnified. communication with a Court in any of such Protectorates take security from the plaintiff in such sum as shall be sufficient to cover all the costs charges and expenses to be incurred by the Court to which application is made, and shall in demnify such Court against all such costs charges and expenses.

5. The fees to be paid for any process or proceeding under this Ordinance Feet shall be such as may be fixed from time to time by the High Court with the

approval of The Governor.

6. The Governor may by proclamation published in the Gazette extend the Power of Governor provisions of this Ordinance to decrees passed in any other British Protectorate, to extend the Colony, Dependency or possession, and upon the publication of such proclamation all the provisions of this Ordinance with reference to the execution of Protectorates or Colonies.

Africa and Zanzibar shall have as full force and effect with reference to the decrees of the Courts of the Protectorate, Colony, Dependency or possession mentioned in the said proclamation as if such Courts had been mentioned in this Ordinance together with His Majesty's High Court of East Africa and of British Central Africa and His Britannic Majesty's Court for Zanzibar and the Courts subordinate to any of such Courts.

7. The Judgments Extension Ordinance 1905 is hereby repealed.
