GOVERNMENT NOTICE No. 262]

#### NOTICE.

AT THE COUNCIL CHAMBER, WHITEHALL,

THE 19TH DAY OF OCTOBER, 1914.

#### BY THE LORDS OF HIS MAJESTY'S MOST HONOURABLE PRIVY COUNCIL.

WHEREAS it is provided by Section 2 of the Customs (Exportation Prohibition) Act, 1914, that any Proclamation or Order in Council made under Section 8 of the Customs and Inland Revenue Act, 1879, as amended by the Act now in recital, may, whilst a state of war exists, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade :

And whereas there was this day read at the Board a recommandation from the Board of Trade in the following words :-

That the prohibition of the export of the undermentioned articles from the United (1)Kingdom, established by the Order of Council of the 11th September, 1914, be withdrawn from this date :-

Molasses, invert sugar and all sugar and extracts from sugar which cannot be completely tested by the polariscope.

That the prohibition of the export to all destinations of sugar, unrefined, and of (2)sugar, refined and candy, established by the same Order of Council, be

withdrawn so far as regards exports to the following destinations :-

The Channel Islands;

Malta;

Gibraltar

Falkland Islands;

St. Helena;

The East Africa Protectorate;

British West African Colonies and Protectorates.

That the following articles be deleted from the list of articles prohibited from (3)being exported to foreign ports in Europe and on the Mediterranean and Black Seas with the exception of those of France, Russia (except Baltic ports), Belgium, Spain and Portugal, established by His Majesty's Proclamations of the 5th and 20th August, 1914, and by the Order of Council of the 25th September, 1914 :-

Uniform clothing;

Men's marching and shooting boots;

Heliographs;

Horse and pony shoes;

Graphite.

That the export of the following articles to foreign ports in Europe and on the (4)Mediterranean and Black Seas with the exception of those of France, Russia (except Baltic ports), Belgium, Spain, and Portugal be prohibited, viz :-

Undressed goat skins;

Sheep skins, woolled (i. e. with the wool left on);

Graphite, suitable for the manufacture of crucibles.

That the export of the following articles be prohibited to all foreign ports other than those situated in His Majesty's Dominions, Colonies not possesing (5)· Responsible Government, Possessions and Protectorates :-

Woollen and worsted yarns;

All woollen and worsted cloth, without pattern (except women's dress stuffs and cloth manufactured from merino wool,) if suitable for uniform clothing ;?

Uniform clothing;

Cardigan jackets, woollen jerseys, woollen gloves, woollen socks, and men's woollen underwear of all kinds;

That the export of the following articles be prohibited to all destinations : (6)

Compasses other than ships' compasses;

Signalling lamps operated by electricity, and capable of being used for signalling Morse or other code; Men's heavy boots;

Horseshoes;

Heliographs;

Woollen waste;

Woollen rags applicable to other uses than manure, pulled or not;

Woollen tops;

Woollen noils; NOW THEREFORE, Their Lordships having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved. Whereof the Commissioners of His Majesty's Customs and Excise and all other persons

whom it may concern, are to take notice and govern themselves accordingly.

FOR purposes of Martial Law the following shall be the boundaries of Mombasa Military area :--

Commencing at Kipini up the Tana River to Engatana thence in a straight line to Loga Hill, thence in a straight line to Mackinnon Road Station on the Uganda Railway, thence to Pika Pika Hill, and thence in a straight line running due South to the border of German East Africa.

## 64] RULES. The Indian Post Office Act, 1898.

ISSUED by His Excellency the Governor under the provisions of the Indian Post Office Act, 1898.

Nairobi,

Dated this 18th day of November, 1914.

#### PART I.-Registration.

1. A publication may be registered as a newspaper for transmission by the Inland Post subject to the following conditions :----

- (a) Application must be made by the Proprietor, or by his duly authorised representative, to the Postmaster General of the East Africa and Uganda Protectorates, and must be accompanied by a copy of the publication and a fee of Rs. 3-75 cents.
- (b) The publication must have the full title and date of each number printed at the top of the first page and the whole or part of the title and the date of publication printed at the top of every subsequent page.
- (c) The registration shall expire with the termination of the calendar year in which it is made, or renewed, unless a written application for renewal together with a copy of the current issue of the publication and a further fee of Rs. 3-75 be received by the Postmaster General of the East Africa and Uganda Protectorates during the first 15 days of December of each year, and such renewal is accepted by him.
- (d) The Postmaster General of the East Africa and Uganda Protectorates may refuse to register as a newspaper a publication printed and published elsewhere than in the East Africa Protectorate or the Uganda Protectorate unless arrangements have been made to his satisfaction for maintaining a responsible representative of the publication in one or other of the two aforementioned Protectorates.

#### PART II.—Transmission.

2. The conditions of transmission of newspapers by the Inland Post, that is to say from any place within the East Africa and Uganda Protectorates to any other place within either of those Protectorates shall be as follows :---

(a) Rates of Postage.—The prepaid rate for a newspaper (as defined in Section IX of the Indian Post Office Act, 1898, and duly registered as such at the Office of the Postmaster General of the East Africa and Uganda Protectorates) shall be as follows :—

A packet containing two or more registered newspapers is not, however, chargeable with a higher rate than would be chargeable on a book packet of the same weight.

If posted unpaid, or insufficiently prepaid, newspapers are chargeable with double postage or double the deficiency as the case may be. Weight and Dimensions.—A newspaper or packet of newspapers may not weigh

- (b) Weight and Dimensions.—A newspaper or packet of newspapers may not weigh more than five pounds or exceed 2ft. in length and 1ft. in width or depth.
- (c) Every newspaper or packet of newspapers shall be posted either without a cover or in a cover open at both ends, so that the same can be easily removed for the purpose of examination.
- (d) Every newspaper when posted shall be so folded and covered (if posted in a cover) as to permit the title to be readily inspected.
- (e) No article not part of the newspaper shall be posted in or in the same cover with the newspaper except an extra or supplement as specified in the definition given in Section IX of the Indian Post Office Act, 1898.
- (f) No newspaper and no cover of a newspaper shall bear anything (not being part of the newspaper) except :---
  - (i) The names, addresses and descriptions of the sender and addressee with index or reference numbers and letters.
  - (ii) The words "with compliments."
  - (iii) The title of the newspaper, and a reference to its registration for transmission by post.
  - (iv) A reference to any page of or place in the newspaper to which the attention of the addressee is directed.
  - (v) A request for return in case of non-delivery.

3. Any publication not registered as aforesaid, and any registered newspaper in respect of which any of the foregoing rules be infringed shall, if posted or tendered for transmission by Post, be charged with postage as a book packet or parcel whichever treatment involves the lowest charge : provided that any newspaper containing a communication of the nature of a letter, or bearing such communication either on the newspaper or the cover thereof, shall be charged with postage as a letter.

4. These Rules may be cited as "The Post Office (Newspaper) Rules, 1914."

#### **UNDER MARTIAL LAW.**—Central Committee of Supplies.

NO Sales or purchases of cattle, sheep or goats are permitted save through or under permits from the Director of Veterinary Services, his representatives, or Officers of the Administration.

Such permits shall only be issued after due consideration of the military requirements. All sheep or goats from Masailand or the Northern Frontier District shall be presented for inspection at the Government Livestock Depot, Naivasha.

All sheep or goats from Kamasia and Baringo shall be presented for inspection at the Government Livestock Depot, Nakuru.

After inspection all sheep or goats rejected as unsuitable for military requirements will be branded on the face with a circle brand and permission will be granted for their sale.

No livestock shall leave Masailand via the Ngong port of exit unless under special permit granted by the Director of Veterinary Services or his representative.

Offences against this notice will be dealt with under Martial Law.
