GOVERNMENT NOTICE No 118

THE INDIAN EXPLOSIVES ACT, 1881

RULES

IN EXERCISE of the powers conferred upon him by the Indian Explosives Act, 1884, as applied to the East Africa Protectorate and of all other powers him thereunto enabling His Excellency the Acting Governor has been pleased to make the following Rules —

1 The Rules may be cited as “The Explosive (Blasting Powder) Amendment Rules, 1920,” and shall be read as one with “The Explosive (Blasting Powder) Rules, 1919,” hereinafter referred to as “the Principal Rules”

2 Anything in the Principal Rules to the contrary notwithstanding licences to possess Blasting Powder at such places as shall be approved, and if the quantity to be possessed at the same time does not exceed 50 lbs may be granted to a person for his private use and not for sale by the District Commissioner of the district in which such person resides subject to such conditions as the District Commissioner may prescribe and in particular subject to the following conditions —

(a) Every application for a licence under this Rule shall be submitted to the District Commissioner and shall clearly set forth the description of Blasting Powder required, the purpose for which it is to be used, the situation, character and construction of the building in which the Blasting Powder is to be kept

(b) Every licence granted under this Rule shall be in the form contained in the Schedule hereto annexed, and shall be subject to the conditions prescribed therein

CONDITIONS

1 This licence is given subject to the provisions of the Indian Explosives Act, 1884, as applied to the Protectorate and the Rules issued thereunder

2 The Blasting Powder shall be kept in a building exclusively appropriated for the purpose and detached from a dwelling-house, and at a safe distance from any road, public thoroughfare or public place, made and closed so as to prevent any unauthorised persons having access thereto, and to secure it from danger from without

3 No person shall smoke in any part of the building

4 No person under the age of 16 years shall be employed in or enter the building except in the presence and under the supervision of some grown-up person

5 Nothing in this licence contained shall authorize the licence holder to store Blasting Powder contrary to the provisions of any Township Rules

GENERAL NOTICE No 364

THE MUNICIPAL CORPORATIONS ORDINANCE, 1909

IN EXERCISE of the powers conferred upon them by the Municipal Corporations Ordinance, 1909, the Municipal Council of Nairobi, with the approval of His Excellency the Acting Governor, have made the following Bye-laws —

1 These Bye-laws may be cited as 'Nairobi Township (Scaffoldings) Bye laws, 1920'

2 The Town Clerk shall have power by written notice addressed to the party responsible to prohibit and stop the erection, use, or employment, and to order the alteration or removal of any crane, scaffolding, staging or shoring in or connected with the construction and erection, or the demolition, alteration, repair, or securing of any new or existing building, or in or connected with any excavation for the purpose of any building operations, where such crane, scaffolding, staging, or shoring is, or is likely to be, in the judgment of the Town Clerk, a source of danger

Any person not complying with the terms of such a notice shall be guilty of an offence

GENERAL NOTICE No 360

THE CROWN LANDS ORDINANCE, 1915

SALE OF LAND IN THE DISTRICT OF NAIROBI

CROWN LANDS OFFICE, NAIROBI

NOTICE is hereby given, in respect of the LANDS in the schedule hereunder, that the same are to be sold by public auction in the Public Office of the Crown Lands Office, Nairobi, on the 14th day of April, 1920, at 11 o'clock in the forenoon.

Plans of the lands to be sold are to be seen at the Public Map Office, at the Lands Office, Nairobi, or may be obtained from the above office on payment of 2/- per plan.

The interest in the lands to be sold from the auction is to be sold as follows:

CONDITIONS

1. Every person who bids and purchases (and British subjects) require the consent of the Government in writing.)

2. Each plot shall be auctioned separately.

3. The highest bidder shall be the purchaser, and, if any dispute arises as to any bidding, the plot shall be put up again at the next undisputed bidding.

4. The amount of the advance of each bidding shall be regulated by the auctioneer and no bidding shall be retracted.

5. Each purchaser shall pay to the auctioneer immediately on the fall of the hammer a deposit of 20% of his purchase money. In default of such payment the plot may be immediately re-offered for sale and any subsequent bid by the person who has made default may be ignored or refused.

6. The balance of the purchase money may be paid in full on the issue of the lease or may be paid by four equal annual instalments payable on the first day of January in each year, the first of such instalment to be paid on the first day of January, 1921. The purchaser shall also pay interest at the rate of 8 per centum per annum on the unpaid portion of the purchase money, such interest to be paid on the first day of July, 1920, and subsequently on the first day of January in each year. Unless each such instalment and the interest on the unpaid portion of the purchase money is paid on the date on which it falls due they shall be deemed to be added to the annual rent reserved in the lease and shall be payable and recoverable as such.

7. The lease shall be for 99 years and shall commence from the 1st day of July, 1920, and the rent shall be payable from that date.

8. No building shall be erected on any plot unless plans, drawings, elevations and specifications thereof shall have been previously submitted to and approved by the Land Officer or such other person as he may appoint.

9. The Lessee shall further submit a block plan of the plot with the position of the building clearly defined and showing a system of drainage, which shall satisfy the Medical Officer of Health, for properly dealing with the surface water on the plot and, before any building may be occupied, the Lessee shall satisfy the Medical Officer of Health that such system of drainage has been properly constructed.

10. Each Lessee shall suitably connect his premises with any town drainage system when in the opinion of the Medical Officer of Health such drainage shall be so far completed as to enable the Lessee reasonably so to connect.

11. The Government or such person as may be appointed for the purpose shall have the right to enter upon any plot and lay and have access to water, gas and service pipes, telegraph or telephone wires and electric mains of all descriptions over any unoccupied ground and the Lessee shall erect any building in such a way as to avoid interference with any existing routes, main or service pipes or telegraph or telephone wires and electric mains as mentioned.

12. Every purchaser shall bear the cost of all expenses of registration and survey fees, and all other expenses if any connected with the purchase of the plot.

13. The purchaser shall erect on his plot within 3 years of the completion of the lease a building (or buildings) of such a nature as to be suitable for the purpose of the lease.

14. At no time during the term of the lease shall any building erected on the plot be used for the purpose of a public dwelling house.

15. At no time during the term of the lease shall any plot or any portion thereof or any building erected on the plot be used for the purpose of carrying on any of the trades specified in the schedule hereto.

INVITATION FOR TENDERS FOR AN AREA OF LAND
CONSIDERED SUITABLE FOR THE PRODUCTION
OF SUGAR CANE

UNDER instructions from the Secretary of State, tenders are invited under the following conditions for the purchase of the lease of an area of 6716 acres of land considered suitable for the production of sugar cane described in the schedule hereto and situate on the Uganda Railway between Kibigori and Kibos at an altitude of about 4000 feet

1 The lease will be for a term of 99 years from the 1st September 1920, at an annual rental of £44-15-4 payable either at the office of the Crown Agents for the Colonies in London or the Land Office, Nairobi, on the 1st of January in each year

2 Ten per cent of the purchase price together with proportionate rental to the 31st December, 1920, must be paid forthwith by the successful tenderer and the remainder by 9 equal yearly instalments on the 1st January in each year

Survey fee, registration fee and stamp duty as stated in the schedule hereto must be paid at the Land Office, Nairobi, upon the issue of the lease

3 The premises to be used for the purpose of growing, cultivating and manufacturing sugar and purposes ancillary thereto

4 The Lessees to covenant to expend £50,000 upon cultivation, buildings and plant for the production of sugar to the satisfaction of the Land Officer

5 Prior to the fulfilment of condition No 4 above the Lessees shall not assign or sub-lease the whole or any part of the premises without first obtaining the consent in writing of the Governor of the East Africa Protectorate
