GENERAL NOTICE No. 290.

INSTRUCTIONS TO GOVERN THE APPLICA-TION OF THE NATIVE AUTHORITY AMENDMENT ORDINANCE, 1920.

1. THE following rules to apply only to labour ordered cut for the full period of 60 days (for work outside its own district).

(a) The District Commissioner issuing the order shall make out a list in quadruplicate of the men sent out to work. Two shall be sent to the Department employing the labour, and two retained by the District Commissioner. On arrival of the men at their destination the officer employing them shall retain one list and return the other to the District Commissioner duly corrected to show deserters and receipted. The District Commissioner shall amend his own two ts to agree and hand one copy to the Chief supplying the labour, who shall be instructed to not return at the expiration of two months. The other copy shall be sent to the Assistant Registrar of Natives for special entry.

(b) The copy retained by the District Commissioner shall be filed in a special file cover, forming a loose-leaf record open to public inspection.

(c) The Assistant Registrar shall also file his copy similarly for record, and shall enquire on the expiration of the period whether the labour has been returned.

(d) Any officer detaining natives over 60 days will be reported by the District Commissioner to the Chief Native Commissioner who will report direct to the Governor.

(c) The employer shall sign off the native's certificate or if not registered his "Record of employment" at the end of the 60 days period.

(f) The employer shall report to the District Commissioner who ordered the men out the date on which the men are returned and shall send them back in charge of a responsible headman.

(g) District Commissioners shall exercise a careful discretion with regard to the men who are ordered out and shall eliminate any who in their opinion shall show good cause for remaining in the Reserve.

(h) The period of 60 days shall begin from the day the man starts work, but in no case later than the 8th day from the date on which the man was registred on contract in the Reserve.

(i) "60 days" shall be interpreted to mean a period of "60 days" and not 60 working days.

(j) No man shall be detained at work for a longer period than 60 days unless he desires so to remain, in which case his employer must make a fresh contract with him before a Magistrate and inform the District Commissioner of the man's district accordingly.

2. The following rules apply only to labour ordered out under the conditions specified below:—

(a) When labour is required for (1) work in its own district for 60 days or shorter period or (2) work in its own Province for a shorter period than 60 days, the District Commissioner may with Provincial Commi sioner's approval order out such labour without reference to the Chief Native Commissioner's Office and without making out quadruplicate list required in Rule 1 (a). In such case the employer shall on the completion of the period for which the labour is required, if shorter than one month give each man a chit stating the number of days he has worked and if longer than one month, enter such period on the man's Registration certificate. (b) A careful record of all labour so supplied shall be kept by the District Commissioner and a Return thereof sent to this office at the end of every month.

(c) Every man so ordered out shall be informed that 60 days work gives him exemption from the operation of the Ordinance for a year.

PROPOSED FORM OF CONTRACT UNDER THE MASTER AND SERVANTS ORDINANCE, 1910.

MEMBERS of the public are invited to submit criticisms of the undermentioned Form of Contract to the Acting Chief Native Commissioner, P.O. Box 322, Nairobi. The new form is intended to avoid the ambiguities contained in the existing Form of Contract, but is not applicable to contracts under the Resident Natives Ordinance.

1. Length of engagement. Contracts in excess of one month to be expressed both in working days and calendar months in the proportion of 6 working days to 8 days of the calendar month. e.g., to be for 8 calendar months or 180 working days whichever is completed first.

2. Place of employment.

3. Nature of service.

4. (1) Wages—Amount and how payable—Fls. per 25 or 26 working days and 4 or 5 Sundays according to the length of the month payable on completion of each calendar month from the date on which employee arrives at place of employment or

(2) Fls.....payable on completion of each 30 day labour card. Provided that in neither case shall the employer pay for less than 15 working days in each calendar month unless the employeee shall be wilfully absent from duty.

5. Food (Kinds and quantities) to be supplied at Employer's expense.

6. Blanket, Cooking Pots, etc., to be supplied at Employer's expense.

7. Accommodation to be supplied at Employer's expense.

8. Amount of food or money to and from place of engagement to be supplied at employer's expense.

- 9. Other Conditions:
 - (1) Employee to be returned at Employer's expense to the place of engagement from nearest station to place of employment, or
 - (2) Employer to make all reasonable arrangements for return of employee by road.
 - (3) In fuel-cutting contracts the following condition to be inserted:—"*Nature of Service*.—Cutting within ½ mile of line only, unless trolley supplied, to a distance of 2 miles up and down line from Camp."
