No. 42 of 1921.

### An Ordinance to impose a Tax on Dangerous Petroleum.

BE it enacted by the Governor of the Colony of Kenya with the advice and consent of the Legislative Council thereof:-

1. This Ordinance may be cited as "The Dangerous Short title. Petroleum Tax Ordinance, 1921."

2. The term "Dangerous Petroleum" means dangerous Definitions, petroleum as defined by "The Indian Petroleum Act, 1899," as

applied to the Colony.

The term "Colony" means the Colony and Protectorate of Kenya.

There shall as from the 1st day of January, 1922, be Tax to be paid

charged, levied and paid to the general revenue of the Colony on imported dangerous by any person importing into the Colony for sale or consumption petroleum. therein dangerous petroleum a tax at the rate of twelve and a half cents a gallon on all dangerous petroleum so imported.

4. The Governor-in-Council may make Rules for securing Powers to make the payment of the tax on dangerous petroleum and generally for carrying into effect the provisions of this Ordinance.

5. Any person acting in contravention of this Ordinance or Penalties. of the Rules made thereunder shall be guilty of an offence and shall be liable to a fine not exceeding fifty pounds or in default of payment to three months simple imprisonment; or if payment of the tax has been avoided by such contravention of the Ordinance or Rules, an additional penalty not exceeding three times the amount of the tax so avoided.

### An Ordinance to Amend the Customs Ordinance, 1910.

BE it enacted by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof:

1. This Ordinance may be cited as "The Customs (Amend- Short title. ment) Ordinance, 1921," and shall be read as one with the Customs Ordinance, 1910, hereinafter referred to as "the Principal Ordinance.

2. In this Ordinance the term "Colony" shall mean the Interpretation. Colony and Protectorate of Kenya.

3. Section 144 of the Principal Ordinance is hereby amended Amendment to Section 144 of the Section 144 of the by the addition of the following proviso:

"Provided that the Governor may extend the period of six months herein mentioned in cases where he is satisfied that there is good cause for the delay in passing the merchandise through the Colony in transit.'

4. Section 153 of the Principal Ordinance is hereby Amendment to Section 153 amended by the addition of the words at the end of the section of the Principal Ordinance. 'subject to the proviso to Section 144 of the Principal Ordinance.'

5. Where under the Principal Ordinance, or any Ordin-Invoices to be ance amending the same, invoices are required to be produced in duplicate. to an officer of Customs they shall, if so required by the Commissioner, be in duplicate and one copy, or if only the original is produced then the original, may be retained and filed as the Commissioner may direct provided that the Commissioner shall cause the name and address of the supplier to be removed from such criginal or duplicate supplied and to be destroyed.

An Ordinance to Provide for the Grading and Inspection of Agricultural Produce to be Exported by Sea and Generally for the Better Regulation of the Preparation and Manufacture of Same.

BE it enacted by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof:-

Short title.

1. This Ordinance may be cited as "The Agricultural Produce Export Ordinance, 1921" and shall come into operation on such date as the Governor-in-Council shall declare by Proclamation in the Gazette.

Interpretation of terms.

- 2. In this Ordinance unless the context otherwise requires "Agricultural produce" or "product" means meat or any product thereof, milk products, eggs, margarine or butter substitutes, and further includes any article whatever produced or derived from farming operations which the Governor-in-Council may from time to time by Proclamation in the Gazette declare to be agricultural produce for the purpose of this Ordinance.
- "Brand" when used as a verb means to stamp, mark, label or in any other manner distinguish by concrete or visible sign; and, when used as a noun, has a corresponding meaning;

'Export' means export by sea from the Colony and Protectorate of Kenya for purposes of sale thereout;

"Director" means the Director of Agriculture; "Inspector" means a person generally or designated by the Director to examine or grade or both examine and grade agricultural produce intended for export or to examine animals the produce whereof is intended for export.

3. No person shall export or cause or permit to be exported, or attempt to export from any prescribed port, any agricultural produce for which rules are made unless and until such produce

has been inspected, or inspected and branded, in manner prescribed by such rules. 4. No person shall export, or cause or permit to be exported,

or attempt to export: The produce of any animal intended for human consumption, which is infected with any disease rendering such produce unfit for such consumption; or

(b) Agricultural produce intended for human consumption which at the time of presentation for export is unfit for such consumption; or

(c) Agricultural produce which owing to its condition or for any other reason is unlikely to be brought to its destination in a sound or good marketable state.

The question whether any produce is or is not in such a condition as would render it subject to the prohibitions contained in this section shall be determined by the Inspector according to the instructions given generally or specifically by the Director.

- 5. (1) Whenever an Inspector has ground for believing that any animal is to be slaughtered and that the meat thereof is intended for export, he may, if such animal is found to be so infected with disease as to render the meat unfit for human consumption, cause it to be seized and slaughtered and the carcase thereof dealt with or disposed of as he may determine, but in such a manner that such carcase cannot be used either for human consumption or as food for animals: Provided that any monies received from such disposal shall, after deduction of the expenses incidental thereto, be paid to the owner of the carcase.
- (2) If any agricultural produce intended for human consumption is found at the time of inspection under this Ordinance or of its presentation for export, to be unfit for such consumption, an

Prohibition of export of agricultural produce by sea without inspection,

Prohibition of export of produce which is unsound.

Seizure and destruction of diseased animals and of agricultural produce intended for export.

Inspector may cause it to be seized and destroyed or otherwise dealt with or disposed of, but in such manner that such produce cannot be used for human consumption or food for animals: Provided that any monies received from such disposal shall, after deduction of the expenses incidental thereto, be paid to the owner of the produce.

6. (1) No person shall export or cause or permit to be exported Sanction and or attempt to export any meat or any produce thereof unless the Abattoirs and abattoir or slaughtering place used for the slaughter of the animal slaughtering places from which such meat is to be taken is a place sanctioned by the dairies, etc.

Director as fit for the purpose. (2) No person shall export or permit to be exported or attempt to export any milk products, compositions or substitutes thereof unless the dairy, factory, creamery or premises where such products, compositions or substitutes are collected, prepared or

stored are premises sanctioned by the Director as fit for such

There shall be allotted to all premises sanctioned under the preceding sub-section a registration certificate and number, and the holder of the registration certificate for these premises shall have the exclusive right to use that registration number for the purpose of designating the milk products manufactured at such premises.

7. The sanction given by the Director under Section 6 Withdrawal of hereof may be at any time withdrawn by him if it appears that Sanction. such premises and places are not being kept in such a condition or do not possess such appurtenances or facilities as will enable the person using them to comply with the provisions of this Ordinance.

For the purposes of this Ordinance every Inspector and Powers of entry on any person generally or specially authorized in writing by or on behalf of the Director, may at all reasonable times enter any premises in which is kept or suspected of being kept for export, any agricultural produce, or premises in which any animal is kept the produce whereof is intended for export, and may examine any part of such premises or any receptacle or package therein.

9. The Governor-in-Council may from time to time by Pro. Prohibitions, limitations, clamation in the Gazette:

Prescribe the specific designation under which any (1)particular kind of agricultural produce may be exported and define each such kind of produce;

(2) Prescribe the percentage of impurity and the maximum amount of moisture which may be present in different kinds of

grain intended for export;

(3) Prescribe the standards of composition and fix the maximum percentage of moisture, salt, preservatives or other substitutes in milk products, margarine and butter substitutes intended for export, and prohibit the export of any such article in which the prescribed requirements are not maintained;

(4) Prohibit the export of agricultural produce which has been so treated, as to give it the appearance of an article of different commercial value.

10. The Governor-in-Council may make rules, not incon-Rules. sistent with this Ordinance to provide for the following matters relating to agricultural produce intended for export, namely:-

(1) The inspection of animals the produce of which is intended for export and the inspection of the premises in which animals are slaughtered, or in which produce is prepared, manufactured or otherwise dealt with;

The time and place at which, and the manner in which notice of intention to export shall be given, the manner of packing, the size, description, quality and material of the receptacles to be used, the weight of the contents and the marking of such weight and of the receptacles;

(3) The time and place at which delivery of the produce shall take place at the port of shipment;

(4) The place and manner of storage, the conveyance, and the treatment of any produce;

(5) The inspection of produce, the fixing of grades, the place and manner of inspection and of grading and branding of any produce and the manner in which different designations or grades of produce shall be branded or indicated whether on the receptacle or on a certificate of the Inspector or otherwise;

- (6) The percentage which shall be inspected in any one consignment;
- (7) The temperature at which conveyance by rail and shipment of the produce shall take place;
- (8) The abstraction or removal of samples by an Inspector for examination, inspection, or analysis;
- (9) The circumstances under which different kinds of produce may be accepted or rejected, and degraded, regraded or rebranded by an Inspector after examination and inspection:
- (10) The circumstances under which and the conditions on which produce inspected and graded may be withdrawn from shipment;
- (11) The forms of notices, certificates and other documents to be used or issued for the purposes of this Ordinance;
- (12) The fees which shall be paid by the owner or the consignor of animals or produce for inspection and for grading; and generally for the better carrying out of the objects and purposes of this Ordinance.

Differing rules may be made under this section to apply to different kinds of agricultural produce.

- 11. (1) Any person who obstructs, resists or hinders an Inspector in the lawful exercise of his powers or duties under this Ordinance or any Proclamation or Rule issued thereunder shall be guilty of an offence and liable on conviction to a fine not exceeding £50.
- (2) Any person who fails, within the time required by an Inspector, to remove any produce from any place of inspection, reception or shipment whenever such removal is so required shall be guilty of an offence and liable on conviction to a fine not exceeding £5 for every day during which the offence continues.
- 12. (1) Any person who forges or utters knowing it to be forged, any certificate or brand or label, or any writing or signature required by or provided in this Ordinance, shall be guilty of an offence and liable on conviction to the penalties prescribed by law for the crime of forgery.
- (2) Any person who wilfully applies to agricultural produce intended for export a certificate or invoice or label or warranty given in relation to any other agricultural produce shall be guilty of an offence, and liable on conviction to imprisonment, with or without hard labour, for a period not exceeding 12 months.
- (3) Any person who with intent to deceive issues a written warranty or invoice, label or certificate or notification in respect of agricultural produce intended for export shall, if such written documents falsely describe such produce or are false in any other material particular, be guilty of an offence and liable on conviction to the penalties prescribed by law for the crime of cheating.
- 13. Any person who contravenes any provision of this Ordinance or of any Proclamation or Rule issued thereunder, or makes default in complying with any such provision with which it is his duty to comply shall, if no penalty is specially provided for the contravention or default, be liable in the case of a first conviction to a fine not exceeding £100, and in the case of a second or subsequent conviction, to a fine not exceeding £250, and in default of payment in either case to imprisonment not exceeding six months.
- 14. If any person is aggrieved by any decision of, or action taken by an Inspector under this Ordinance, the Inspector shall, if required by such person, state in writing the reasons for his decision or action and the matter shall thereupon be referred to a Board which shall be appointed by the Director or at his request, by a Resident Commissioner, Resident Magistrate, or District Commissioner. The decision of the Board in the matter shall be reduced to writing and shall be final. Before the matter is referred to the Board, the person aggrieved shall deposit with the Inspector such a reasonable amount as, in the Director's opinion, will be sufficient to defray the expenses which will necessarily be incurred by the Board, but the amount so deposited shall be refunded to such person if his contention is upheld by the Board.

#### An Ordinance to Traffic amend the Motor Ordinance 1915.

BE it enacted by the Governor of the Colony of Kenya with the advice and consent of the Legislative Council thereof:-

- 1. This Ordinance may be cited as "The Motor Traffic Short title (Amendment) Ordinance, 1921," and shall be read as one with the Motor Traffic Ordinance, 1915, hereinafter called "the Principal Ordinance.'
- 2. Section 2 of the Principal Ordinance is hereby amended by the insertion of the following words after the word "than" in line 4 thereof:-"road rollers and."
- 3. Section 3 of the Principal Ordinance is hereby amended User and driver of by the addition of the words "user and driver" after the word unlicensed motor car to "owner" in the first line thereof by the insertion of the word be liable to penalty. "owner" in the first line thereof, by the insertion of the word, "severally" before the word "liable" in line 5 thereof, the addition of the words "or in default to imprisonment of either description for a term not exceeding one month" to the sixth line thereof and by repealing the proviso and substituting the following therefor: Provided that no motor car or carriage duly licensed for any particular year or half year in the Uganda Protectorate and imported from that Protectorate shall be required to be licensed under this Ordinance during the year or half year as the case may be in which it was so imported.

Amendments to Section 7 of the Principal

Ordinance.

4. Section 7 of the Principal Ordinance hereby amended:

(1) By the addition of the following words to sub-section (1) thereof:

"and shall be fixed to and exhibited on the vehicle in respect of which it is issued in such manner as may be prescribed by Rules made by the Governor-in-Council, provided that a licence issued for a vehicle without rubber tyres shall not be required to be so affixed.

- (2) By the insertion of the words "within the Colony and Protectorate of Kenya" after the word "Carriage" in the second line of sub-section (3) thereof and the deletion of the words "licensed under this Ordinance."
  - (3) By the addition of the following sub-section:
  - "(4) In the event of any licensee losing his licence he shall apply to the Licensing Officer for the issue of a duplicate licence and a fee of Fl. 1 shall be charged by the Licensing Officer for the issue of such duplicate licence.
- Section 9 of the Principal Ordinance is hereby repealed Scale of fees. and the following section substituted in lieu thereof:-
  - "9. The fees set forth in the fourth Schedule hereto annexed shall be payable in respect of any licence for a motor car or carriage or in respect of any other matter or thing for which under this Ordinance fees are payable.'
- 6. Section 10 of the Principal Ordinance is hereby amended Amendments to Section as follows:-
  - (1) By the deletion of sub-section (3) thereof:

- (2) By the deletion of the figure 4 in sub-section (4) thereof and the substitution of the figure 3 therefor:
  - (3) In sub-section (5) thereof:
  - (a) by the deletion of the figure 5 and the substituting 4 therefor:
  - (b) by the deletion of the words "annual fee as the Governor-in-Council may prescribe" and substituting therefor the words "the annual fee set out in Schedule 4 hereof:
    - (c) by the addition of the following proviso:
    - "Provided that any car used under such general identification mark shall not carry more than two persons in addition to the driver."

Driving Certificate of Royal Automobile Club not to be recognised as certificate of competency in the Colony and Protectorate of Kenya.

7. (1) Section 11 (1) of the Principal Ordinance is hereby amended by inserting the words "on any public thoroughfare" after the word "car" in line 1 thereof, and by deleting the words "the provisions of the Motor Traffic Ordinance, 1910," in line seven thereof and substituting therefor the words "any law in force in that Protectorate," and by the deletion of the words "or unless he shall hold a Driving Certificate issued by the Royal Automobile Club," in lines eight and nine thereof.

Age at which certificate of competency may be granted, reduced to 16 years.

(2) Section 11 (3) of the Principal Ordinance is hereby amended by the substitution of the word "sixteen" for "eighteen" in the second line thereof and by the substitution of the word "fourteen" for the word "sixteen" in line four thereof.

Amendment consequential on amendment of Section 11 (1) of Principal Ordinance.

8. Section 12 (1) (b) of the Principal Ordinance is hereby amended by deleting the words "the provisions of the Motor Traffic Ordinance, 1910," and substituting therefor the words "any law in force in that Protectorate" in line three thereof and by deleting the words "or a driving certificate issued by the Royal Automobile Club" from the 4th and 5th lines thereof.

- 9. Section 15 of the Principal Ordinance is hereby amended:-
- (1) By the deletion in sub-section (vii) of the words "sunset and sunrise" and the substitution of the words "6.15 p.m. and 5.45 a.m." therefor.
- (2) By the deletion of sub-section (x) and the substitution of the following sub-section therefor.
  - "(x) The driver of a motor car shall in the case of a breakdown remove from the public thoroughfare any portion of the car obstructing the passage of other traffic."
- (3) By the addition to sub-section (xviii) of the words "or in default to imprisonment of either description for a period not exceeding 14 days."

Foreign certificate and licences.

10. The provisions of Sections 3, 11 and 12 of the Principal Ordinance as amended in respect of Uganda Certificates and licences may be applied by the Governor-in-Council by Proclamation in the Gazette to certificates and licences issued in any neighbouring territory.
