THE EAST AFRICA TOWNSHIPS ORDINANCE, 1903.

PROCLAMATION.

IN EXERCISE of the powers conferred upon me by the East Africa Townships Ordinance, 1903, I, Edward Brandis Denham, Companion of the Most Distinguished Order of Saint Michael and Saint George, Governor's Deputy of the Colony and Protectorate of Kenya, do hereby declare that the area described in the Schedule hereto shall constitute the Township of Machakos, and further, that the descriptions of the area of the said Township, as contained in the Proclamations, dated the 2nd May, 1906, and the 15th December, 1920 (No. 155), are hereby cancelled and revoked.

SCHEDULE.

DESCRIPTION OF BOUNDARIES OF MACHAKOS TOWNSHIP.

Commencing at the most Westerly corner of L.O. No. 1791 (Machakos Industrial School) on the River Igieni (Mtoni) which forms the South-western boundary of that portion;

thence bounded by the centre of the course of that river down-stream for about 800 feet to a point bearing 92° 23′ 24″ from a Beacon approximately 210 feet therefrom;

thence Westerly bearing 272° 23′ 24″ through that Beacon for a distance of approximately 6286 feet to a Beacon;

thence South-easterly bearing 144° 14' 22" for approximately 1369 teet to a Beacon;

thence South-westerly bearing 209° 26′ 33″ for appr ximately 6732 feet to a Beacon;

thence Southerly bearing 189° 06′ 33″ for about 6800 feet to the River Murongoni;

thence by the centre of the course of that river up-stream to the North-east corner of L.O. No. 358;

thence Easterly bearing 96° 38′ 08″ for approximately 2200 feet to a Beacon;

thence still Easterly bearing 83° 38′ 31″ for approximately 6690 feet to a Beacon;

thence North-north-easterly bearing 14° 15′ 15″ for approximately 6101 feet to a Beacon;

thence Easterly bearing 91° 02′ 32″ for approximately 2195 feet to a Beacon;

thence Southerly bearing 177° 14′ 03″ for approximately 1754 feet to a Beacon;

thence Easterly bearing 90° 57′ 44″ for approximately 2003 feet to the River Igieni;

thence by the centre of the course of that river down-stream to the point of commencement.

The foregoing boundaries are delineated, edged red, on Land Surveys Boundary Plan No. 18 deposited at the Land Survey Office, Nairobi, a copy of which is on record at the District Commissioner's Office, Machakos.

SCHEDULE.

I. SHIMBA FOREST.

The forest known as the Shimba Forest and delineated by lines edged green on Land Survey Boundary Plan No. 17, Sheet 1.

GENERAL DESCRIPTION OF FOREST BOUNDARIES.

Commencing at the Trigonometrical Beacon Mwele;

thence bounded by a straight line Northerly to the junction of the two principal sources of the Mamolo River;

thence by the centre of the course of that river down-stream. to its junction with the Cha Shimba River;

thence by the centre of course of the latter river downstream to the bridge carrying the Mombasa water supply pipe line thereover;

thence by a straight line South-easterly to a Beacon on the Southern bank of the said river;

thence by a surveyed line in a South-easterly direction through the Trigonometrical Beacon Shimba to its intersection with the Northern boundary of the existing Kwale Forest Reserve (L.O. No. 4411);

thence Easterly by part of that boundary to Beacon 11;

thence by a straight line due South to a foot-path in the vicinity thereof;

thence by that foot-path in a South-easterly and Southerly direction to a Beacon;

thence for 200 feet on a true bearing of 168° 51′ 02" to another Beacon;

thence Easterly to Beacon 1 on the Eastern boundary of the existing Kwale Forest Reserve;

thence by straight lines South-easterly through Beacons 32 and 31 to Beacon 30;

thence by straight lines South-westerly through Beacon 29 to Beacon 28;

thence by a straight line South-westerly to the Trigonometrical Beacon Longo Magandi;

thence by a straight line still South-westerly to the Trigonometrical Beacon Machade;

thence by a straight line more Westerly to the point of commencement.

The Pemba Native Reserve (L.O. No. 4412), which lies entirely within the foregoing boundaries, is excluded from this Forest Area.

II. Gogoni Forest.

The forest known as the Gogoni Forest and delineated by lines edged green on Land Survey Boundary Plan No. 17, Sheets 1 and 2.

GENERAL DESCRIPTION OF FOREST BOUNDARIES.

Commencing at the South-west corner of L.O. No. 4821;

thence bounded by the Southern boundary of that portion in the most Southern corner on the generally Westerly or Northwesterly boundary of L.O. No. 5035;

thence in a generally Westerly and South-westerly direction by part of that boundary to the most Easterly corner of that portion;

thence Northerly by part of the Eastern boundary of L.O. No. 5004 to the point of commencement.

III. BUDA (MAFISINI) FOREST.

The forest known as the Buda Forest the boundaries of which are as delineated by lines edged green on Land Survey Boundary Plan No. 17, Sheets 1 and 3.

Rules.

IN EXERCISE of the powers so conferred by the Diseases of Animals Ordinance, 1906, and by the General Revision Ordinance, 1924, Section 27, the Governor's Deputy-in-Council has been pleased to make the following Rules:—

- 1. These Rules may be cited as "The Diseases of Animals (Scale of Fees) (Amendment) Rules, 1924," and shall be read as one with the Diseases of Animals (Scale of Fees) Rules, 1922, hereinafter referred to as "the Principal Rules" and all amendments thereof.
- 2. The Schedule to the Principal Rules, under the heading "Laboratory Products," is hereby amended by the addition of—

Sheep Pox Vaccine, per dose ... Shs. 00 Cts. 05

THE DISEASES OF PLANTS PREVENTION ORDINANCE, 1910.

REGULATIONS.

IN EXERCISE of the powers so conferred by the Diseases of Plants Prevention Ordinance, 1910, Section 2, and the General Revision Ordinance, 1924, Section 27, the Governor's Deputy-in-Council has been pleased to make the following Regulations:—

- 1. These Regulations may be cited as "The Diseases of Plants Prevention Regulations, 1924."
 - 2. In these Regulations:
 - (a) The word 'Ordinance' shall mean the Diseases of Plants Prevention Ordinance, 1910;
- (b) The word "Pest" and "Disease" shall respectively mean insect pest and plant disease.

 General.
- 3. The Director of Agriculture may appoint Inspectors for the purposes of these Regulations.
- 4. The importation of plants and seed into the Colony will only be permitted as hereinafter provided.
- 5. An Inspector may enter upon any lands. nurseries, or other places where he has reason to believe there is any pest or disease or where he has reason to believe there is any plant or seed which may prevent the proper control of any pest or disease.
- 6. An Inspector may cause any plant or seed to be detained until it can be examined; any detention shall be at the risk of the owner thereof, and any Inspector detaining any such plant or seed shall notify such owner or his agent, where possible, of such detention.
- 7. An Inspector may give such instructions as he may consider necessary for the treatment or destruction of any plant or seed, or the container thereof, which he may suspect to be infected with, or to constitute an obstacle to the proper control of, any pest or disease. Such instructions shall be complied with by the owner or person in possession of such plant, seed or container. An Inspector may cause such treatment or destruction to be carried out at the expense of the owner or person in possession of such plant, seed or container should either of those persons fail to carry out such instructions.
- 8. The Director of Agriculture may prohibit the movement within the Colony of any plant or seed which is diseased, or which he may suspect of being diseased or likely to spread disease.

- 9. Any owner or occupier of land who shall become aware of the existence of a disease or a pest upon such land shall forthwith notify the Director of Agriculture thereof and shall also send him specimens of such disease or pest.
- 10. No person shall sell, offer for sale, or in any way dispose of or receive any plant or seed, if the same is infected with any pest or disease.
- 11. Any person who without lawful cause obstructs an Inspector in the discharge of his duties under these Regulations, or refuses to permit an Inspector to examine any plant or seed, or who refuses to carry out the instructions of an Inspector relative to the proper control of any pest or disease, shall be guilty of an offence and shall, on conviction, be liable to a fine not exceeding Shs. 2,000 or in default of payment thereof to imprisonment of either description for a term not exceeding three months.
- 12. The Director of Agriculture may permit the admission into the Colony, for scientific purposes, of any plant, seed, pest or disease.
- 13. Any plant or seed, or the container thereof, may be destroyed with or without compensation. The rate of any compensation to be paid shall be determined by the Director of Agriculture.

Importation of Plants, etc.

- 14. All plants and seed imported into the Colony shall be examined by an Inspector.
 - 15. (a) Any package or parcel containing any plant or seed imported otherwise than by post, shall be delivered to an Inspector by the Customs Department at the place of importation.
 - (b) Any package or parcel containing any plant or seed imported by post shall be delivered to an Inspector by the Postal Department.
 - (c) After examination and treatment (where necessary) such package or parcel shall be returned by such Inspector to the Customs or Postal Department as the case may be, for delivery to the addressee, except where such package, parcel, plant or seed is destroyed under the instructions of such Inspector.
- 16. No compensation shall be paid in respect of any package, parcel, plant or seed destroyed under Regulation 15 (c).
- 17. Any package or parcel containing any imported plant or seed must bear on the outside thereof a label on which shall be set forth the following particulars:—
 - (a) The full name of the kind and variety and the place of origin of such plant or seed; and
 - (b) The name and address of the nursery or person supplying such plant or seed.
- 18. Except under a permit signed by the Director of Agriculture first obtained and in accordance with any special condition which may be stated on such permit, the importation of the following is prohibited:—
 - (a) Peach stones.
 - (b) Apple or Pear stocks or cuttings. The term "stock" shall include young rooted plants for budding or grafting purposes.
 - (c) Potatoes. Permission, however, to import seed potatoes from the United Kingdom will be granted if
 - (1) The variety thereof is included in a list published by the Ministry of Agriculture of England and Wales of varieties immune from wart disease (Synchytrium endobioticum);
 - (2) The consignment thereof is accompanied by a certificate, under the seal of either of the Boards of Agriculture of England, Scotland, or Ireland, that no case of wart disease has been reported within a radius of five miles from the place where the tubers thereof were grown; and
 - (3) Such consignment is accompanied by a declaration on oath by the consignor thereof that all the tubers of such seed potatoes were grown in the place mentioned in such certificate.

- (d) Citrus trees and Citrus fruits other than Citrus fruit grown on the Islands of Zanzibar and Pemba.
 - (e) Gooseberry and Current (Ribes). Stocks or cuttings.
 - (f) Sugar Cane.
 - (g) Buckthorn and Barberry.
 - (h) Onion and Leek seed.
 - (i) Vines or Vitaceæ.
 - (i) Tea seeds or plants.
- (k) Coffee plants, whether living or dead, coffee beans or coffee (except roasted coffee beans, ground coffee and coffee extract). This prohibition shall not extend to:—
 - (1) Coffee plant, coffee beans, and coffee imported for transit through the Colony, which may be so imported subject to the following conditions:—
 - (i) Coffee plants, coffee beans, and coffee must be securely packed in cases or in double bags of substantial sacking, separately sealed to the satisfaction of the Director of Agriculture and the Commissioner of Customs.
 - (ii) Every case or cover containing such plant, bean or coffee must be sealed or stencilled in a prominent position thereon by a Customs Officer showing the country of origin and the place of importation, and no such case or cover shall thereafter be opened within the Colony.
 - (iii) Should any case or cover containing such plants, beans, or coffee become so damaged in course of transit through the Colony as to render it possible for any such plant, bean, or coffee to escape therefrom, such case or cover or any such plant, bean, or coffee there in or therefrom may, at the discretion of the Director of Agriculture, be destroyed. No compensation shall be payable in respect of such destruction.
 - (2) Trade samples of coffee beans or coffee, not exceeding one half pound in weight, imported through the Department of Agriculture.

Any coffee plant, coffee bean or coffee imported in contravention of this clause shall be liable to be detained and destroyed or otherwise dealt with as the Director of Agriculture may direct.

- (l) Cotton seed except in transit for re-export. Permission, however, to import cotton seed will be granted if:
 - (1) Imported into the Colony for use therein through. Kilindini, Mombasa or any other port or place of entry as may be approved by the Director of Agriculture on the application of the importer.
 - (2) The consignment thereof is accompanied by a certificate under the seal of the Department of Agriculture of the country from which it is consigned to the effect that it has been fumigated within one month before consignment to the Colony or that it is free from pest or disease.

All cotton seed unaccompanied by a certificate as specified in Sub-clause (2) hereof shall be delivered by the importer or his agent to an Inspector for fumigation at the port or place of entry (or elsewhere as may be directed by the Director of Agriculture) and shall be removed by the importer or his agent immediately after such fumigation.

Any cotton seed imported in contravention of this clause may be detained and destroyed or otherwise dealt with as the Director of Agriculture may direct.

Coffee Plantations.

- 19. An Inspector may enter upon any lands on which he has reason to believe that any coffee bush is growing, for the purpose of inspecting the same.
- 20. Whenever an Inspector shall consider that any coffee bush is infected with any pest or disease or that the condition of any coffee bush or the state of any land on which any coffee bush is growing is such as may give rise to any pest or disease, he may:—
 - (a) If such land is occupied, require, in writing, the owner or occupier thereof to take such action with regard to such land or any coffee bush or bushes thereon as he may consider necessary or advisable to control or eradicate any such pest or disease or to prevent the spread of any such pest or disease, or

- (b) If such land is unoccupied or appears to such Inspector to be unoccupied, treat or destroy any or all coffee bushes thereon, as to him may seem necessary or advisable.
- 21. (a) Whenever under the powers conferred by Regulation 20 an Inspector shall require an owner or occupier to take any particular action with regard to any land or any coffee bush thereon he shall specify a period as may seem reasonable to him within which such action shall be completed.
- (b) If such owner or occupier shall fail to carry out such requisition, such Inspector may cause such treatment or destruction to be carried out at the expense of such owner or occupier.
- (c) Service of such requisition sent by post to such owner or occupier (or to the manager or person appearing to such Inspector to be the manager of such land) shall be deemed to be good service upon the owner or occupier.
- (d) If such owner or occupier to whom such requisition is made shall fail to complete such action within the time so specified, he shall be guilty of an offence and shall on conviction, be liable to a fine not exceeding Shs. 2,000 or in default of payment thereof to imprisonment of either description for a term not exceeding three months.
- 22. The Regulations mentioned in the Schedule hereto are hereby cancelled.

THE MUNICIPAL CORPORATIONS ORDINANCE, 1922.

EAST AFRICAN CURRENCY BOARD.

THE following regulations are published for general information.

REGULATIONS DEFINING THE CONSTITUTION,
DUTIES AND POWERS OF THE EAST AFRICAN
CURRENCY BOARD.

- 1. The East African Currency Board has been constituted to provide for and to control the supply of currency to the Colony and Protectorate of Kenya, the Uganda Protectorate and any other Dependencies in East Africa which may be added by the Secretary of State, to ensure that the currency is maintained in satisfactory condition, and generally to watch over the interests of the said Dependencies so far as currency is concerned.
- 2. The members of the Board and the Secretary are appointed by the Secretary of State.
- 3. The Board will have power to appoint officers for the discharge of such duties in connection with currency in the United Kingdom or in East Africa, and at such rates of salary as the Board may think fit, subject in each case to the approval of the Secretary of State.

- 4. The Board will, in accordance with Section 9 of the East Africa and Uganda (Currency) (No. 2) Order-in-Council, 1920, take over the powers, rights, duties, assets, and obligations of the Currency Board established for the purposes of the East Africa and Uganda (Currency) Order-in-Council, 1905.
- 5. The Board is authorized to incur expenditure necessary for the due performance of such duties as are now or may be hereafter assigned to them.
- 6. The Board will have authority to make all necessary arrangements for the minting of any special coins authorized for circulation in the said Dependencies, and to comply with applications for the supply of any coins at the time being legally current in those Dependencies. Subject to the provisions of these regulations and of any legislation from time to time in force in East Africa, they may provide, and may issue and re-issue in East Africa, notes hereinafter referred to as currency notes. They will arrange for the supply of currency in exchange for the coins and notes at present current in the Dependencies so long as these remain legal tender.
- 7. The Board may charge for coin or currency notes to be delivered in East Africa against prepayment in London such premium above the nominal value (at the rate of ten florins to the pound), not exceeding the actual cost of transporting specie (packing, carriage, insurance), as they may think fit, and may vary the charge from time to time within this limit. If coin or notes are delivered on telegraphic order to East Africa, the Board may increase the premium as they think fit.
- 8. The Board will, when required, arrange for the issue against silver or notes tendered in East Africa of drafts payable in sterling in London at a charge not exceeding the cost of transporting specie from East Africa to London, and may at their discretion issue telegraphic transfers on London on such terms as they may think fit.
- 9. Currency notes may be for such denominations as may be fixed by the Board.
- 10. The plates from which the currency notes are printed shall be of such designs and shall bear such devices as the Secretary of State shall approve, and shall be prepared by a person selected by the Board. The Board shall be responsible for their safe custody.
- 11. The currency notes shall be printed on such paper as may be approved by the Board, and shall be authenticated by facsimiles of the signatures of the members of the Board for the time being.
- 12. The Board shall make such arrangements as they may from time to time think necessary or proper for the cancellation of notes which have become unfit for further use, for the destruction of such cancelled notes, and for recording the issue and cancellation of notes.
- 13. Profits on the issue of silver coin, nickel bronze coin and currency notes shall, after the necessary deductions have been made for expenses of administration, be allocated at the discretion of the Board between the funds hereinafter referred to as "the Silver Coinage Fund," "the Nickel-Bronze Coinage Fund" and "the Note Guarantee Fund."
- 14. Expenditure in connexion with the manufacture, issue and redemption of coin or notes, and also any losses which may be incurred, will be debited at the discretion of the Board against the respective funds. In case of necessity each of the three funds shall be available to support the others.

- 15. Subject to the provisions of paragraph 20 of these Regulations, the Board may invest their funds in securities of the Government of any part of His Majesty's Dominions, or in such other manner as the Secretary of State may approve.
- 16. The Board shall submit half-yearly to the Secretary of State a statement of the position of the Coinage and Note Guarantee Funds on the last day of the half-year.
- 17. If the proportion borne to the total face value of the notes in circulation by that portion of the Note Guarantee Fund which is held in current coin in East Africa (hereinafter referred to as the coin portion of the fund) falls below a limit to be fixed from time to time by the Secretary of State, the Board shall take all practicable steps to restore the proportion as soon as possible.
- 18. The Board shall cause to be published half-yearly in the Government Gazette of the Colony and Protectorate of Kenya an abstract showing (a) the whole amount of currency notes in circulation on the last day of the half-year; (b) the amount of the coin portion of the Note Guarantee Fund on the said day; (c) the nominal value of, the price paid for, and the latest known market price of the securities forming the investment portion of the Note Guarantee Fund.
- 19. The accounts of all the transactions of the Board will be audited by the Colonial Audit Department.
- 20. The Board will submit annually for the approval of the Secretary of State a statement of their transactions during the preceding year.
- 21. When the Board are satisfied that their reserves are more than sufficient for all the purposes for which such reserves may be required, they may, with the approval of the Secretary of State, pay over the whole or any part of the surplus amount in aid of the revenues of the Dependencies in East Africa in such proportions as may be hereafter determined.
