#### AT THE COURT AT BUCKINGHAM PALACE,

#### The 25th day of June, 1925.

#### PRESENT,

#### THE KING'S MOST EXCELLENT MAJESTY IN COUNCIL.

WHEREAS by Treaty, grant, usage, sufferance, and other lawful means, His Majesty the King has jurisdiction within the dominions of His Highness the Sultan of Zanzibar :

AND WHEREAS by an Order of His Majesty in Council bearing date the eighth day of December, 1924, and known as the Zanzibar Order in Council, 1924, provision was made for the exercise of His Majesty's jurisdiction within the said dominions, and it was declared, amongst other things, that there should be a High Commissioner for the Zanzibar Protectorate and that appointments to the said office should be made by Commission under His Majesty's Sign Manual and Signet, and also that there should be an officer in the Protectorate styled "British Resident in Zanzibar" who should be appointed by Commission under His Majesty's Sign Manual and Signet :

AND WHEREAS it is desirable to make other provision for the exercise of His Majesty's jurisdiction within the said dominions :

NOW, THEREFORE, His Majesty, by virtue and in exercise of the powers in this behalf by the Foreign Jurisdiction Act, 1890, or otherwise in His Majesty vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows :--

#### PART I.---PRELIMINARY.

1. This Order may be cited as "the Zanzibar Order in Council, 1925."

The limits of this Order are the Islands of Zanzibar and Pemba, including the territorial waters thereof, and any islets within those waters, which islands and waters are in this Order (except when the context requires a different construction) included in the expressions "Zanzibar" or "the Protectorate." 2. On and after the date of the coming into operation of this Order the office of the High Commissioner for the Zanzibar Protectorate shall cease to exist and the powers and authorities conferred upon the said office under the provisions of the above-recited Zanzibar Order in Council, 1924, or any other Order applying to Zanzibar shall be exercised by the British Resident for the Protectorate,

3. The clause defining "The High Commissioner" in Article 3 of the Zanzibar Order in Council, 1924, is hereby revoked.

4. Articles 7, 8, 9, 10, 11, 12, 14, 15, 17, 18, 21 and 33 of the Zanzibar Order in Council, 1924, are hereby revoked, without prejudice to anything lawfully done thereunder, and the aforesaid Zanzibar Order in Council, 1924, shall henceforth be construed and take effect as if, instead of Articles 7, 8, 12, 14, 15, 17, 18, 21, and 33, the following Articles had been inserted therein :—

"7. There shall be a British Resident for the Zanzibar Protectorate, and appointments to the said office shall be made by Commission under His Majesty's Sign Manual and Signet. Such British Resident shall act in His Majesty's name and on His behalf and represent His Majesty's Crown and authority in matters occurring within the Zanzibar Protectorate, and further shall take all such measures and do all such matters and things as in the interest of His Majesty's service he may think expedient, subject to such instructions as he may from time to time receive from His Majesty or through the Secretary of State."

"8. During a vacancy in the office of the British Resident or in the case of his absence or incapacity by reason of illness or otherwise the powers of the British Resident shall be vested in such person as His Majesty may appoint under His Sign Manual and Signet, or if there be no such person so appointed, or if such person be absent from the Protectorate or unable to act, then the person for the time being discharging the functions of Chief Secretary to Government or some other officer whom the Secretary of State may designate shall act provisionally as British Resident, provided that the British Resident, during his passage to and from any place included in the Protectorate or when, in the exercise or discharge of any powers or duties by this Order or otherwise conferred or imposed upon him by His Majesty or by the Secretary of State he is in or on the way to or from any territories adjacent to or near to the Protectorate, shall not be considered to be absent from the Protectorate within the meaning of this Order."

"12. In the event of the British Resident having occasion at any time to be temporarily absent for a short period from the seat of government, or, in the exercise or discharge of any powers or duties by this Order or otherwise conferred or imposed upon him by His Majesty, or by the Secretary of State, to visit any territories adjacent to or near to the Protectorate, he may by an instrument under his official seal appoint any person or person to be his Deputy or Deputies within any part or parts of the Protectorate during such temporary absence, and in that capacity to exercise, perform, and execute, for and on behalf of the British Resident during such absence, but no longer, all such powers and authorities by this Order or otherwise vested in the British Resident as shall in and by such instrument be specified and limited, but no others. Every such Deputy shall conform to and observe all such instructions as the British Resident shall from time to time address to him for his guidance. Provided nevertheless that by the appointment of a Deputy or Deputies as aforesaid the power and authority of the British Resident shall not be abridged, altered, or in any way affected, otherwise than His Majesty or the Secretary of State may at any time hereafter think proper to direct."

"14. The Secretary of State, or the British Resident, subject to the directions of the Secretary of State may appoint or authorise the appointment of such public officers for the administration of the Protectorate under such designations as he may think fit, and may prescribe their duties."

"15.—(1) The British Resident may, upon sufficient cause to him appearing, dismiss any public officer not appointed by virtue of a Warrant from His Majesty whose annual pensionable emoluments do not exceed fifteen hundred rupees, or one hundred pounds sterling, according as the said emoluments are fixed with reference to rupees or to pounds sterling, as the case may be, provided that in every such case the grounds of intended dismissal are definitely stated in writing and communicated to the officer in order that he may have full opportunity of exculpating himself, and that the matter is investigated by the British Resident with the aid of the head for the time being of the department in which the officer is serving.

" (2) The British Resident may, upon sufficient cause to him appearing, suspend from the exercise of his office any person holding any office within the Protectorate, whether appointed by virtue of any Commission or Warrant from His Majesty or in His Majesty's name, or by any other mode of appointment. Such suspension shall continue and have effect only until His Majesty's pleasure therein shall be signified to the British Resident. If the suspension is confirmed by the Secretary of State the British Resident shall forthwith cause the officer to be so informed, and thereupon his office shall become vacant. In proceeding to any such suspension the British Resident is strictly to observe the directions in that behalf given to him by any instructions from His Majesty or signified through the Secretary of State."

"17.—(1) There shall be a Court styled 'His Britannic Majesty's High Court for Zanzibar,' in this Order referred to also as 'the High Court' and 'the Court.'

"(2) Subject to the other provisions of this Order all His Majesty's jurisdiction, criminal and civil, in Zanzibar shall be and is hereby vested in the High Court. "(3) There shall be as many Judges of the Court as may from time to time be required, who shall respectively be appointed on His Majesty's behalf by the British Resident by an instrument under his hand and official seal in pursuance of instructions received from His Majesty through the Secretary of State.

" (4) The Judges shall hold office during the pleasure of His Majesty.

"(5) When there are more Judges than one the principal Judge shall have such distinguishing title as the Secretary of State may approve.

"(6) Subject to any Rules of Court the principal Judge shall make any such arrangements as he thinks fit for the distribution of the business of the Court."

"18. In any case of death, illness or absence or in any other emergency the British Resident may appoint an acting Judge."

"21.--(1) Courts subordinate to the High Court and Courts of special jurisdiction may be constituted by or under any Order of the British Resident and shall exercise such jurisdiction as may be assigned to them by any such Order.

"(2) The High Court shall have within the district of any such subordinate Court an original jurisdiction concurrent with the jurisdiction thereof.

"(3) Provision may be made by Order of the British Resident for the hearing and determining of appeals from every such Court by the High Court or otherwise."

"33. Where it is shown by evidence on oath, to the satisfaction of the British Resident, that any person subject to this Order is conducting himself so as to be dangerous to peace and good order in Zanzibar, or is endeavouring to excite enmity between the Sultan or people of Zanzibar and His Majesty, or is intriguing against His Majesty's power and authority in Zanzibar or against the authority of the Sultan of Zanzibar, the British Resident may by order under his hand and official seal order that person to be deported from the Protectorate to such place and for such period as he shall direct.

"Provided that where such person is a foreigner no such order shall be made by the British Resident without the concurrence in writing of the Consul of the State to which such foreigner belongs."

4. This Order shall be published in the Official Gazette of the Zanzibar Government, and shall thereupon come into operation.

And the Right Honourable Leopold Stennett Amery, one of His Majesty's Principal Secretaries of State, is to give the necessary directions herein.

BY His Excellency Edward Brandis Denham, Esquire, Companion of the Most Distinguished Order of Saint Michael and Saint George, Acting Governor and Commanderin-Chief of the Colony and Protectorate of Kenya.

WHEREAS by Section 2 of the Township Private Streets Ordinance, 1924, it is provided that the Governor in Council may, from time to time, by Proclamation declare that all or any of the provisions of the said Ordinance shall be in force in any Municipality.

And whereas it is by the said section further provided that upon the publication of any such Proclamation the said provisions shall extend to and be in force in the Municipality or township or part thereof mentioned therein.

And whereas by Proclamation made under the Municipal Corporations Ordinance, 1909, on the 5th day of July, 1919, by His Excellency Sir Edward Northey, Major-General of His Majesty's Forces, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Companion of the Most Honourable Order of the Bath, Governor and Commander-in-Chief of the East Africa Protectorate, the Township of Nairobi was declared to be a Municipality.

Now therefore, by virtue of the powers in me as Governor in Council vested as aforesaid, I do hereby declare that from the date of publication hereof all the provisions of the Township Private Streets Ordinance, 1924, shall be in force in the Municipality of Nairobi.

#### THE FOREST ORDINANCE, 1911.

#### Rules.

IN EXERCISE of the powers conferred upon him by the Forest Ordinance, 1911, Section 13, and the General Revision Ordinance, 1924, Section 27, His Excellency the Acting Governor in Council has been pleased to make the following Rules :—

1. These Rules may be cited as "the Machakos Native Reserve Forest Rules, 1925."

2. It shall be lawful for the Conservator of Forests to sell for their own use, but not for sale, trade, or barter, to natives of the area provisionally gazetted as the Machakos Native Reserve under Government Notice No. 193 of 1920, round poles when available from the Government Plantations in the Machakos District at the following rates inclusive of the cost of cutting :—

(b) Not more than 4 inches in diameter breast height ... 6 poles 1 00

#### THE NATIVE REGISTRATION ORDINANCE, 1921.

#### RULES.

IN EXERCISE of the powers conferred on the Governor in Council by the Native Registration Ordinance, 1921, His Excellency the Acting Governor in Council has been pleased to make the following Rules :-

1. These Rules may be cited as "the Native Registration (Mombasa) Rules, 1925.'

2. Every person resident in Mombasa District employing a native registered under the provisions of the Native Registration Ordinance, 1921, shall render to the Resident Commissioner, Mombasa, a special return after the 1st day of November and before the 7th day of November, 1925. Such special return shall be made upon a form as set out in the schedule annexed to this Rule and shall include the following information :-

(a) Name of employer (or firm or company) his residential and postal address, his administrative district, the date on which the return is submitted.

(b) The registration number and name of any native in the employer's service on the 1st November, 1925, and the date of engagement of such native.

(c) The registration number and name of any native discharged or having deserted or died during the month of October, 1925, and the date on which such discharge, desertion or death took place.

(d) The registration number and name of any native who has been in the employer's service who having gone on leave or left such employer's service without being signed off and who has not returned to such employer's service within the period of his contract, and who has not been reported by such employer on a previous labour return as having been discharged or as having left such employer's service and the date of such native's departure from such employer's service.

### THE DISEASES OF PLANTS PREVENTION ORDINANCE, 1910.

#### REGULATIONS.

IN EXERCISE of the powers conferred upon him by the Diseases of Plants Prevention Ordinance, 1910, His Excellency the Governor in Council has been pleased to make the following Regulations :---

1. These Regulations may be cited as "the Movement of Coffee Plant Regulations, 1925."

2. No person shall move or cause to be moved any coffee plant from any of the districts of Ngong, Kyambu, Ruiru, Thika or Fort Hall to any other part of the Colony or Protectorate : Provided that nothing in this rule shall be construed as prohibiting the movement of coffee plants within or between the districts mentioned in this rule.

3. Any person committing an offence against these regulations shall be liable on conviction to a fine which may extend to  $\pounds 100$  or to imprisonment of either description for a period which may extend to two months or to both such fine and imprisonment.

1. In his speech at the East African dinner on June 25th, 1925, the Secretary of State said :---

"He wished to correct the idea that there was something transient in their hold upon Tanga-nyika. It was essentially a part of the British framework as any other Protectorate.

In connection with the disposal of ex-enemy properties in British Cameroons, the Secretary of State authorised a statement which appeared in the press on November 13th, 1924, containing the following passage:

"As it has been alleged that the titles of these properties are not as secure as if the properties were situated in a British Colony or Protectorate, it is desirable to state that this is not the case. There is no more reason for fearing that the British Cameroons might be handed over to another Power than there is that a British Colony or Protectorate might be so handed over.
