THE COMMISSIONS OF INQUIRY ORDINANCE, 1912.

A COMMISSION.

I, EDWARD WILLIAM MACLEAY GRIGG, Knight Commander of the Royal Victorian Order, Companion of the Most Distinguished Order of Saint Michael and Saint George, Companion of the Distinguished Service Order, upon whom His Majesty has conferred the decoration of the Military Cross, Lieutenant-Colonel in His Majesty's Army (retired), Governor and Commander-in-Chief of the Colony and Protectorate of Kenya, do by virtue and in exercise of the powers conferred upon me by the Commissions of Inquiry Ordinance, 1912, by this my Commission under my hand appoint :—

EDWARD BRANDIS DENHAM, Companion of the Most Distinguished Order of Saint Michael and Saint George; Colonial Secretary, Colony and Protectorate of Kenya.

EDWARD BLACKWELL JARVIS, Companion of the Most Distinguished Order of Saint Michael and Saint George; Chief Secretary, Uganda Protectorate.

REGINALD CLIFTON GRANNUM, Companion of the Most Distinguished Order of Saint Michael and Saint George, Treasurer of the Colony and Protectorate of Kenya.

GEOFFREY WALSH, Commissioner of Customs, Colony and Protectorate of Kenya and Uganda Protectorate.

ALLISTER JOHN MACKINTOSH CAMERON;

ROBERT SANDFORD CAMPBELL;

HENRY WALTER DUNCAN FRUDD;

WILLIAM MCCLURE LUNT;

WILLIAM MCHARDY, Officer of the Most Excellent Order of the British Empire;

to be Commissioners :—

(1) To enquire into and to report upon the existing system of control and working on shore and afloat at the Ports of Kilindini and Mombasa, and to make recommendations as to the future form of control and management, methods of working and financial arrangements, and to frame such regulations, scales of charges, etc., as may be necessary to give effect to such recommendations.

(2) After investigating the whole of the position at the Port at Kilindini to make such recommendations as are considered necessary for extensions or other facilities, including oil sites, oil piers, coal piers for imports or bunkering, repair slipways, etc., etc., on the completion of the Deep Water Berths now under construction.

(3) Generally to report on any other matters connected with Port and Harbour work coming under the notice of the Commission, and to make such recommendation as is considered necessary in the interests of efficient working and future development.

AND I DO HEREBY APPOINT the said EDWARD BRANDIS DENHAM, C.M.G., to be Chairman of the said Commission.

AND I DO HEREBY DIRECT that six Commissioners shall form a quorum.

AND I DO HEREBY APPOINT CECIL JAMES JUXON TALBOT BARTON to be Secretary of the said Commission.

AND I DO HEREBY APPOINT FREDERICK CHARLES GAMBLE, a Resident Magistrate in the Colony and Protectorate of Kenya, to be the person before whom the Commissioners appointed under this Commission shall make and subscribe the proper Oath as by the aforesaid Ordinance required.

AND I DO HEREBY DIRECT that the aforesaid enquiry shall be held at such place or places in the Colony as the Chairman may think fit.

AND I DO HEREBY COMMAND all persons whom it may concern to take due notice hereof and give their obedience accordingly.
