THE CORPORAL PUNISHMENTS BILL, 1925.

STATEMENT OF OBJECTS AND REASONS.

The power to award the punishment of whipping has hitherto been given by various Ordinances. In this Bill all such powers are repealed and whipping is allowed for certain specified offences.

Whipping is by this Bill limited to offences by males of a brutal, indecent or anti-social nature.

Power is also given to whip young offenders under the age of sixteen.

A Bill

Intituled

An Ordinance to Consolidate and Amend the Law relating to Corporal Punishments.

- 1. This Ordinance may be cited as "the Corporal Short title. Punishments Ordinance, 1925."
- 2. In this Ordinance the following expression shall, Interpretation. unless the contrary intention appears, have the meaning hereby assigned to it, namely:—
 - "Juvenile offender" means an offender who in the opinion of the court is under the age of sixteen years.
 - 3. Whoever:—

Offences for which whipping may be

- (a) Abets, commits or attempts to commit rape, as awarded.

 defined in Section 375 of the Indian Penal Code;
 - (b) Compels, or induces any person by fear of bodily injury, to submit to an unnatural offence, as defined in Section 377 of the said Code;
- (c) Voluntarily causes hurt or grievous hurt in committing or attempting to commit robbery, as defined in Section 390 of the said Code;
 - (d) Commits dacoity as defined in Section 391 of the said Code;

- (e) Is guilty of hurt punishable under Sections 323 to 333 inclusive of the said Code;
- (f) Is guilty of assault punishable under Sections 354, 356 and 357 of the said Code, involving circumstances of savagery or brutality;

- (g) Is guilty of extortion punishable under Sections 384 to 389 inclusive of the said Code;
- (h) Is guilty of any offence punishable under the Criminal Law Amendment Ordinance, 1914;

may, in lieu of or in addition to any other punishment to 10 which he may for such offence, abetment, or attempt be liable, be punished with whipping not exceeding twenty-four strokes of a cane.

Whipping of juveniles.

- **4.** Any juvenile offender who abets, commits or attempts to commit:—
 - (a) Any offence punishable under the Indian Penal Code, except offences specified in Chapter VI and in Sections 153a and 505 of that Code and offences punishable with death; or
 - (b) Any offence punishable under any other law with 20 imprisonment which the Governor in Council may by notification in the Gazette specify in this behalf;

in lieu of any other punishment to which for such offence, abetment or attempt he may be liable, may be punished with whipping not exceeding fifteen strokes of a cane.

Females not to be whipped.

- 5. This Ordinance shall not apply to females.
- Power to make rules.
- **6.** The Governor in Council may make rules for the better carrying out of the provisions of this Ordinance.

THE CRIMINAL PROCEDURE (AMENDMENT) BILL, 1925.

STATEMENT OF OBJECTS AND REASONS.

This amendment is required as consequential to the Corporal Punishments Bill.

A Bill

Intituled

An Ordinance to Amend the Criminal Procedure Ordinance, 1913.

1. This Ordinance may be cited as "the Criminal Short title. Procedure (Amendment) (No. 2) Ordinance, 1925," and shall be read as one with the Criminal Procedure Ordinance, 1913 (hereinafter referred to as "the Principal Ordinance"), and additional 5 all amendments thereto.

"18. The Supreme Court and subordinate courts of the first and second class and Liwalis and Cadis courts may impose a sentence of whipping under the provisions of the Corporal Punishments Ordinance, 1925.

THE CUSTODY OF CHILDREN ORDINANCE, 1925.

STATEMENT OF OBJECTS AND REASONS.

This Bill gives the court power to refuse the production of a child if the parent has previously abandoned it.

One of the objects of the Bill is to give charitable societies power to recover the whole or a part of the cost incurred in bringing up a child and thus to limit the present all too frequent applications for custody of children when they reach a wageearning age, by parents or guardians who have borne no part of the expense of bringing them up or educating them.

There are several charitable societies in this Colony which board and bring up children who are frequently removed to undesirable homes and surroundings before they are of an age to look after themselves.

Under existing law these societies can neither refuse the parent the custody, nor can they recover any part of the cost incurred in bringing up the child.

The court can also give directions as to the child's religious upbringing.

Where a person has been charged with or convicted of any offence of a brutal or anti-social nature in regard to a child. the court may take the child out of the custody of such person and arrange for its upbringing in good surroundings.

Similarly, where the court in any case is of opinion that a girl is being brought up in immorality it may take the girl away from parents, etc., and commit her to the care of some desirable person or institution.

A Bill

Intituled

An Ordinance Relating to the Custody of Children.

Short title.

1. This Ordinance may be cited as "the Custody of Children Ordinance, 1925."

Definition of "parent."

2. For the purposes of this Ordinance the expression "parent" of a child includes any person at law liable to maintain such child or entitled to his custody, and the expression "child" means a person under, or appearing to the court to be under, the age of sixteen years.

Power of court as to production of child.

3. Where the parent of a child applies to the Supreme Court for a writ or order for the production of the child, and the court is of opinion that the parent has abandoned or 10 deserted the child, or that he has otherwise so conducted himself that the court should refuse to enforce his right to the custody of the child, the court may in its discretion decline to issue the writ or make the order.

Power to court to order repayment of costs of bringing up child. 4. If at the time of the application for a writ or order 15 for the production of the child the child is being brought up by another person, or is boarded by a charitable or provident institution or society, the Supreme Court may, in its discretion, if it orders the child to be given up to the parent, further order that the parent shall pay to such person or to the charitable 20 or provident institution or society, the whole of the costs properly incurred in bringing up the child, or such portion thereof as shall seem to the court to be just and reasonable, having regard to all the circumstances of the case.

Court in making order to have regard to conduct of parent.

5. Where a parent has:—

- 25
- (a) Abandoned or deserted his child; or
- (b) Allowed his child to be brought up by another person at that person's expense, or by a charitable or provident institution or society, for such a length of time and under such circumstances as to satisfy the court 30 that the parent was unmindful of his parental duties:

the court shall not make an order for the delivery of the child to the parent, unless the parent has satisfied the court that, having regard to the welfare of the child, he is a fit person to have the custody of the child.

35

Power to court as to child's religious education.

6. Upon any application by the parent for the production or custody of a child, if the court is of opinion that the parent ought not to have the custody of the child, and that the child is being brought up in a different religion to that in which the parent has a legal right to require that the child should 40 be brought up, the court shall have power to make such order as it may think fit to secure that the child be brought up in the religion in which the parent has a legal right to require that the child should be brought up. Nothing in this Ordinance contained shall interfere with or affect the power of 45 the court to consult the wishes of the child in considering what order ought to be made, or diminish the right which any child now possesses to the exercise of its own free choice.

7. (1) Where a person having the custody or care of a Disposal of child by order child has been-

- (a) Convicted of committing, abetting or attempting to commit in respect of such child an offence mentioned in the schedule to this Ordinance; or
- (b) Committed for trial for any such offence by the Supreme Court;

the court, either at the time when the person is so convicted or committed for trial, and without requiring 10 any new proceedings to be instituted for the purpose, or at any other time and also any subordinate court before which the case may be brought may, if satisfied on inquiry that it is expedient so to deal with the child, order that the child be taken out of the custody, charge or care of the person so 15 convicted or committed for trial, and be committed to the care of the relative of the child, or some other fit person (which expression includes a charitable or provident institution or society) named by the court (such relative or other person being willing to undertake such care), until the child attains 20 the age of sixteen years, or for any shorter period, and the Supreme Court may of its own motion, or on the application of any person, from time to time, by order renew, vary, and revoke any such order.

- (2) If the child has a parent or legal guardian no order 25 shall be made under this section unless the parent or legal guardian has been convicted of or committed for trial for the offence, or is under committal for trial for having been, or has been proved to the satisfaction of the court making the order to have been, party or privy to the offence, or cannot 30 be found.
- (3) Every order under this section shall be in writing, and any such order may be made by the court in the absence of the child; and the consent of any person to undertake the care of a child in pursuance of any such order shall be proved 35 in such manner as the court may think sufficient to bind him.
- Where an order is made under this section in respect of a person who has been committed for trial, then, if that person is acquitted of the charge, or if the charge is dismissed for want of prosecution, the order shall forthwith be void, 40 except with regard to anything that may have been lawfully done under it.
- (5) The Governor may at any time in his discretion discharge a child from the care of any person to whose care he is committed in pursuance of this section, either absolutely 45 or on such conditions as the Governor may approve.
- (6) The Governor in any case where it appears to him to be for the benefit of a child who has been committed to the care of any person in pursuance of this section, may empower such person to procure the emigration of the child, 50 but, except with such authority, no person to whose care a child is so committed shall procure his emigration.
- Where on the trial of any offence it is proved to the Custody of satisfaction of the Supreme Court that the seduction or girls under sixteen. prostitution of a girl under the age of sixteen has been caused, 55 encouraged or favoured by her father, mother, guardian, master or mistress, it shall be in the power of the court to divest such father, mother, guardian, master or mistress of all authority over her and to appoint any person willing to take charge of such girl to be her guardian until she has attained 60 the age of twenty-one, or any age below this as the court may direct, and the Supreme Court shall have power from time to time to rescind or vary such order by the appointment of any other person as such guardian, or in any other respect.

Power to make rules. 9. The Governor in Council may make rules in relation to children committed to the care of any person and to the duties of such persons with respect to such children.

PROCLAMATION.

BY His Excellency Edward William Macleay Grigg, Knight Commander of the Royal Victorian Order, Companion of the Most Distinguished Order of Saint Michael and Saint George, Companion of the Distinguished Service Order, upon whom His Majesty has conferred the decoration of the Military Cross, Lieutenant-Colonel in His Majesty's Army (retired), Governor and Commander-in-Chief of the Colony and Protectorate of Kenya.

PROCLAMATION.

IN EXERCISE of the powers conferred upon me by the East Africa Townships Ordinance, 1903, I, Edward Macleay Grigg, Knight Commander of the Royal Victorian Order, Companion of the Most Distinguished Order of Saint Michael and Saint George, Companion of the Distinguished Service Order, upon whom His Majesty has conferred the decoration of the Military Cross, Lieutenant-Colonel in His Majesty's Army (retired), Governor and Commander-in-Chief of the Colony and Protectorate of Kenya, do hereby declare the area described in the schedule hereto to be a Township for the purposes of the above Ordinance, and to be named "Njoro."

NJORO TOWNSHIP.

Description of the Boundaries.

Commencing on the Njoro River, at the north-west corner of L.O. No. 2947/1, thence bounded by the north-western boundary of that portion to its western corner;

thence by the northern boundary of L.O. No. 2947/2 to its north-west corner;

thence by the north-eastern boundary of L.O. No. 526 to its northern corner;

thence northerly by part of the generally eastern boundary of L.O. No. 527 to its north-east corner on the Uganda Railway southern 100-foot zone;

thence by a straight line across the Uganda Railway to the south-east corner of L.O. No. 517/2/2;

thence by part of the south-eastern boundary of that portion for 139.5 feet to the southern corner of L.O. No. 4800;

thence by the south-eastern boundary of the latter portion to its eastern corner;

thence by a straight line across the 200-foot road reserve to the southern corner of L.O. No. 4803;

THE INDIAN PETROLEUM ACT, 1899.

RULES.

IN EXERCISE of the powers conferred upon him by the Indian Petroleum Act, 1899, as applied to the Colony, and all other powers thereunto enabling him, His Excellency the Governor in Council has been pleased to make the following Rules:—

- 1. These Rules may be cited as "the Petroleum Import (Amendment) Rules, 1925," and shall be read as one with the Petroleum Import Rules, 1920 (hereinafter called "the Principal Rules").
- 2. Rule 16 of the Principal Rules is hereby amended by inserting immediately after the word "Petroleum" in line one the words "in packages or in portable tanks or in portable receptacles."
- 3. Rule 17 of the Principal Rules is hereby repealed and the following Rule is substituted therefor:—
 - "17. (1) Smoking or the use of any fire or light on any lighter, barge or boat which is being used in the carrying of petroleum from a vessel to the shore or vice versa is prohibited.

- "(2) Smoking is prohibited on all vessels carrying petroleum in a port of the Colony, except at such times and places as designated by the Captain. During the discharge of dangerous petroleum, smoking shall be completely prohibited in any part of the vessel.
- "(3) Where petroleum is being imported, no smoking shall be permitted in a storage shed or in or about an installation, except in such places as may be specially set apart for the purpose, and suitable notices to this effect shall be conspicuously posted on the premises.
- "(4) Where petroleum is being imported, no fire or naked lights shall be permitted within the installation, except in the offices, soldering shed, laboratory, living quarters, engine-room, boiler-house, and smithy.
- "(5) Where dangerous petroleum is being imported, no light other than electric light, and no fire shall be permitted at any time in the installation within 100 feet of any tank or storage shed.
- "(6) Electric lights shall be enclosed in a double glass, the outer one of which shall be gas-tight. All switches and fuses shall be outside the buildings and enclosed in gas-tight boxes."
- 4. Sub-rule (2) of Rule 18 of the Principal Rules is hereby repealed and the following sub-rule is substituted therefor:—
 - "(2) When petroleum is imported in bulk, its removal from the vessel shall be performed in either of the following ways:—
 - " (a) By pumping through an oil-tight pipe to a storage tank on shore; or
 - "(b) By discharge into a barge duly certified as under Rule 17 (b) of the Petroleum Possession and Transport Rules, 1923, and therefrom by pumping through an oil-tight pipe to a storage tank on shore.
 - "The discharge shall be continuous day and night until completed, weather and appliances permitting. When working at night, electric light only shall be used; and when the vessel or barge has finished discharging, the pipe to the storage tanks shall immediately be emptied by means of a supplementary pump on shore or by means of the vessel's or barge's pumps. If for any cause, the discharge of petroleum is at any time suspended, arrangements must be made by means of a valve, for effectually preventing any of the petroleum left in the pipe from escaping."

EAST AFRICA TOWNSHIPS ORDINANCE, 1903.

Rules.

THE PUBLIC HEALTH ORDINANCE, 1921.

REGULATIONS.

IN EXERCISE of the powers conferred upon him by the Public Health Ordinance, 1921, His Excellency the Governor in Council on the advice of the Central Board of Health, has been pleased to make the following Regulations:—

- 1. These Regulations may be cited as "the Public Health (Kisumu Density of Dwellings) Regulations, 1925."
- 2. Throughout these Regulations the following words and expressions shall have the meanings hereinafter respectively assigned to them unless the context otherwise requires:
 - (1) "Dwelling" means any house, room, shed, hut, cave, tent, vehicle, vessel or boat or any other structure or place whatsoever, any portion whereof is used by any human being for sleeping or in which any human being dwells.
 - (2) "Dwelling-house" means a building or any part or portion of a building used or constructed, adapted or designed to be used for human habitation, as a separate tenancy, or by one family only, whether detached, semi-detached or separated by party walls or by floors from adjoining buildings, together with such outbuildings as are reasonably required to be used or enjoyed therewith.
 - (3) "Old Bazaar" shall mean and include that area of the Township bounded on the south-east and east by the Uganda Railway boundary, to its junction with Temple Road, thence along Temple Road to its junction with Junction Road, thence along this road to its junction with the Uganda Railway boundary.
 - (4) "Plot" means any area of land being the subject of a separate lease or conveyance from the Crown.
 - (5) "Subplot" means any portion of a plot, such portion being the subject of a separate registered conveyance, assignment or sublease, and shall also extend to and include any portion of a plot being the subject of a separate sublease or upon which any building is erected which is wholly in or is constructed or adapted to be wholly in, one occupation or is let or adapted to be let to a separate tenant.

- 3. No person shall erect a building or make any alteration or addition to a building on any plot or subplot where such plot or subplot or such building as aforesaid, or any building or part of a building on such plot or subplot, is intended to be used as a dwelling unless at least half of the said plot or subplot shall be left unbuilt upon or unless the said plot or subplot be so denuded of buildings that, after erecting such building or making such alterations or additions to a building as aforesaid, at least half of such plot or subplot shall be left unbuilt upon.
- 4. On and after the date of the publication of these Regulations no person shall use or, being the owner thereof, permit to be used any plot or subplot or any building or part of a building on any plot or subplot as a dwelling where, on the date of the publication of these Regulations, such plot or subplot or such building or part of a building as aforesaid was not being used as a dwelling unless at least half of the said plot or subplot has been left unbuilt upon or unless the said plot or subplot be so denuded of buildings that at least half of such plot or subplot shall be left unbuilt upon.
- 5. On and after the first day of April, 1929, no person shall use or, being the owner thereof, permit to be used as a dwelling any plot or subplot or any building or part of a building on any plot or subplot, in the Old Bazaar, unless at least half of the said plot or subplot has been left unbuilt upon or unless the said plot or subplot be so denuded of buildings that at least half of such plot or subplot shall be left unbuilt upon.
- 6. Notwithstanding anything to the contrary contained in Regulations 3, 4 and 5 hereof, in the case of buildings appearing in the opinion of the Superintendent of Conservancy to be constructed, adapted or designed to be used entirely as hotels or residential clubs the proportion of the plot or subplot upon which such buildings stand or are to stand which shall be left unbuilt upon may be reduced to one-third.
- 7. No person shall so erect, add to or alter a building in such a manner that on the plot or subplot on which such building stands (such plot or subplot being not greater than one thirty-fifth of an acre), there shall be more than one dwelling-house, or so that there shall be any dwelling-house on any plot or subplot which is of less extent than one thirty-fifth of an acre, or so that the number of dwelling-houses over the whole area of such plot or sub-plot shall exceed the number yielded by a ratio of thirty-five dwelling-houses to one acre.

In coming to a determination as to the number of dwelling-houses which shall be permitted upon any plot or subplot in accordance with the foregoing provisions, no regard shall be had to any open spaces, streets or passages reserved or agreed to be reserved and abutting upon or in the vicinity of such plot or subplot.

Nothing contained herein shall be deemed to apply to any building which, in the opinion of the Superintendent of Conservancy, is constructed, adapted or designed to be used as a hotel or residential club and which in his opinion is unlikely, on account of the manner in which it may be used, to become a menace either to the health of the inhabitants thereof or of the community.

- 8. No person shall so erect, add to or alter a building intended, adapted or designed to be used wholly or partially for human habitation that any portion thereof which constitutes a dwelling-house shall be without separate and independent access to a street, such street not being a sanitary lane or a passage.
- 9. No person shall erect a building intended, adapted or designed to be used wholly or partially for human habitation on any plot or subplot which has not a frontage of at least fourteen feet upon a street, such street not being a sanitary lane or a passage.
- 10. The Superintendent of Conservancy shall have powers in every case to determine whether any street is a sanitary lane or a passage, and his decision shall be final, provided that no street measuring forty feet or more in width shall in any circumstances be deemed to be a sanitary lane or a passage.
- 11. Any person guilty of an offence against, or contravention of, or default in complying with, any provision of these Regulations shall be liable on conviction to a fine not exceeding five hundred shillings, and if the offence, contravention or default is of a continuing nature, to a further fine not exceeding sixty shillings for each day during which he shall make default.
- 12. These Regulations shall apply to the Township of Kisumu.
