THE STATISTICS (AMENDMENT) BILL, 1926.

STATEMENT OF OBJECTS AND REASONS.

In the Statistics Ordinance, 1918, the power of collecting statistics is limited to industrial and agricultural undertakings only.

A Statistical Department has now been established and it is important that provision should be made to enable this Department to function properly.

This amending Bill gives power to collect information on most matters, the compilation of statistics in regard to which will be of value for the better government of the Colony.

A Bill

Intituled

An Ordinance to Amend the Statistics Ordinance, 1918.

1. This Ordinance may be cited as "the Statistics (Amendment) Ordinance, 1926," and shall be read as one with the Statistics Ordinance, 1918, hereinafter called "the Principal Ordinance."

Short title.

5 2. The title of the Principal Ordinance is hereby amended by the addition of the words "and other matters" after the word "undertakings."

Amendment of Title of the Principal Ordinance.

3. Section 3 (1) of the Principal Ordinance is hereby amended by the addition of the following clauses:—

BY His Excellency Sir Edward William Macleay Grigg, Knight Commander of the Royal Victorian Order, Companion of the Most Distinguished Order of Saint Michael and Saint George, Companion of the Distinguished Service Order, upon whom His Majesty has conferred the decoration of the Military Cross, Lieutenant-Colonel in His Majesty's Army (retired), Governor and Commander-in-Chief of the Colony and Protectorate of Kenya.

WHEREAS by Section 10 of the Maintenance Orders Enforcement Ordinance, 1921, as amended by the Maintenance Orders Enforcement (Amendment) Ordinance, 1922, it is enacted that where the Governor is satisfied that reciprocal provisions have been made by the legislature of any British Possession or any Territory under His Majesty's protection for the enforcement within such Possession or Territory of maintenance orders made by the Courts in the Colony or Protectorate of Kenya, the Governor may, by Proclamation, extend this Ordinance to maintenance orders made by the Courts within such Possession or Territory and thereupon this Ordinance shall apply to such maintenance orders as if they had been made in England or in Ireland.

And whereas I am satisfied that reciprocal provisions have been made by the legislature of Nyasaland Protectorate for the enforcement within that Protectorate of maintenance orders made by the Courts of the Colony and Protectorate of Kenya.

Now therefore, by the powers in me vested as aforesaid, I do hereby proclaim and declare that the provisions of the said Ordinance are extended to maintenance orders made by the Courts in Nyasaland Protectorate.

THE ABUSE OF OPIATES PREVENTION ORDINANCE,
1913.
RULES.

IN EXERCISE of the powers conferred upon him by the Abuse of Opiates Prevention Ordinance, 1913, His Excellency the Governor in Council has been pleased to make the following Rules :—

1. These Rules may be cited as “ the Abuse of Opiates Prevention Rules, 1926,” and shall be read as one with the Rules dated the 28th day of February, 1914, and published as Government Notice No. 49 of 1914 (hereinafter called “ the Principal Rules ”).

2. A licence to import any opiate shall authorise importation through the Port of Kilindini and through no other port.

3. The form described in the Principal Rules as “ Authority to Import ” is hereby amended by adding thereto : “ This authority applies only to import through the port of Kilindini.”

4. Every person applying for a licence to export any opiate shall forward to the Director of Medical and Sanitary Services with his application a permit signed by the competent authority in the country to which it is desired to export the opiate authorising the importation of the opiate into that country.

The Director of Medical and Sanitary Services may retain the permit so forwarded to him.

THE PUBLIC TRAVEL AND ACCESS ROADS

NOTICE.

WHEREAS by Section 8 of the Public Travel and Access Roads Ordinance, 1920, as amended by the Public Travel and Access Roads (Amendment) Ordinance, 1924, it is enacted that whenever it is made to appear to the Governor that requirements exist for the establishment of a line of public travel or the conversion of a road of access into a line of public travel, the Governor may, by order published in the Gazette dedicate a line of public travel which shall be clearly described in such

order, and from such date of publication such line of public travel shall be absolutely dedicated to the public as a public road within the meaning of any law now or hereafter in force, and such public road shall be of such width as the Governor shall direct.

And whereas it has been made to appear to me that requirements exist for the establishment of a line of public travel from Chemill Siding on the Uganda Railway proceeding in a generally north-easterly direction towards Songhor, traversing Farms L.O. Nos. 1583, 1582, 1612, 3074, 3071, 3070, 3068, 1623, 3106, 1624 and 3067.

Now therefore in exercise of the powers vested in me by the said section, I hereby order that the line of public travel hereinbefore described and as shown approximately in Red Line on the plan marked P.W.D. No. 3565, filed at the Head Office of the Public Works Department at Nairobi, be dedicated as a line of public travel for the purposes of the said Ordinance, and I also direct such public road shall be 120 feet in width.

4. All outbuildings, offices, etc., shall be properly screened from view to the satisfaction of the Commissioner of Lands or such other person as he may appoint and shall be kept so screened during the term of the grant.

5. No building shall at any time during the term of the grant be used for any other purpose than a private dwelling-house.
