## NOTICE.

HIS Excellency the Governor has approved of the following Bill being introduced into Legislative Council :—

### **A Bill to Amend the Immigration Restriction Ordinance.**

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows :—

1. This Ordinance may be cited as “ the Immigration Restriction (Amendment) Ordinance, 1928,” and shall be read as one with the Immigration Restriction Ordinance (Chapter 62 of the Revised Edition) hereinafter referred to as “ the Principal Ordinance.”

2. Paragraph (f) of section 5 of the Principal Ordinance is hereby repealed and the following paragraph is substituted therefor :—

(f) Any person who, in consequence of information received from any trusted source or from any Government, whether British or Foreign, through official or diplomatic channels, is deemed by the Immigration Officer to be an undesirable immigrant.

3. Section 40 of the Principal Ordinance is hereby repealed and the following section is substituted therefor :—

“ 40. Notwithstanding anything to the contrary in this Ordinance contained, it shall be lawful for the Immigration Officer to prohibit any person, (not being a person mentioned in section 4), from entering the Colony, unless such person is in possession of a valid passport or other document satisfactorily establishing his identity, issued to him by or on behalf of the Government of which he is a subject and duly visaed or endorsed for the British Empire or the Colony.”
