IN EXERCISE of the powers conferred upon me by section 4 of the Local Government (District Councils) Ordinance, 1928, I do hereby declare the area described in the Schedule hereto to be a District under the jurisdiction of a District Council, to be known as the Nairobi District.

#### SCHEDULE.

Boundaries of the Nairobi District Council Area.

The Nairobi District Council Area shall consist of the following areas:—

- I. The Nairobi Administrative District as defined by Proclamation No. 54 of the 25th February, 1924.
- II. That portion of Kitui Administrative District, as defined by the said Proclamation, which lies to the west of the Kitui Native Reserve boundary from the junction of the Kithioko and Tana Rivers to the intersection of the Machakos-Kitui Road with the Athi River as defined by Government Notice No. 394 of 13th October, 1926.
- III. The Fort Hall Administrative District as defined by the said proclamation, excluding the Fort Hall Native Reserve as defined by the said Government Notice No. 394 and excluding the parts of the Aberdare Forest Reserve therein, and excluding L.R. No. 333.

IV. That portion of Machakos Administrative District as defined by the said Proclamation which lies to the north of the following boundary:—

Commencing on the Athi River at the intersection of the north-western boundary of L.R. No. 2711 extended thereto;

thence south-easterly bounded by the north-eastern or eastern boundaries of L.R. Nos. 2711, 2359, 3594, 2362 and 3597 to Koma Rock on the North-western boundary of the Machakos (Ulu) Native Reserve as defined in the said Government Notice;

thence north-easterly by that Native Reserve boundary to its intersection with the Administrative District boundary on the Athi River.

V. Those portions of the Kiambu Administrative District, as defined by the said proclamation, which are not included within the forest reserves therein or are not part of the Kiambu Native Reserve as defined by the said Government Notice, and excepting the Township of Kijabe.

Such area as may from time to time be defined as the Municipality of Nairobi, together with the Townships of Escarpment and Kikuyu and such areas within the above boundaries as may from time to time be declared townships under the Townships Ordinance, Chapter 82 of the Revised Edition, are excluded from the Nairobi District Council Area.

  - "(2) It shall be lawful for the Town Clerk, without notice, to remove or pull down any advertisement displayed in contravention of this By-law and to enter upon any land or premises for the purpose."

# THE STATISTICAL ORDINANCE REGULATIONS, 1928.

Any person wishing to board any Ship or Native vessel at any port in the Colony, whether as passenger, member of the crew or otherwise, who is to be conveyed to a port outside the Colony, must complete an Emigration Return (Schedule "D"), which must be given to the Shipping Agents to enable a return to be made to the Immigration Officer.

Should any such person be illiterate, such information as is necessary must be supplied orally to enable the return to be completed on his or her behalf.

Immigration forms (Schedule "B") will be supplied on board ship, or on application to the Immigration Department, Mombasa.

Emigration forms (Schedule "D") will be supplied by any shipping agent, or on application to the Immigration Officer, Mombasa or Nairobi.

Intending emigrants are warned that they are liable to suffer delay in securing their tickets unless the emigration forms are filled in and presented to the shipping agents when the tickets are applied for.

# DEPARTMENT OF AGRICULTURE.

LOCUST REPORT TO 27/2/29.

Hoppers.—All hopper destruction parties are now withdrawn from all areas.

Flying Swarms.—These are present in the Trans Nzoia, about Ravine, on the Kinangop, in Laikipia, about Lumbwa, and generally moving about with no settled direction of flight.

Requests for spray pumps and arsenic for use on such swarms are received, but as a means of destruction of flying swarms it is inadvisable to use them, and therefore none are issued.

If settlers are able to burn fires under the roosting locusts a number will be destroyed. Some success has been achieved by the use of a bundle of tow tied on to a long stick. The tow is dipped in paraffin and the resulting torch passed under the locusts.

Flame Throwing.—The experimental unit has been withdrawn; much useful work was done, but on account of the fact that swarms are not packing densely, the destruction caused per charge was insufficiently great. It is anticipated that with the advent of damp weather better conditions for destruction, with far less risk to property, will arise.

It is now possible to make an estimate of the extent of hopper destruction achieved during the hopper campaign now ending. It is taken that an area of 162,500 square miles of the Colony was infested with hoppers, and for purposes of calculation we have to assume that each square mile had equal density of infestation.

From this calculation it is indicated that of the total hopper infestation of the area of the Colony assumed to be infested, over one-third, or possibly 35 per cent., was destroyed.

It is certain that until the remote areas included in the Northern Frontier Province are rendered accessible and are to some extent developed and brought under surveillance, it will not be possible to take action to effect a high percentage of destruction of a hopper infestation in such areas.

It has been observed that young flying swarms from the first layings appear to fly in a direction which will take them over the country in which subsequent laying by the mother swarms has taken place. It will be interesting to observe whether during this coming season there will again occur a concentration of swarms as appeared to occur at Isiolo late last year.

ARRANGEMENTS have been made by Government for the sale of quinine to the public at approximately cost price. The quinine will be sold in packets each containing a quarter pound (four ounces) of Quinine Bisulphate at the price of eight shillings per packet including postage. Full directions for use, together with a leaflet on the treatment of malaria will be attached to each packet. The quinine will be issued by the Medical Department and all orders, which must be accompanied by cash, should be addressed to the Medical Storekeeper, P.O. Box No. 425, Nairobi.
