SCHEDULE.

Boundaries of the Naivasha District Council Area.

Commencing at the north-western corner of L.R. No. 1261 on the Naivasha Administrative District Boundary as defined by Proclamation No. 54 of the 25th February, 1924;

thence bounded easterly and southerly by that Administrative District Boundary to its intersection with the western boundary of Kijabe Township;

thence north-easterly and south-easterly by the boundary of that Township to the Tongitongi River;

thence by that river down-stream to its intersection with the aforesaid Administrative District Boundary;

thence southerly by that boundary to its intersection with the south-western boundary of L.R. No. 373;

thence north-westerly by the south-western boundaries of L.R. Nos. 373 and 375 to the western corner of the latter;

thence still north-westerly by a straight line to a beacon on the Kijabe-Narok road on the aforesaid Naivasha Administrative District Boundary;

thence in a generally north-westerly direction by that boundary to its intersection with the Nakuru Administrative District Boundary as defined by the aforesaid Proclamation;

thence north-westerly by the latter boundary to the southeast corner of the Eastern Mau Forest Reserve;

thence northerly by part of the eastern boundary of that forest reserve to the southern corner of the Nakuru Lake Forest Reserve;

thence still northerly by the eastern boundary of the latter forest reserve extended to low-water mark in Lake Nakuru;

thence easterly by that low-water mark to its intersection with the northern boundary of L.R. No. 5697 extended thereto:

thence easterly by that boundary extended across the Kenya and Uganda Railway to its intersection with the eastern 100-foot zone thereof;

thence northerly by that 100-foot zone to the north-west corner of L.R. No. 434;

thence easterly by the generally northern boundaries of L.R. Nos. 434, 435, 436 and 439 to the intersection of the last with the western boundary of the Naivasha Administrative District;

thence northerly by that District Boundary to the point of commencement.

The Townships of Naivasha, Gilgil and Kijabe, together with such areas within the above boundaries as may from time to time be declared townships under the Townships Ordinance, Chapter 82 of the Revised Edition, are excluded from the Naivasha District Council Area.

IN EXERCISE of the powers conferred upon him by section 32 of the Local Government (District Councils) Ordinance, 1928, His Excellency the Acting Governor in Council has been pleased to make the following Rules:—

- 1. These Rules may be cited as "the District Councils Election (Postal Ballot) Rules, 1929," and shall apply to such Districts established under the Local Government (District Councils) Ordinance, 1928, as the Governor may, by notice in the Gazette, appoint.
- 2. There shall be one polling station only for each District.
- 3. The date fixed for the taking of the poll shall be not less than forty-two days from the date of publication of the notice published by the Commissioner for Local Government under section 29 (2) of the Local Government (District Councils) Ordinance, 1928.
- 4. The Returning Officer shall be the returning officer appointed under section 25 of the Local Government (District Councils) Ordinance, 1928.
- 5. When an election has been adjourned for the purpose of taking a poll, the Returning Officer shall cause ballot papers to be printed on which shall be shown in alphabetical order the names of all duly nominated candidates for the district or ward, as the case may be, in which the poll is to be taken.

Every ballot paper shall be in the form prescribed under these Rules (Form 4), and such instructions may be printed thereon as the Council may approve.

- 6. The number appearing against the name of each voter in the voters' roll for the district or ward, as the case may be, shall be entered upon a ballot paper and the counterfoil thereof; the ballot paper shall then be marked with an official mark, either stamped or perforated, detached from the counterfoil and placed in an envelope on which shall appear the name and address of the voter whose number has been entered on such ballot paper.
- 7. Every ballot paper placed in an envelope and addressed to a voter shall be accompanied by :—

(a)

- 8. The Returning Officer shall cause the envelopes containing the ballot papers, declaration forms, etc., to be sealed and shall distribute them through the post or in such other manner approved by the Commissioner for Local Government as is calculated to ensure their delivery to the voters concerned with the least possible delay.
- 9. When the sealed envelopes have been sent out by the Returning Officer (which shall be within fourteen days from the date of publication of the notice published by the Commissioner for Local Government under section 29 (2) of the Local Government (District Councils) Ordinance, 1928, he shall cause to be inserted in one or more newspapers (if any) circulating in the District a notice specifying:—
 - (a) the place, time and date (which shall be the date appointed under section 29 (2) of the Local Government (District Councils) Ordinance, 1928) for the taking of the poll;
 - (b) the time and date (which shall be six o'clock on the afternoon of the day immediately preceding the date appointed for the taking of the poll) on or before which the ballot papers shall be delivered to the Returning Officer;
 - (c) the methods adopted for distributing the ballot papers (by post or otherwise);
 - (d) in cases where delivery to individual voters through the post or other agency cannot be arranged, the places where, and the persons to whom, application for ballot papers should be made.

Such notice shall also be exhibited in a conspicuous place at or near the public entrance to the offices of the Council and in such other place or places as the Council shall decide.

10. The Returning Officer may, upon written application being made and if he is satisfied that any registered voter has not received a ballot paper, or that any ballot paper has been inadvertently spoiled or mislaid, issue a duplicate ballot paper to such voter at any time within seven days immediately preceding the date appointed for the taking of the poll, but

not later than five o'clock in the afternoon of the last of such days. Every duplicate ballot paper and the counterfoil thereof shall be clearly marked "Duplicate" by the Returning Officer before being issued, shall bear the number appearing against the name of the voter in the voters' roll, and shall be marked with an official mark, either stamped or perforated.

- 11. Upon receiving the ballot paper the voter shall signify for whom he desires to vote by placing a cross against the name of the candidate whom he wishes elected. If he shall sign his name on the ballot paper or make any mark thereon by which his ballot paper would become recognisable, except the cross aforesaid, such ballot paper shall be considered blank and shall not be taken into account.
- 12. When the voter has completed the ballot paper he shall fold and seal it as directed thereon. He shall then complete and sign the declaration referred to in Rule 7 and place both documents in the special envelope provided for the purpose, and shall then forward the same by post or other convenient method to the Returning Officer.
- 13. No ballot papers which fail to reach the Returning Officer on or before the time and date appointed under Rule 9 shall be taken into account in the election.
- 14. Every envelope received by the Returning Officer shall be opened by him without delay, and he shall, in each case—
 - (a) ascertain that the ballot paper number and the voters' roll number shown on the outside of the folded and sealed ballot paper agree with the number on the completed declaration form;
 - (b) ascertain that the signature on the declaration form purports to be the signature of the voter concerned;
 - (c) ascertain whether a ballot paper has previously been received in respect of the same voter.

He shall then place each ballot paper with the seal unbroken in a ballot box provided for the purpose and shall retain all declarations: Provided that, if more than one ballot paper shall be received in respect of the same voter, the first only of such ballot papers shall be placed in the ballot box, and counted by the Returning Officer: And provided further that no ballot paper in respect of which a properly completed declaration has not been furnished shall be placed in the ballot box or counted by the Returning Officer. Ballot papers rejected under this Rule shall be placed in a separate packet by the Returning Officer.

- 15. Every ballot box shall be locked and sealed by the Returning Officer before any ballot papers are placed therein, and shall not be opened except as provided in these Rules.
- 16. At the place, date and time appointed for the taking of the poll the Returning Officer shall cause the ballot box to be opened in the presence of the Senior Administrative Officer of the District, or his deputy, and of such of the candidates and/or their agents as desire to be present. He shall then proceed, in the presence of the persons aforementioned, to ascertain the result of the poll by counting the votes given for each candidate, and shall forthwith declare those candidates,

not exceeding the number of vacancies to be filled, who have received the highest number of votes to be duly elected.

- 17. In the event of the number of votes being found to be equal for any two or more candidates all of whom cannot be declared elected to fill vacancies in the Council, the Returning Officer shall by lot immediately determine the election. The decision of the Returning Officer shall be final, subject to the provisions of section 28 of the Legislative Council Ordinance, Chapter 24 of the Revised Edition.
- 18. The Returning Officer shall reject and not count any ballot papers which—
 - (a) do not bear the official mark;
 - (b) give votes to more candidates than the voter is entitled to vote for;
 - (c) bear any writing or mark by which a voter can be identified otherwise than in these Rules prescribed;
 - (d) are unmarked or void for uncertainty;
 - (e) are rejected under Rule 14.
- 19. The returning Officer shall endorse "rejected" on any ballot paper which he may reject as invalid and shall add to the endorsement "rejection objected to" if an objection be in fact made by or on behalf of any candidate to his decision.
- 20. The Returning Officer shall immediately after the declaration of the poll seal up the voting papers and all other documents relating to the election and shall deliver them to the clerk, who shall safely keep such sealed packet for six months, after the expiration whereof the said packet and all papers contained therein shall be destroyed in the presence of two members of the Council.
- 21. No such sealed packet as aforesaid shall be opened during the said period of six months unless by order of the Supreme Court or any Judge thereof, and if any person shall, contrary to the provisions hereof, wilfully break the seal or open such packet he shall upon conviction be liable to a fine of fifty pounds or to imprisonment of either description for a period not exceeding two months, or to both such fine and imprisonment.
- 22. The Returning Officer shall provide ballot boxes, ballot papers, stamping instruments, copies of the voters' roll, and any other things which may be necessary; he may appoint persons to assist him and shall do such acts and things and make such arrangements to facilitate the taking of the poll as he may deem advisable; and any expenditure necessarily incurred by the Returning Officer under these Rules shall be met from the funds of the District.
- 23. The Commissioner for Local Government shall have power from time to time to issue instructions for the purpose of more effectually carrying out the provisions of these Rules as to the proceedings for election by ballot, provided that such instructions are not inconsistent with such Rules.
- 24. No election shall be declared invalid by reason of any mistake or non-compliance with the terms of these Rules

if it appears to the court having cognisance of the question that the election was conducted in accordance with the principles laid down in these Rules and that such mistake or non-compliance did not affect the result of the election.

25. The forms appended to these Rules, numbered Forms 1, 2, 3 and 4, are prescribed for the purposes of Part II of the Local Government (District Councils) Ordinance, 1928, and of these Rules.

INSTRUCTIONS TO APPLICANT.

Before signing this application, the applicant should carefully examine the qualifications and disqualifications of voters set out in this form.

Any person who wilfully makes any false statement on an application to be enrolled on any voters' roll in liable on conviction to a fine not exceeding twenty-five pounds or to imprisonment of either description for a period not exceeding two months, or to both such fine and imprisonment.

If the District is divided into Wards, a separate application form must be completed in respect of each Ward in which the applicant claims to be qualified.

QUALIFICATIONS OF EUROPEAN VOTERS.

The qualifications of European voters under section 10 of the Local Government (District Councils) Ordinance, 1928, are as follows:—

A.—Property Qualification:—

- (1) is of European origin or descent; and
- (2) is not less than twenty-one years of age; and
- (3) owns rateable property within the district of the capital value of not less than one hundred pounds.

If the District is divided into Wards, a voter is entitled to be enrolled once in each Ward in which he owns rateable property of the capital value of not less than one hundred pounds, but may not be enrolled in the same Ward in respect of both a property and a residential qualification.

B.—Residential Qualification:—

- (1) is of European origin or descent; and
- (2) is not less than twenty-one years of age; and
- (3) has resided in the district for twelve months out of the twenty-four months preceding the date of application for enrolment; and
- (4) either—
 - (a) has been in occupation for a like period of premises in the district of an annual value of thirty-six pounds; or
 - (b) is, at the date aforesaid, and has been for six months out of the preceding twelve months, in receipt of earnings at the rate of not less than ten pounds per month.

A married woman who is qualified under (1), (2), and (3) hereof, but who does not possess either of the qualifications under (4) is, if her husband possesses either of those qualifications, entitled to be enrolled.

QUALIFICATIONS OF INDIAN VOTERS.

(To be omitted if there are no Indian Elected Members for the District.)

The qualifications of Indian voters under section 11 of the Local Government (District Councils) Ordinance, 1928, are as follows:—

A.—Property Qualification:—

- (1) is a British subject of Indian origin or descent or an Indian under the suzerainty or protection of His Majesty; and
- (2) is not less than twenty-one years of age; and
- (3) owns rateable property within the district of the capital value of not less than one hundred pounds.

If the District is divided into Wards, a voter is entitled to be enrolled once in each Ward in which he owns rateable property of the capital value of not less than one hundred pounds, but may not be enrolled in the same Ward in respect of both a property and a residential qualification.

B.—Residential Qualification:—

- (1) is a British subject of Indian origin or descent or an Indian under the suzerainty or protection of His Majesty; and
- (2) is not less than twenty-one years of age; and
- (3) has resided in the District for twelve months out of the twenty-four months preceding the date of application for enrolment; and

(4) either—

- (a) has been in occupation for a like period of premises in the district of an annual value of twelve pounds, or
- (b) is, at the date aforesaid, and has been for six months out of the preceding twelve months, in receipt of earnings at the rate of not less than five pounds per month.

A married woman who is qualified under (1), (2), and (3) hereof, but who does not possess either of the qualifications under (4) is, if her husband possesses either of those qualifications, entitled to be enrolled.

DISQUALIFICATIONS OF VOTERS.

The disqualifications of voters under section 12 of the Local Government (District Councils) Ordinance, 1928, are as follows:—

- (a) has been found by a competent court to be of unsound mind; or
- (b) has been convicted of a criminal offence, whether in the Colony or elsewhere, and has been sentenced to imprisonment for a term of not less than twelve months and has not received a free pardon: Provided that such disqualification shall cease two years after the date of the expiration of the sentence; or

Rules.

IN EXERCISE of the powers conferred upon him by section 32 of the Local Government (District Councils) Ordinance, 1928, His Excellency the Acting Governor in Council has been pleased to make the following Rules:—

- 1. These Rules may be cited as "the District Councils Election Rules, 1929," and shall apply to such Districts established under the Local Government (District Councils) Ordinance, 1928, as the Governor, by notice in the Gazette, may appoint.
- 2. (1) The poll at every election shall, unless otherwise ordered by the Commissioner for Local Government, commence at eight o'clock in the forenoon of the day appointed, and shall close at six o'clock in the afternoon of the same day.
- (2) Every voter who, on the close of the poll, is present in the polling station for the purpose of voting shall be entitled to receive a ballot paper, and to mark and deposit it in the same manner as if he had voted before the close of the poll.
- 3. There shall be one polling station only within each polling district:

Provided that where no polling districts have been proclaimed by the Governor under section 4 of the Local Government (District Councils) Ordinance, 1928, each ward shall, for the purposes of holding a poll under these Rules, be deemed to be a polling district.

- 4. The Returning Officer shall be the returning officer appointed under section 25 of the Local Government (District Councils) Ordinance, 1928.
- 5. The Returning Officer shall provide such compartments, desks, ballot boxes, ballot papers, stamping instruments, copies of the voters' roll, and any other things which may be necessary; he shall appoint presiding officers and polling officers, and shall do such other acts and things and make such arrangements to facilitate the taking of the poll as he may deem advisable; and any expenditure necessarily incurred by the Returning Officer under these Rules shall be met from the funds of the District.
- 6. The presiding officer at each polling station shall keep order thereat, and shall regulate the number of voters to be admitted at one time, and shall exclude all other persons, except the Returning Officer, the clerks, the candidates or their agents, and the police officers on duty.
- 7. Every candidate may, if he think fit, appoint by writing under his hand a person to represent him at the polling station to see that the votes are fairly taken and may also appoint in writing an agent to represent him at the counting of the votes by the Returning Officer.
- 8. (1) No inquiry shall be made at any election as to the right of any person to vote, except that the polling officer

shall, if the right of any person to vote is challenged, put to such voter the following questions:—

- (a) Are you the person whose name appears as AB on the voters' roll of voters in this ward, or polling district (as the case may be)?
- (b) Have you already voted at this election in the capacity in which you now claim to vote?

And no person who shall refuse to answer such questions, or who shall not answer the first of such questions in the affirmative and the second of such questions in the negative shall be permitted to vote.

- (2) Any person who wilfully makes a false answer to either of these questions shall be guilty of an offence and shall be liable on conviction to a fine not exceeding fifty pounds or to imprisonment of either description for a period not exceeding six months, or to both such fine and imprisonment.
- 9. Every voter coming to record his vote shall vote without undue delay, and any voter who delays unduly in recording his vote may, unless he shall forthwith proceed to vote upon being required to do so by the presiding officer, be compelled to hand to the presiding officer any ballot paper which he may have received and may be removed from the polling station upon the instruction of the presiding officer. Such voter shall not be entitled to vote at such election, but such ballot paper shall be treated as a spoiled paper under Rule 11 hereof.
- 10. Every voter shall vote at the polling station appointed for the ward or polling district, as the case may be, in respect of which his or her name appears upon the voters' roll, and at no other place.
- 11. The voting at all elections held under these Rules shall be by ballot which shall be conducted in substance and as nearly as is material in the following manner:—
 - (a) The presiding officer at each polling station shall ascertain that the person coming to vote is a voter enrolled upon the voters' roll for the ward or polling district, as the case may be, and having ascertained that such person is so enrolled shall enter the number appearing against his name in the voters' roll upon the counterfoil of the ballot paper, and shall tear out the ballot paper corresponding with such counterfoil and mark the same with an official mark, either stamped or perforated, and shall then hand such ballot paper to the voter and place a mark against the number of the voter in the voters' roll to denote that such voter has received a ballot paper.
 - (b) When the voter has received such ballot paper, on which shall be printed in alphabetical order the names of all duly nominated candidates, he shall take the same to the compartment and desk provided for that purpose and signify for whom he desires to vote by secretly placing a cross against the name of the candidate whom he wishes elected. He shall then fold the ballot paper so that the official mark shall be visible, and having held up the ballot paper so that the polling officer can recognise such mark shall drop the ballot paper in the ballot box placed in front of the polling officer.

- (c) Should the voter either sign his name on the ballot paper or place any mark or word by which his ballot paper would become recognisable, then such ballot paper shall be considered blank and shall not be taken into account.
- 12. If a voter inadvertently spoils a ballot paper he may return it to the presiding officer from whom he received it, who shall, if satisfied of such inadvertence, give him another paper and retain the spoiled paper, and the spoiled paper shall be immediately cancelled and the fact of such cancellation shall be entered upon the counterfoil.
- 13. The presiding officer on the application of any voter who is unable to read or who is incapacitated by blindness or other physical cause from voting in the manner prescribed by these Rules shall, before such of the candidates or their agents as may be present, cause the vote or votes of such voter to be marked on a ballot paper or papers in a manner directed by such voter and the ballot paper or papers to be placed in the ballot box; and the name and number on the voters' roll of every voter whose vote is marked in pursuance of the terms of this Rule and the reason why it is so marked shall be entered on a list in these Rules called the "list of votes marked by the presiding officer."
- 14. If a person representing himself to be a particular voter applies for a ballot paper after another person has voted as such voter, the applicant shall, upon duly answering the questions permitted by these Rules to be asked of voters at the time of polling, be entitled to mark a ballot paper in the same manner as any other voter, but the ballot paper (hereinafter called "a tendered ballot paper") shall not be put in the ballot box, but shall be given to the presiding officer and endorsed by him with the name of the voter and his number on the voters' roll and set aside in a separate packet, and shall not be counted by the returning officer, and the name of the voter and his number on the roll shall be entered in a list, in these Rules called the "tendered votes' list."
- 15. Every presiding officer shall as soon as practicable after the close of the poll, before such of the candidates or their agents as shall be present, make up into separate packets sealed with his own seal and the seals of such agents of the candidates who desire to affix their seals—
 - (a) each ballot box entrusted to him unopened but with the key attached;
 - (b) the unused and spoiled ballot papers placed together;
 - (c) the tendered ballot papers;
 - (d) the marked copies of the voters' roll and the counterfoils of the ballot papers;
 - (e) the tendered votes' list and the list of votes marked by him as presiding officer and a statement of the number of voters whose votes are so marked by the presiding officer under the head, "Physical Incapacity";

and shall deliver such packets to the Returning Officer.

The packets shall be accompanied by a statement made by each presiding officer showing the number of ballot papers entrusted to him and accounting for them under the heads of ballot papers in the ballot box, unused, spoiled and tendered ballot papers.

- 16. Upon receipt of the aforesaid packets from the presiding officer by the Returning Officer the latter shall take charge of the same and shall, in the presence of such of the candidates or their agents as may be in attendance, open the ballot boxes and ascertain the result of the poll by counting the votes given to each candidate, and shall forthwith declare those candidates, not exceeding the number of vacancies to be filled, who have received the highest number of votes to be duly elected. In the event of the number of votes being found to be equal for any two or more candidates all of whom cannot be declared elected to fill vacancies in the Council, the Returning Officer shall by lot immediately determine the election. The decision of the Returning Officer shall be final, subject to the provisions of section 28 of the Legislative Council Ordinance, Chapter 24 of the Revised Edition.
- 17. The Returning Officer shall reject and not count any ballot papers which—
 - (a) do not bear the official mark;
 - (b) give votes to more candidates than the voter is entitled to vote for;
 - (c) bear any writing or mark by which a voter can be identified otherwise than in these Rules prescribed;
 - (d) are unmarked or void for uncertainty;
 - (e) are returned under Rule 8:
- any ballot paper which he may reject as invalid and shall add to the endorsement "rejection objected to" if an objection be in fact made by or on behalf of any candidate to his decision. He shall endorse "returned under Rule 8" on any ballot papers returned under that rule.
- 19. The Returning Officer shall immediately after the declaration of the poll seal up the voting papers and all other documents relating to the election and shall deliver them to the clerk, who shall safely keep such sealed packet for six months, after the expiration whereof the said packet and all papers contained therein shall be destroyed in the presence of two members of the Council.
- 20. No such sealed packet as aforesaid shall be opened during the said period of six months unless by order of the Supreme Court or any Judge thereof, and if any person shall, contrary to the provisions hereof, wilfully break the seal or open such packet he shall upon conviction be liable to a fine of fifty pounds or to imprisonment of either description for a period not exceeding two months, or to both such fine and imprisonment.

INSTRUCTIONS TO APPLICANT.

Before signing this application, the applicant should carefully examine the qualifications and disqualifications of voters set out in this form.

Any person who wilfully makes any false statement on an application to be enrolled on any voters' roll is liable on conviction to a fine not exceeding twenty-five pounds or to imprisonment of either description for a period not exceeding three months or to both such fine and imprisonment.

If the District is divided into Wards a separate application form must be completed in respect of each Ward in which the applicant claims to be qualified.

QUALIFICATIONS OF INDIAN VOTERS.

The qualifications of Indian voters under section 11 of the Local Government (District Councils) Ordinance, 1928, are as follows:—

DISQUALIFICATIONS OF VOTERS.

The disqualifications of voters under section 12 of the Local Government (District Councils) Ordinance, 1928, are as follows:—

- (a) has been found by a competent court to be of unsound mind; or
- (b) has been convicted of a criminal offence, whether in the Colony or elsewhere, and has been sentenced to imprisonment for a term of not less than twelve months and has not received a free pardon: Provided that such disqualification shall cease two years after the date of the expiration of the sentence; or
- (c) has received relief from any public funds within twelve months prior to the date of his application to have his name entered upon the voters' roll; or
- (d) has been declared bankrupt or insolvent by a competent court, whether in the Colony or elsewhere, and has not received his discharge; or

- 1. These By-laws may be cited as "the Mombasa Municipality (Refuse Removal Fees) By-laws, 1929," and shall take effect as from the 1st day of January, 1929.
 - 2. For the purposes of these By-laws:—
 - "Native dwelling house" shall mean a wattle and daub dwelling house defined as such under the Buliding Regulations.
 - "Shop" shall mean any building in which goods are sold or exposed for sale and shall include any building in respect of which the occupier holds a trading licence issued under the Traders' Licensing Ordinance (Chapter 58 of the Revised Edition) or a goldsmith's or silversmith's licence issued under the Brokers' Ordinance (Chapter 104 of the Revised Edition) or a pawnbroker's licence issued under the Pawnbrokers' Ordinance (Chapter 105 of the Revised Edition).
- 3. A refuse removal service shall be maintained by the Board in respect of all premises on the Island of Mombasa which in the opinion of the Board it is practicable and desirable to provide with such service, and the fees specified in the Schedule hereto shall be paid for such service.
- 4. The fees prescribed in the Schedule hereto shall become payable on the first day of March, the first day of June, the first day of September and the first day of December in each year.
- 5. Whenever it shall appear that any premises have remained unoccupied for not less than one calendar month the Town Clerk shall, on application, make a rebate or refund of the proportionate amount of the fee payable in respect of such premises provided that no such rebate or refund shall be made unless the application is made within two months from the date on which payment for the quarter, in respect of such premises is due.
- 6. Any employee of the Municipal Board provided with written authority signed by the Town Clerk shall, for the purpose of ascertaining by observation, measurement or otherwise, the class or classes to which any of the premises belong according to the Schedule hereto, have power to enter at any time between the hours of 8 a.m. and 4 p.m. any of the premises in respect of which fees are payable under these By-laws.

LOCUST REPORT, 7TH MARCH, 1929.

The only news of locusts now received concerns the arrival and departure of flying swarms.

Flying swarms should mature and lay about the beginning of May. Although swarms have recently reappeared in the region of Meru and have come also to Nyeri from the west, there has been a strong westerly movement generally. Swarms have arrived in Elgeyo from the east, and there are reports of swarms in the western Trans Nzoia and the Nandi. There are several swarms in Kisii.

In Tanganyika there is a movement about Kilimanjaro in a north-easterly direction, which may become accentuated, and there is a tendency for some of the swarms which went south to return north. Swarms have reached Mwanza from the east, and departed in a south-westerly direction. The presence of birds in numbers is reported and considerable natural destruction is taking place in most swarms.

It is as yet too early to indicate the areas of concentration of maturing locusts, but the presence of very large swarms between the Aberdares and Mount Kenya indicates that there may again be a concentration in the Isiolo area. Scouts are out in Turkana and Baringo, at Marsabit, Northern Frontier Province, and in Kavirondo.

Should a dry season such as we have experienced occur again this year, it is unlikely that the locusts which come to the laying stage will travel far away from the Colony before they lay. If good and very general rains fall much less risk will be run both as regards the infestation and as regards damage should flying swarms move over the Colony.

It is reported from Palestine that the large swarms there were dissipated by strong winds and enormous flocks of storks.
