LOCUST REPORT UP TO MARCH 27th, 1929.

Flying locusts have been and are now reported from practically all districts in Kenya. They occur in the Nandi, Trans Nzoia, Plateau, the Nakuru District, about Nairobi, below Nyeri, on the Aberdares, on Mount Kenya, about Voi, and are entering Kenya from Tanganyika daily.

Tanganyika reports that the vast majority of swarms in that territory turned northwards over a week ago and at the time of writing, it is apparent that the rains are driving the locusts rapidly northwards. No egg-laying is reported from Tanganyika, although a few swarms seen there are reaching maturity, and from Voi it is reported that a proportion of each swarm is reaching the yellow stage.

On the whole, locusts in those territories are within three or four weeks of laying and are present in very great numbers. Rain and cold damp winds make them move away rapidly if they are on the wing. If not flying, the insects crowd closely into bushes and trees and even densely on grass land. As they are unable to fly well if wet, the swarms do not usually move until rain has passed and they are fit to resume flight.

The white stork is found in considerable numbers; when resting on the ground they look, at a distance, like large flocks of sheep.

It is observed that swarms about Mount Kenya are flying high up the mountain; it is now known that in 1908 large numbers of locusts were seen dead about and below the snowline on that mountain.

As swarms become unmobilised due to weather conditions, their destruction by means of flame throwers will again be attempted, although the cost of the fuel used is abnormally high in this Colony.

It is regrettable that the onset of the rains in Tanganyika should have again been late this year as locusts would have been driven out of that territory in a younger stage, and consequently would have moved northwards two weeks ago. Should very heavy and continuous rain fall in the Colony with a very wide and simultaneous distribution, most swarms will be driven far afield, but if patchy rains fall such as we have experienced during the past few years, locusts will no doubt remain well within the Colony and will lay again.

- 3. The highest bidder will be the purchaser, but if any dispute arise as to any bid, the plot will be re-offered at the last undisputed bid.
- 4. Each purchaser shall pay to the Auctioneer immediately on the fall of the hammer a deposit of 25 per cent. of the purchase money. In default of such payment the plot may be immediately reoffered for sale and any subsequent bid by the person who has made default may be ignored or refused.
- 5. Each purchaser shall on paying the deposit inform the Auctioneer of the name or names and addresses of the person or persons on whose behalf the plot is purchased; the grant will be issued in accordance with this information.
- The balance of the purchase money together with the rent due to 31st December, 1929, shall be paid to the Senior Commissioner, Nakuru, while the survey fees, the fees payable for the preparation and registration of the grant (Sh. 110), and the stamp duty payable in respect of the grant and all other expenses, if any, shall be paid to the Surveyor General, Nairobi; all the amounts to be paid within 7 days from the date of the sale and upon such payments being duly made the purchaser shall, subject to the provisions of the Crown Lands Ordinance (Chapter 140 of the Revised Edition of the Laws of Kenya) the Registration of Titles Ordinance (Chapter 142 of the Revised Edition of the Laws of Kenya) and of these conditions of sale having been complied with, be entitled to a grant of the plot, which grant shall be presented to him duly executed as soon as conveniently may be. 7. (b) General.

- 1. The Government or such person or authority as may be appointed for the purpose shall have the right to enter upon any plot and lay and have access to water mains, service pipes, telegraph or telephone wires, and electric mains of all descriptions whether overhead or underground, and the grantees shall not erect any building in such a way as to cover or interfere with any existing routes, mains or service pipes, or the telegraph or telephone wires and electric mains aforementioned.
- 2. No building shall be erected on any plot unless plans (including block plans showing the position of the buildings), drawings, elevations and specifications thereof shall have been previously approved by the Authority and by the Commissioner for Local Government Lands and Settlement or such other person as he may appoint. The purchaser shall erect within two years of the commencement of his grant a building of approved design constucted of stone, burnt brick, concrete, asbestos, wood or iron, on proper foundations, provided that any buildings of asbestos, wood or iron shall not be erected within less than 5 ft. of any adjoining plot.
- 5. The grantee shall not at any time sub-divide the plot, or assign, sub-let or otherwise dispose of any portion of the plot without the previous written consent of the Governor.
- 6. Any building erected shall conform to a building line decided upon by the Authority.

(c) Special.

1. The plots shall be used for business purposes only but purchasers may be at liberty to use plots for the combined purpose of business and residence notwithstanding.

Provided that in the event of a plot being used for the said combined purpose then not more than one-half of the area thereof shall be built upon; otherwise not more than ninety per cent. of the area thereof shall be built upon.

Provided further that in no case shall the area of any plot used solely for business purposes required to remain unbuilt on be less than 300 sq. ft. and that the said area shall be free from any erection thereon above the level of the ground except latrine accommodation contructed in accodance with all laws and by-laws in force relating thereto, and in accordance with a design approved by the Authority.

Such open space shall be at the rear of the building and shall extend along the entire width of the building or for a distance of not less than 30 ft. whichever shall be the less and the distance across such open space from every part of the building to the rear boundary of the plot shall be not less than 10 ft.

- 2. At no time during the term of the grant shall any plot or any portion thereof or any building erected on the plot be used for the purpose of carrying on any trade or business which has been or may be declared to be dangerous or offensive by Notice in the Official Gazette.
- 3. Verandahs may be creeted within a road reserve with the previous consent of the Authority and must conform to a building line decided upon by such Authority.
