IN EXERCISE of the powers conferred upon it by section 69 (65) of the Local Government (Municipalities) Ordinance, 1928, the Municipal Council of Nairobi has made the following By-laws:—

- 1. These By-laws may be cited as the Nairobi Municipality (Amendment No. 3) By-laws, 1930, and shall be read as one with the Nairobi Municipality By-laws, 1929, and the Nairobi Municipality (Muthaiga Area) By-laws, 1929, hereinafter referred to as the "Principal By-laws."
- 2. By-law No. 557 of the Principal By-laws is hereby further amended by the revocation of sub-section (d) and the substitution therefor of the following:—
 - "557. (d) shall remain in the Municipality for a longer period than 36 hours (excluding from this period Sundays and public holidays) without employment (the proof whereof shall be on such native) or without having obtained from the Town Clerk a resident's or visitor's permit (as provided for in By-law 557A) or shall be found within the Municipality after the expiry of such permit."
 - 3. The following By-law is added:—
 - "557A. (1) The Town Clerk may issue to any native applying to him for permission to remain in the Municipality a resident's or visitor's permit.
 - (2) A resident's permit in the form of Schedule "A" hereto may be granted to a native by the Town Clerk for a period of 12 months. Such permit shall be granted to any native whom the District Commissioner may recommend in writing to the Town Clerk and shall be revocable after seven days' notice given to the holder in writing. Provided that nothing in this By-law contained shall render it unlawful for a holder of a resident's permit to be accompanied throughout the period of his residence in the Municipality under such permit by his wife and children, other than male children of an apparent age of more than sixteen years.
 - (3) A visitor's permit shall be in the form of Schedule "B" hereto and be valid for seven days from date of issue and be issued to such person as may apply to the Town Clerk to remain in the Municipality on his lawful occasions:

Provided that one visitor's permit only shall be issued in any consecutive period of thirty days to any one native save in any case wherein it shall be made to appear to the District Commissioner or the Town Clerk that the issue of a further visitor's permit to that native is necessary or desirable. (4) The Schedule to By-law No. 557 is hereby revoked."

Locust Report for Two Weeks ending 14-5-30.

No information has been received during the last two weeks as to the presence of locusts in the settled areas; Turkana, Baringo and parts of the Northern Frontier Province are, however, infested with gravid swarms and bands of hoppers, which, although not very extensive, may form the nucleus of future locust inroads.

HOPPERS.

Baringo.—One officer is operating in this district with bran bait. Hopper bands are very scattered.

S. Tukana.—Hoppers are reported to be in considerable numbers in the vicinity of the Suguta River. Natives are destroying the hoppers, but reports indicate that the situation is becoming beyond their control, and that European supervision is necessary.

N. Turkana.—Hoppers will hatch out during the next week in the area between Lake Rudolf and the Kuch mountains.

Northern Frontier Province.—A report from Marsabit states that the administrative headquarters is inundated with hoppers. The District Commissioner is dealing with the situation, and a supply of poison has been despatched from Nairobi.

Masai Reserve.—Owing to lack of communications and unpassable roads no report has been received from the officer operating in this Province.
