IN EXERCISE of the powers conferred upon him by the Townships Ordinance (Chapter 82 of the Revised Edition), His Excellency the Governor in Council has been pleased to make the following Rules :—

1. These Rules may be cited as "the Thika Township (Amendment) Rules, 1930," and shall be read as one with the Thika Township Rules, 1930, hereinafter called "the Principal Rules."

GOVERNMENT NOTICE NO. 366.

THE FISH PROTECTION ORDINANCE.

RULES.

IN EXERCISE of the powers conferred upon him by the Fish Protection Ordinance (Chapter 163 of the Revised Edition) His Excellency the Governor in Council has been pleased to make the following Rules :—

1. These Rules may be cited as "the Fish Protection (Lake Naivasha) Rules, 1930", and shall apply to Lake Naivasha.

2. (1) No person shall take or kill by any means whatsoever any fish of the species *Micropterus salmonoides* (Black Bass).

(2) No person shall take or kill any fish by any means whatsoever except by rod and line or by the net known as the 5 inch gill net.

(3) No person shall buy, sell, barter or exchange any fish taken from the waters of the Lake.

3. Any person who contravenes any provision of the last preceding Rule shall be guilty of an offence against these Rules, and shall, on conviction, be liable to a fine not exceeding thirty pounds and in default of payment to imprisonment of either description for a period not exceeding three months.

4. Any court before which any person is convicted of an offence against these Rules may, in addition to or in lieu of any other punishment, order that any net, stake, machine, instrument or appliance used or suspected of being used by such person in contravention of these Rules shall be confiscated.

GOVERNMENT NOTICE NO. 367.

THE INDIAN POST OFFICE ACT, 1898,

AND

THE POST OFFICE AMENDMENT ORDINANCES OF 1919 AND 1921.

RULES.

IN EXERCISE of the powers conferred upon him by the Indian Post Office Act, 1898, as applied to the Colony, the Post Office Amendment Ordinance, and all other powers thereunto enabling him, His Excellency the Governor in Council has been pleased to make the following Rules :---

1. These Rules may be cited as "the Telegraph Money Order Rules, 1930", and shall be read as one with the Telegraph Money Order Rules appearing at page 1122 of the Revised Subsidiary Legislation, hereinafter referred to as "the Principal Rules", and shall have effect as from the 1st day of June, 1930.

2. The Principal Rules are hereby amended by the insertion immediately after Rule 49 of the following Rule :----

Seychelles.

"49A. There shall be payable in respect of the issue of a telegraph money order payable in Seychelles, in addition to the commission chargeable on an ordinary money order issued on Seychelles and the charge for a telegram of advice, a special supplementary fee of one shilling."

GOVERNMENT NOTICE NO. 368.

THE TOWNSHIPS ORDINANCE.

RULES.

IN EXERCISE of the powers conferred upon him by the Townships Ordinance (Chapter 82 of the Revised Edition), His Excellency the Governor in Council has been pleased to make the following Rules :—

1. These Rules may be cited as "the Machakos and Kibwezi Townships Rules, 1930," and shall apply to the townships of Machakos and Kibwezi.

2. The words "common lodging house" as used in Rules 135 to 139 inclusive of the Township General Rules (Chapter 82 of the Revised Subsidiary Legislation) shall include native eating houses.

3. "Native eating house" means any premises kept for the purpose of gain, where food or drink is supplied to African natives or Asiatics, for consumption on such premises.

4. No premises shall be registered as a common lodging house or native eating house unless the Medical Officer of Health shall first certify that such premises are fit to be used for such purpose.

5. The Medical Officer of Health, the Police or the District Commissioner, or any other officer appointed by him for that purpose, shall have power at all times to enter upon any premises registered as a common lodging house or native eating house in order to inspect such premises.

6. The registration paper, granted by the District Commissioner in respect of any premises registered as a common lodging house or native eating house shall state the period for which such registration is available, and the number of persons that may be accommodated on such premises at any one time.

7. The licensee shall not allow any larger number of persons than by the conditions of his licence stipulated to be upon the licensed premises at any one time.

8. Any person who uses or permits any premises to be used as a common lodging house or for the purpose of carrying on the business of a native eating house, without such premises having been registered at the office of the District Commissioner or after the expiry of the period for which such registration is available under Rule 6 of these Rules, shall be deemed

to have committed an offence under these Rules.

9. A fee of Sh. 2 per month for the registration of common lodging houses and native eating houses shall be levied.

THE REGISTRATION OF DOMESTIC SERVANTS ORDINANCE, 1928.

Rules.

IN EXERCISE of the powers conferred upon him by the Registration of Domestic Servants Ordinance, 1928, His Excellency the Governor in Council has been pleased to make the following Rules :—

1. These Rules may be cited as "the Registration of Domestic Servants Rules, 1930."

2. The return to be furnished by an employer desiring to register a servant under the provisions of section 5 of the Registration of Domestic Servants Ordinance, 1928, herein referred to as "the Ordinance" shall be as set out in Schedule I attached to these Rules, and the servant shall furnish information as set out in Schedule II attached to these Rules.

3. When, through any cause whatsoever, the Registrar shall be unable to hand to a servant the pocket register for which he has applied, he shall issue to such servant a temporary licence in the form set out in Schedule III attached to these Rules. Such temporary licence shall only be valid for a period not exceeding fifteen days; it shall be retained by the employer, whose duty it shall be to cause his servant to exchange it for the pocket register issuable to him, on the expiration of the period for which the licence shall be valid.

4. When it shall be deemed necessary to establish a servant's identity by means of finger prints, the Registrar shall cause such finger prints to be taken on the form set out in Schedule IV attached to these Rules.

5. When a servant is permitted to establish his identity by means of photographs the applicant shall provide the Registrar, at his own expense, with two such photographs, and one copy shall, if so required, be authenticated by a responsible person to the satisfaction of the Registrar.

Photographs used for this purpose shall measure approximately 3 in. x 2 in. One copy shall be retained in the general register, and the duplicate shall be pasted in the space specially reserved for the purpose in the pocket register, and it shall be over-embossed by the departmental seal.

6. The copy of the particulars of employment required by section 14 of the Ordinance to be entered upon a servant's pocket register shall, on cessation of employment, be recorded on the perforated slip provided for the purpose in the pocket register, and shall be forwarded to the Registrar within fortyeight hours of such discharge or dismissal taking place. 7. (1) When a registered servant shall have been convicted of any offence for which a term of imprisonment or detention has been imposed without the option of a fine, it shall be the duty of the judge or magistrate to endorse in the pocket register the particulars of such conviction and thereafter to forward the pocket register to the Registrar at the place where the pocket register was issued.

(2) It shall be the duty of an employer within seven days of becoming aware that a registered servant in his employment has been convicted as aforesaid to forward to the judge or magistrate who recorded such conviction the pocket register of such registered servant.

(3) Every Superintendent of a prison or detention camp or a reformatory having in his custody a registered servant who has been sentenced to imprisonment or detention without the option of a fine shall forward to the judge or magistrate who recorded such conviction the pocket register of such registered servant.

(4) Every Superintendent of Police in whose district a registered servant is convicted of an offence for which a sentence of imprisonment or detention without the option of a fine is imposed, shall, within seven days, forward to the judge or magistrate who recorded such conviction any pocket register that may be found in the servant's possession.

8. It shall be the duty of an employer to forward to the District Commissioner within seven days of such death occurring, the pocket register of any registered servant dying whilst in his employ.

9. It shall be the duty of the Medical Officer in Charge of any hospital, or of the superintendent in charge of any asylum or quarantine, to forward to the Registrar within seven days, the pocket register of any unemployed registered servant dying whilst in his care.

10. If on revision or appeal the conviction of any registered servant is quashed or the sentence passed on such registered servant is varied to any sentence other than a sentence of imprisonment or detention without the option of a fine the particulars of such conviction endorsed in the pocket register shall be expunged by the Registrar or a deputy registrar of the Supreme Court.

11. It shall be lawful for the Registrar to whom application is made for the replacement of a pocket register that may have become lost, mutilated, or stolen, to demand from the servant the same means of identification he may have required on the occasion of his original registration. The fee for the replacement of such a pocket register shall be Sh. 5.

12. When a servant's pocket register shall have been endorsed by employers to its full capacity or shall have become indecipherable through fair wear and tear and the servant shall require a further pocket register, a second pocket register, bearing all the identification particulars of the first, shall be issued to him at a cost of Sh. 2.

13. All fees recoverable under the Ordinance shall be paid on application or on registration of engagement, as the case may be.

14. The pocket register shall be in the form in Schedule V of these Rules.

15. A registered servant desiring to have an alteration or correction made in the name appearing on his pocket register, may apply to the Registrar to have such correction or alteration made. The Registrar, on being satisfied of the bona fides of the application, may thereupon make the desired correction, and authenticate it by his name and designation and the date. If, in his opinion, the Registrar considers the alteration would deface the applicant's pocket register, he may issue a new amended pocket register, bearing the servant's record of service, and a note of the change of particulars :

Provided that if such servant be a person to whom the Native Registration Ordinance or any Ordinance amending or replacing the same, apply, no alteration or correction shall be made in the pocket register which is not consistent with the names and particulars in the Servant's Native Registration Certificate.

The fee for correction or alteration shall be Sh. 2, provided that the correction of an error made by the officer issuing the pocket register shall be made free of charge.

16. All endorsements made upon a registered servant's pocket register, and all returns submitted by employers, shall be written in English, and shall be made in black or blueblack ink only.

17. No servant shall keep or carry a pocket register other than the pocket register issued to him under these Rules.

18. Any person who shall come into possession of a pocket register in addition to the one issued to him, or shall be in possession of more than one pocket register, shall at the earliest opportunity forward the pocket register which was not issued to him, or which he has retained in addition to the last one issued to him, or of which he has come into possession by any other means, to the nearest Registrar.

19. No person shall withhold a pocket register from any servant entitled thereto, except for such reasonable period of time required to examine the particulars therein contained, or as provided for in section 13 of the Ordinance.

20. No person shall unlawfully or improperly deprive any servant of any pocket register in his possession.

21. No person shall at any time make any entry whatsoever on the pocket register of a registered servant with whom he has not entered into a contract of service.

22. No postage shall be payable on any postal packet sent by post in compliance with the provisions of any of these Rules.

GOVERNMENT NOTICE NO. 370.

THE ROADS PROTECTION ORDINANCE, 1924.

NOTICE.

WHEREAS by section 3 of the Roads Protection Ordinance, 1924, it is enacted that the Governor may, with the concurrence of the Local Authority concerned, by order prescribe that any road reserve or part thereof shall be open to traffic of a particular kind or shall be closed to traffic of a particular kind.

NOW, IN EXERCISE of the powers vested in him by the said section, His Excellency the Governor has, with the concurrence of the Uasin Gishu District Council, been pleased to order that the constructed and cambered carriageway on the public roads described in the schedule hereto shall be closed to all kinds of wheeled traffic except the following, namely :—

- (a) Pedal cycles.
- (b) Motor cycles with or without sidecars.
- (c) Light buckboards or carts designed for carrying passengers only.
- (d) Motor vehicles fitted with pneumatic tyres and not exceeding six-and-one-half tons gross weight,

and that all other vehicles shall use those portions of the said public roads which have been made for use by wagons.

THE DEFENCE FORCE ORDINANCE, 1927.

NOTICE.

BY VIRTUE of the provisions of section 13 (2) of the Defence Force Ordinance, 1927, His Excellency the Governor in Council has been pleased by order to exempt the following persons and classes of persons from such of the obligations imposed by the Defence Force Ordinance, 1927, as are herein-after set out, namely :---

Total exemption from all service under the Defence Force Ordinance :—

Ministers of religion who have undergone a ceremony of ordination in a recognized church;

Judges of the Supreme Court;

Members of the Executive and Legislative Councils;

Officers and non-commissioned officers of the King's African Rifles;

Officers of the King's African Rifles Reserve of Officers;

Officers of the Regular Army Reserve of Officers;

Officers of the Territorial Army Reserve;

Officers, non-commissioned officers and men of His Majesty's Navy, Army and Air Force or the Royal Marines in receipt of disability or wound pensions;

Officers and personnel of the Royal Naval Reserve or the Reserve of the Royal Marines;

Officers and non-commissioned officers of the Police Force;

European officers of the Prisons Service.

Partial exemption :---

Duly accredited members of Missionary Bodies are exempted from service under the Defence Force Ordinance except from the liability to perform after mobilization, such services of a non-combatant

nature as they may be called upon by the Defence Force Authorities to perform, such services to consist of—

(1) tending the sick and wounded;

(2) ambulance work;

(3) care of women and children;

(4) organization of camps for natives,

and such other services of a non-combatant nature as the administrative officers may from time to time request them to perform;

Administrative officers and Resident Magistrates are exempted from all service under the Defence Force Ordinance, except in cases where specified duties are assigned to them under the Ordinance itself. Conscientious objectors :---
