IN EXERCISE of the powers conferred upon me by Clause XXX of the Instructions passed under the Royal Sign Manual and Signet to the Governor and Commander-in-Chief of the Colony and Protectorate of Kenya and dated the 29th day of March, 1934, and all other powers thereunto enabling me, I hereby proclaim that the Legislative Council of the Colony shall be dissolved on the 10th day of February, 1938
