A Bill to Amend the King's African Rifles Ordinance, 1932

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:---

Short title.

No. 48 of 1932.

Amendment of section 80 of the principal Ordinance.

1. This Ordinance may be cited as the King's African Rifles (Amendment) Ordinance, 1946, and shall be read as one with the King's African Rifles Ordinance, 1932, hereinafter referred to as the principal Ordinance.

2. Section 80 of the principal Ordinance is hereby amended by 5 deleting the words "until he has received his certificate of discharge", which appear in the second and third lines thereof, and substituting therefor the words "until the date of his release or discharge as recorded in his release documents or certificate of discharge".

MORANDUM OF OBJECTS AND REASONS

This Bill seeks to amend the principal Ordinance (the King's African Rifles Ordinance, 1932) by making it clear that every locally enlisted British warrant or non-commissioned officer or soldier remains subject to all the provisions of the principal Ordinance and to any rules and regulations made thereunder until the date of his release or discharge as recorded in his release documents or certificate of discharge.

As at present worded section 80 of the principal Ordinance provides that such personnel remain subject to the provisions of the Ordinance and any rules and regulations made thereunder until they have received their certificate of discharge. Under the existing release arrangements a soldier about to be discharged is handed his certificate of discharge at the dispersal centre and the certificate is post-dated to the date upon which he is expected to report at the District Commissioner's office of his district. The soldier remains a member of His Majesty's Forces and is paid as such during the interval between his leaving the dispersal centre and reporting at the District Commissioner's office and it is considered desirable that he should be amenable to military discipline during that period.

No expenditure of public moneys will be involved if the provisions of this Bill become law.

A Bill to Amend His Majesty's Forces Pensions Ordinance, 1941

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:--

1. This Ordinance may be cited as His Majesty's Forces Pensions Short title. (Amendment) Ordinance, 1946, and shall be read as one with His Majesty's Forces Pensions Ordinance, 1941, hereinafter referred to as No. 24 of 1941. the principal Ordinance.

2. Section 2 of the principal Ordinance is hereby repealed and the following substituted therefor: -

replacement of section 2 of the principal Ordinance. "Power to make

Regulations.

2. (1) The Governor in Council may make Regulations-

(a) prescribing the conditions under and the manner in which pensions, gratuities or other allowances may be granted in respect of the death, disablement or sickness of any member of His Majesty's Forces who is serving or has served in any of such forces raised under the authority of any law for the time being in force in the Colony;

(b) providing for the establishment of Pensions Appeal Tribunals, to which an appeal may be made by any person who has been granted or refused a pension, gratuity or other allowance or whose pension, gratuity or other allowance has been varied and who is aggrieved by such grant, refusal or variation;

(c) prescribing the manner in which and the time within which appeals shall be made to, and the manner in which appeals shall be heard by, a Tribunal;

- (d) providing for the mode of proof, the admissibility of evidence, and for the disclosure of documents whether in the possession of a government department or not;
- (e) providing for the representation of an appellant or any other party to the proceedings at the hearing of an appeal and, in particular, for cases where an appellant owing to illness or any other cause is unable to be present at the hearing of an appeal;
- (f) providing for the payment of travelling expenses and allowances to members of a Tribunal, to appellants or to their representatives or attendants, and of medical expenses reasonably incurred by an appellant for the purpose of an appeal;
- (g) providing for the recording and proving of the decisions of a Tribunal;

Repeal and

(h) providing for the appointment of such staff as may be necessary to enable a Tribunal properly to fulfil its functions;

(i) providing for all such other matters, whether similar to or of the same nature as the foregoing or not, relating to the powers, duties and procedure of a Tribunal.

(2) The decision of a Tribunal upon an appeal made under the provisions of any Regulations made under this section shall be final and conclusive.

(3) In this section the expressions "a Tribunal" and "appellant" mean, respectively, any Pensions Appeal Tribunal appointed under Regulations made under the provisions of paragraph (b) of sub-section (1) of this section, and any person who is aggrieved by the grant, variation or refusal of a pension, gratuity or other allowance and who appeals against such grant, variation or refusal.

(4) All Regulations made under the provisions of sub-section (1) of this section shall be laid before the Legislative Council of the Colony within fourteen days after the making thereof if the Legislative Council is then in session, and, if not, shall be so laid before the Legislative Council within fourteen days of the next ensuing session".

MEMORANDUM OF OBJECTS AND REASONS

The object of this Bill is to repeal and replace section 2 of His Majesty's Forces Pensions Ordinance, 1941 (No. 24 of 1941).

Paragraph (a) of sub-clause (1) of Clause 2, and sub-clause (4) of Clause 2 reproduce, with amendments, the section which this measure seeks to repeal.

Paragraphs (b) to (i) of sub-clause (1) and sub-clauses (2) and (3) of Clause 2 are new.

In 1943 a Select Committee of Legislative Council was appointed to examine the Regulations under which pensions and gratuities were paid to European members of the Armed Forces and their dependants. At that time the legislation in force consisted of the principal Ordinance and two sets of Regulations, one for Europeans and one for Africans, the grant of pensions and gratuities, etc., to Asian members of the Armed Forces and their dependants being dealt with by administrative action using the Royal Warrant as a basis.

The Select Committee, apart from recommending various alterations to the existing Regulations, specifically recommended that an independent Tribunal should be appointed to consider and decide appeals against decisions of the Pensions Assessment Board (at present determined by the Governor) and they also recommended that the procedure adopted in the United Kingdom should be followed.

In April, 1944, two *ad hoc* committees were appointed, one to consider the question of pensions to Asian members of the Armed Forces and their dependants, and one to deal with pensions for African members of the Armed Forces and their dependants.

Both the above-mentioned committees reported in 1945, and both of them followed the recommendations of the Select Committee of Legislative Council and recommended the establishment of a Pensions Appeal Tribunal.

This Bill seeks to empower the Governor in Council to make Regulations which will, in accordance with the recommendations of the committees referred to above, as nearly as possible follow the procedure in the United Kingdom.

It is not possible to say what expenditure of public moneys will be involved if the provisions of this Bill become law.

A Bill to Amend the Education Ordinance, 1931

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

Short title.

No. 2 of 1931.

Repeal and replacement of paragraph (5) of section 19 of the principal Ordinance. 1. This Ordinance may be cited as the Education (Amendment) Ordinance, 1946, and shall be read as one with the Education Ordinance, 1931, hereinafter referred to as the principal Ordinance.

2. Paragraph (5) of section 19 of the principal Ordinance is hereby repealed and the following paragraph substituted therefor: -5

"(5) to advise the Director upon all applications for admission or readmission of pupils to the school or group of schools in respect of which the committee is appointed;".

MEMORANDUM OF OBJECTS AND REASONS

Paragraph (5) of section 19 of the principal Ordinance (the Education Ordinance, 1931) provides that a school committee shall consider and decide all applications for admission or readmission of pupils to the school in respect of which the committee is appointed and the paragraph confers, upon an applicant, the right to appeal to the Director of Education against a decision of a school committee.

In the light of experience it is considered desirable that school committees should act, in such matters, in an advisory capacity only. Clause 2 of the Bill, therefore, seeks to repeal paragraph (5) of section 19 of the principal Ordinance and to substitute a new paragraph therefor, which gives effect to that policy.

No expenditure of public moneys will be involved if the provisions of this Bill become law.

A Bill to Amend the Increased Production of Crops Ordinance, 1942

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:-

1. This Ordinance may be cited as the Increased Production of Short title. Crops (Amendment) Ordinance, 1946, and shall be read as one with the Consolidated Edition of the Increased Production of Crops Ordinance, 1942, prepared under the provisions of section 23 of the Increased No. 13 of 1943. ⁵ Production of Crops (Amendment) Ordinance, 1943, hereinafter referred to as the principal Ordinance.

2. Section 2 of the principal Ordinance is hereby amended—

- (a) by deleting the words "Agricultural Production and Settlement Board", which appear in the first line of the definition "Board", and substituting therefor the words "Board of Agriculture"; and
- (b) by deleting the words "Agricultural Production and Settlement", which appear in the second and third lines of the definition "crops".

15 3. Sub-section (2) of section 12 of the principal Ordinance is hereby amended by inserting between the words "increase" and "his", which appear in the fourth line thereof, the words "or modify".

> 4. Section 23 of the principal Ordinance is hereby amended— Amendment of (a) by inserting immediately after the word "marketed", which the principal appears in the second line of sub-section (1) thereof, the Ordinance. following words: —

"and any person so appointed shall comply with all orders issued to him by the Board relating to the expenses which may be incurred and the charges which may be made in connexion with such marketing";

and

(b) by repealing sub-section (2) thereof and substituting the following sub-section therefor: ----

"(2) The Board may—

(a) issue orders relating to the marketing of any crop; and

(b) subject to the approval of the Governor in Council, issue orders regarding the price at which any crop may be sold,

to any person appointed under the provisions of sub-section (1) of this section, and to the Agency appointed under the Sale of Wheat Ordinance, 1930, and any such person and the Agency shall comply with any orders so issued, and shall on demand by the Board supply all such information relating to any crops marketed by them as the Board may require.".

MEMORANDUM OF OBJECTS AND REASONS

The body responsible for carrying out the provisions of the principal Ordinance, the Increased Production of Crops Ordinance, is "the Board" which is defined, in section 2 of the Ordinance, as the "Agricultural Production and Settlement Board". As a result of the reorganization which has taken place consequent on the appointment of the Member for Agriculture and Natural Resources, settlement is now organized separately from agricultural production and it is therefore considered desirable to amend the principal Ordinance by changing the present title of the Board charged with its administration. Clause 2 of the Bill, therefore, seeks to change the title of the Board to "the Board of Agriculture". That title has been recommended by the Executive Committee of the production section of the Agricultural Production and Settlement Board and by the Advisory Committee which was appointed to advise the Member as to the reorganization which should be made.

Sub-section (2) of section 12 of the principal Ordinance provides, inter alia, that a farmer who has submitted a programme of production who wishes to increase his programme shall forthwith notify the Board, in writing, through the District Production and Man Power Committee, to that effect. In most cases it has been found that a modification rather than an increase in programme is desired. That being so clause 3 of the Bill seeks to rectify the position by inserting "or modify" in that sub-section.

Section 5 of the principal Ordinance provides that the Governor in Council may, on the advice of the Board, declare f.o.r. prices to farmers for crops declared to be crops for the purpose of the Ordinance. With the cessation of hostilities consideration was given by the Production Section of the Agricultural Production and Settlement Board to the policy of guaranteeing prices to farmers, and the Board decided that it would be desirable to return to the pre-war system of disposal of cereal crops as soon as possible in those cases where it was convenient to do so. It is proposed, therefore, by the amendments made to section 23 of the Ordinance to make provision that the agents appointed by the Board for the disposal of crops may, subject to the approval of the Governor in Council, be instructed by the Board as to the prices at which any particular crop shall be disposed of. In order to safeguard the interests of the farmer, provision is made for the agents to comply with orders issued by the Board relating to the expenses which they may incur and the charges which they may make and deduct from the selling price of the crop.

No expenditure of public moneys will be involved if the provisions of this Bill become law.

Short title.

No. 34 of 1938.

Amendment of section 20 (1) of the principal Ordinance

1. This Ordinance may be cited as the Pyrethrum (Amendment) Ordinance, 1946, and shall be read as one with the Pyrethrum Ordinance, 1938, hereinafter referred to as the principal Ordinance.

2. Sub-section (1) of section 20 of the principal Ordinance is hereby amended by inserting, immediately after paragraph (i) thereof, 5 the following new paragraph: ---

"(*jj*) prescribing the areas which shall be planted and maintained with trees by pyrethrum growers and the type of trees which shall be so planted in any particular area;".

MEMORANDUM OF OBJECTS AND REASONS

This Bill seeks to amend sub-section (1) of section 20 of the principal Ordinance (the Pyrethrum Ordinance, 1938) by enabling the Governor in Council to make rules laying down the areas which shall be planted and maintained with trees by pyrethrum growers and the type of trees which shall be so grown in any particular area.

In the light of experience it has been found that many pyrethrum growers do not grow sufficient timber, suitable for use as fuel, for the needs of their pyrethrum driers and it is considered desirable, in view of the large quantity of fuel used in the industry, to enable rules to be made which will aim at protecting the position in the future.

No expenditure of public moneys will be involved if the provisions of this Bill become law.

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:----

1. This Ordinance may be cited as the Sugar (Amendment) Short title. Ordinance, 1946, and shall be read as one with the Sugar Ordinance (Chapter 134 of the Revised Edition), hereinafter referred to as the Cap. 134. principal Ordinance.

2. Section 8 of the principal Ordinance is hereby amended as 5 follows----

(a) by inserting between the figure "8" and the word "Any", which appear in the first line thereof, the figure and brackets "(1)";

(b) by adding thereto the following sub-section: -

(2) Where any vehicle has been taken to a police station, under the provisions of sub-section (1) of this section, and the police officer in charge of such police station, after inquiry from the person in charge of such vehicle, has reasonable cause to believe that any of the provisions of sections 3, 4 and 5 of this Ordinance have been contravened he may seize any sugar or sugar juice contained in such vehicle and retain it for a period not exceeding one month, or if within that period there are commenced proceedings for a contravention of any of the provisions of this Ordinance, in which such sugar or sugar juice can properly be adduced in evidence, until the final determination of such proceedings.

This Bill seeks to amend the principal Ordinance (the Sugar Ordinance, Chapter 134 of the Revised Edition) by empowering any police, or tribal police, officer in any area to which the new provisions are applied, by the Governor, by notice published in the Gazette, to

The measure also seeks to empower any police officer in charge of a police station to which any vehicle containing sugar or sugar juice is taken, if he has reasonable cause to believe that any of the provisions of sections 3, 4 and 5 of the principal Ordinance are being contravened, to retain such sugar or sugar juice for a period not exceeding one month, or if within that period proceedings for a contravention of any of the provisions of the principal Ordinance are commenced, in which such sugar or sugar juice can properly be adduced in evidence, until the final determination of such proceedings.

The Bill also seeks to amend section 8 of the principal Ordinance by adding a sub-section thereto to enable the court to order any article which forms an element in a contravention of any of the provisions of the Ordinance to be forfeited to the Crown.

The opportunity has also been taken to repeal section 10 of the principal Ordinance and substitute a new section therefor. The new section seeks to confer upon the Governor, instead of the Governor in Council, power to declare any area in the Colony a "Prohibited area" for the purposes of the Ordinance. The existing section enables the Governor in Council, by proclamation, to apply any section of the Ordinance to any area in the Colony but in view of the fact that section 3 has already been applied to the whole Colony and the application of the rest of the Ordinance only concerns Prohibited areas, it is not considered necessary to re-enact those provisions.

No expenditure of public moneys will be involved if the provisions of this Bill become law.
