CATTLE CLEANSING—EFFECTIVE TICK-DESTROYING  
AGENT

IN EXERCISE of the powers conferred upon me by section 2 of the Cattle Cleansing Ordinance, 1929, I hereby prescribe that an effective tick-destroying agent is any preparation which when mixed with water, in accordance with the instructions printed by the manufacturer on the label of the container, will produce a solution containing arsenious oxide ( $As_2O_3$ ) in the following concentrations:—

(a) Where the cleaning by immersion or spraying is repeated at intervals of not more than seven or less than five days: 0.16 per cent by weight.

(b) Where the cleaning by immersion or spraying at intervals of three days: 0.08 per cent by weight:

Provided that when Coopers approved dip, or any other dip, specifically approved by me from time to time, is used, such concentration of arsenious oxide may be reduced where the cleaning is repeated at intervals of not more than seven or less than five days to 0.125 per cent by weight.

And I hereby further prescribe that to clean cattle by hand-dressing means—

(a) to apply to the inside of the ears, the end of the tail and under the tail a fatty or oily dressing, when so instructed by an Inspector; or

(b) to spray or brush on to the skin and to apply to the inside of the ears, the end of the tail and under the tail an aqueous solution containing not less than 0.08 per cent of arsenious oxide by weight; and

(c) if so ordered by an Inspector, to remove the tail-brush by clipping.

PURSUANT to section 92 of the Local Government (District Councils) Ordinance, 1928, all persons concerned are hereby informed that the Nairobi District Council, at a special meeting held on the 3rd of May, 1946, fixed Monday the 2nd of September, 1946, as the day upon which the rate for the year 1946 shall become due and payable.

Division 1.—1 to 5 acres: Sh. 2 per acre.

Division 2.—Over 5 to 10 acres: Sh. 1/50 per acre.

Division 3.—Over 10 to 50 acres: Cents 50 per acre.

Division 4.—Over 50 to 500 acres: Cents 20 per acre.

Division 5.—Over 500 to 5,000 acres: Cents 2 per acre.

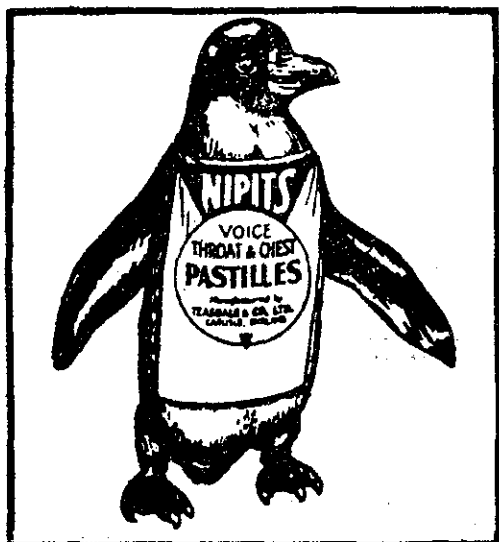

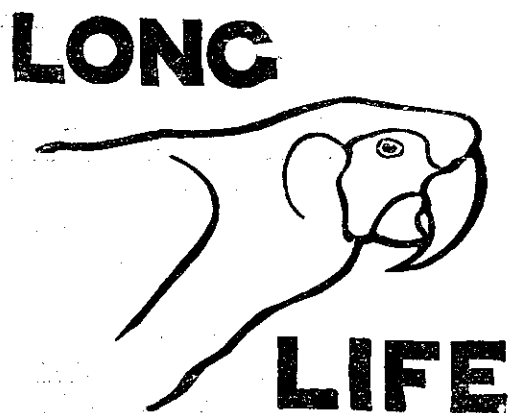

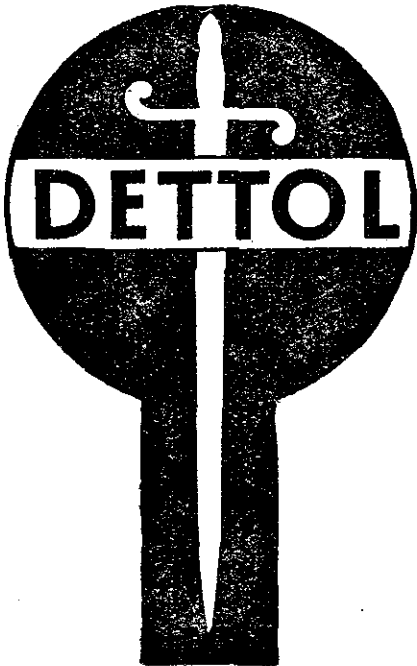
