### VACANCIES IN GOVERNMENT DEPARTMENTS

Senior Technical Instructors, Prisons Department

APPLICATIONS are invited for two vacancies in the post of Senior Technical Instructor, Prisons Department: they should be submitted to the Commissioner of Prisons, P.O. Box 420, Nairobi, to reach him not later than 30th January, 1948.

The salary scale of the post is £360 by £20 to £660 per annum (initial salary according to age, qualifications and experience) on Kenya European Civil Service terms and conditons of service which include—

- (f) when not in occupation of Government quarters, housing allowance is payable to a limit of  $7\frac{1}{2}$  per cent of the salary when the salary does not exceed £520 per annum and 5 per cent of the salary when it exceeds that amount; in cases of hardship due to payment of a high rental, the allowance may be increased to  $17\frac{1}{2}$  per cent of the salary when the salary does not exceed £520 per annum and 15 per cent of the salary when it exceeds that amount.

### NOTICE TO IMPORTERS, EXPORTERS AND CLEARING AGENTS

THE ATTENTION of all importers, exporters, clearing agents and other interested persons is drawn to the new official Import and Export List, published in Government Notice No. 892 of 6th June, 1947, in Kenya, and as a supplement to the Gazette of 15th December, 1947, in Uganda, which will come into effect on 1st January, 1948.

On and after 1st January, 1948, all goods entered for importation or exportation must be described on the appropriate entry in accordance with Part B of the list and the appropriate code number in column 4 thereof is to be inserted on the entry underneath the description of the goods. The code number is not to be inserted in the space provided on the entry for "Class No.", which is to be left blank. The appropriate item number and minimum list number in columns 1 and 2 of Part B of the list are *not* required to be inserted on the entry.

Goods entered provisionally on deposit in accordance with section 63 of the Customs Management Ordinance, 1926, need not be described on the relative provisional entry in accordance with the new Import and Export List and the appropriate code numbers need not be inserted.

It is not proposed to revise the form of any import or export entry at the present time. In the event of any such revision taking place, due notice will be given and importers and exporters will be allowed ample time in which to use up stocks of entries in the old form.

(Chapter 140 of Revised Edition)

TOWNSHIP PLOTS--KITALE

NOTICE is hereby given that grants in respect of the plots at Kitale as described in the schedules hereto will be sold by public auction at the offices of the District Commissioner, Kitale, on Thursday, 29th January, 1948, at 10 a.m.

A plan of the plots contained in the schedule may be seen at the offices of the Commissioner of Lands, Nairobi, or at the office of the District Commissioner, Kitale, as the case may be, or may be obtained on application to the Commissioner of Lands, P.O. Box 89, Nairobi, on payment of Sh. 3 each, post

The right to withdraw any plot from the sale is reserved to the Commissioner of Lands.

In the following conditions of sale the term authority means the District Commissioner, Kitale, or such Municipal Authority as may be hereafter established by law.

### (a) General Conditions

- 1. Each plot will be auctioned separately.
- 2. The amount of the advance of each bid will be regulated by the auctioneer and no bidding shall be retracted.
- 3. The highest bidder will be declared the purchaser of the plot, but if any dispute arises as to any bid, the plot will be re-offered at the last undisputed bid.
- 4. Each purchaser shall pay to the auctioneer immediately on the fall of the hammer, 25 per cent of the amount of his bid. In default of such payment, the plot may be immediately re-offered for sale and any subsequent bid by the person who has made default may be ignored or refused.
- 5. Each purchaser shall, on paying the deposit, inform the auctioneer of the name or names of the person or persons on whose behalf the plot is purchased, and any subsequent grant that may be made will be issued in accordance with this information.
- 6. The amount bid in respect of the plot shall be considered as the stand premium payable thereon.
- 7. The balance of the amount bid, together with the roads and drains contribution in respect of the plot, the survey fees and the rent due to 31st December, 1948, shall be paid to the Commissioner of Lands within seven days of the date of auction, together with the fees payable in respect of the preparation and registration of the grant (Sh. 120) and the stamp duty payable in respect of the grant (approximately 2 per cent on the amount bid and the rent). In default of such payments within the specified time, the Commissioner of Lands may order the deposit paid by the purchaser to be forfeited and the purchaser shall have no further claim to the grant of the plot; provided that the balance of the purchase money shall not be payable within the time stated or thereafter, unless and until the Commissioner of Lands can present to the purchaser the grant duly executed.
- 8. Subject to the proviso contained in Condition 7, if the amounts therein mentioned are not paid as therein laid down wthin seven days of a demand being made therefor, the Commissioner of Lands may order the deposit made by the purchaser to be forfeited and the purchaser shall have no further claim to the grant of the plot.

### (b) Conditions of Grant

1. The purchaser shall erect, within two years of the commencement of his grant, a building of approved design, constructed of stone, burnt brick or concrete on proper foundations.

- 2. No building shall be erected on any plot unless plans (including block plans showing the position of the buildings), drawings, elevations and specifications thereof shall have been previously approved by the authority, and by the Commissioner of Lands or such other person as he may appoint. Such plans, etc., shall be submitted in triplicate to the District Commissioner, Kitale, within three months of the date of sale.
- 3. Grants will be made under the Crown Lands Ordinance (Chapter 140 of the Revised Edition of the Laws of Kenya) and titles will be issued under the Registration of Titles Ordinance. The term of the grants will be 99 years from the 1st day of February, 1948, at the annual rents specified in the
- 4. The grantee shall not, at any time, subdivide the plot, or assign, sub-let or otherwise dispose of any portion of the plot.
- 5. Any building erected shall conform to a building line decided upon by the authority.
- 6. The grantee shall not transfer the plot nor enter into any mortgage charge or agreement of sale in respect thereof within five years of the date of commencement of the grant.
- 7. All out-buildings, offices, etc., shall be properly sited and screened from view to the satisfaction of the authority or such other person as may be appointed and shall be kept so screened during the term of the grant.
- 8. The Government or such person or authority as may be appointed for the purpose shall have the right to enter upon any plot and lay and have access to water mains, service pipes, telegraph or telephone wires, and electric mains of all descriptions, whether overhead or underground, and the grantee shall not erect any building in such a way as to cover or interfere with any existing routes, main or service pipes or the telegraph or telephone wires and electric mains aforementioned.
- 9. Grantees will be required to pay municipal rates upon the whole of the rateable interest and Government's contribution in lieu of rates assessed on the plots. A condition will, therefore, be embodied in each grant providing for the necessary adjustment between the grantee and the Government.
- 10. Under Government Notice No. 20 of 1945 the permission of the Supply Board is required for the erection of a building exceeding £50 in value, but no guarantee can be given that a building permit will be issued in respect of the building required to be erected under the conditions of the grant.

#### (c) Special Conditions in Respect of Business Plots in Schedule I

- 1. The plot and the buildings to be erected thereon shall be used for business purposes only and at no time during the term of the grant shall any building erected on the plot be used for residential purposes.
- 2. The grantee shall not at any time during the term of the grant erect any building or buildings so as to cover more than 90 per cent of the area of the plot.
- 3. In no case shall the area of the plot required to remain unbuilt on be less than 300 square feet or 10 per cent of the area, whichever shall be the greater, and the said area shall be free from any erection thereon above the level of the ground except latrine accommodation constructed in accordance with all laws and by-laws in force relating thereto, and in accordance with a design approved by the authority.

Such open space shall be at the rear of the building, and shall extend along the entire width of the building, or for a distance of not less than 30 feet, whichever shall be the less, and the distance across such open space from every part of the building to the rear boundary of the plot shall be not less than 10 feet.

- 4. At no time during the term of the grant shall the plot or any portion thereof, or any building erected on the plot be used for the purpose of carrying on any trade or business which has been or may be declared to be dangerous or offensive by notice in the Official Gazette.
- 5. A verandah may be erected within the road reserve with the previous consent of the authority, and must conform to a building line decided upon by such authority.

### (d) Special Conditions in Respect of Plots in Schedule II

- 1. The conditions Nos. 2 to 5 contained in (c) will apply.
- 2. The plots in Schedule II will be reserved for the erection of offices only for commercial and professional undertakings and may be used for no other purpose without the previous written consent of the Commissioner of Lands, except that quarters as living accommodation may be provided for the office manager with the approval of the local authority concerned and the Commissioner of Lands.

### (e) Special Conditions in Respect of Residential Plots in Schedule III

- 1. Fittings and floor and roof may be of an approved temporary material and construction provided that these be replaced by approved permanent materials within six months of notice being given by the Commissioner of Lands.
  - 2. The plot shall be used for residential purposes only.
- 3. At no time during the term of the grant shall more than one dwelling-house with necessary offices and out-buildings be erected on the plot without the consent of the Governor.

4. The grantee shall not at any time during the term of the grant erect any building or buildings to cover more than one-third of the area of the plot.
