His Excellency the Governor deeply regrets to announce the death of **Dr. R. K. J. Gascoigne**, Entomologist, Department of Agriculture, which occurred on 24th March, 1948, at Nairobi, following a flying accident.

Dr. Gascoigne was first appointed to the Colonial Service in 1937 as a Field Officer in the Tsetse Research Department of Tanganyika, and was transferred to Nigeria as an Entomologist in 1940. ## (a) General Conditions

3. The highest bidder will be declared the purchaser of the plot, but if any dispute arises as to any bid the plot will be reoffered at the last undisputed bid.

2.
