ORDINANCE, 1928

BY General Notice dated 15th April, 1948, appearing during April and May, 1948, in the local Press the attention of the public was drawn to the provisions of the above Ordinance in view of the numerous contraventions which have been brought to the notice of the Public Health (Division of Lands) Board. The notice briefly explained the provisions of section 6 of the Ordinance by which, inter alia, the sub-division of land into plots of less than 20 acres or the building of more than one house or shop on plots of less than 20 acres or on the same piece of land less than 300 yards apart was prohibited save and except with the approval thereto of the Board having first been obtained.

The Board is satisfied that the contraventions which have been reported to it prior to or as a result of the said notice dated 15th April, 1948, had been committed in genuine ignorance of the requirements of the law. It has therefore been decided that, provided that the provisions of the Ordinance are now properly complied with by such persons having so contravened the same and that the contraventions in so far as the building of dwelling-houses is concerned do not offend principles of health and sanitation, the Board shall not prosecute such persons.

The Board, however, takes the opportunity of once more and finally warning members of the public that any further contraventions will be rigorously dealt with according to law and of reminding the public that the penalties prescribed by the Ordinance entail penal amounts up to £100 and £5 additional for each day of continuance as well as liability to demolition of the unauthorized building.

VACANCIES IN GOVERNMENT DEPARTMENTS

Administrative Secretary, Medical Department

APPLICATIONS are invited for appointment to the post of Administrative Secretary, Medical Department, Kenya. The post is a pensionable one on overseas terms of service and appointment may be on probation for two years at the discretion of the Government of Kenya. Salary scale, £350; £350; £400 by £50 to £500 by £25 to £600 by £60 to £660 by £30 to £840 by £40 to £1,000 with incremental credit for war service and previous experience; efficiency bars at £600 and £840. This salary scale may be subject to revision as a result of the report of the East African Salaries Commission. The successful candidate would be eligible for the cost of living allowance at present being paid to officers; this is an emergency allowance to meet the increased cost of living, and may be withdrawn should conditions improve. The successful candidate would be eligible for free quarters; or, if quarters were not available, for house allowance based on the actual rent paid, but not exceeding 15 per cent of the minimum of the salary scale; the efficiency bar, when it has been passed, is considered the minimum for this purpose. Applicants should preferably be under 40 years of age. They should have administrative experience and should possess a thorough knowledge of office organization. It is desirable that they should also possess a knowledge of the principles of cost accounting and experience of the extraction and compilation of statistics. A firm, capable person is required. Previous experience or employment in such a post and a knowledge of medical affairs, health legislation and the like would be an advantage.
