A BILL ENTITLED AN ORDINANCE TO AMEND THE POLICE ORDINANCE, 1948

ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows—

Short t tle

No 79 of 1948

1. This Ordinance may be cited as the Police (Amendment, No 2) Ordinance, 1950, and shall be read and construed as one with the Police Ordinance, 1948 (hereinafter referred to as the principal Ordinance)

Insertion of new Part VII in the principal Ordinance 2. There shall be inserted next after section 63 of the 5 principal Ordinance a new Part VII as follows—

PART VII—CURFEW

Curfew Order

- 64 (1) If at any time it shall appear to the Commissioner, or to a Provincial Commissioner, that there is a reasonable apprehension that a riot, an unlawful assembly, 10 a concerted breach of the peace, or organized intimidation by threats of violence, will take place in any area within the Colony or within the province of such Provincial Commissioner, as the case may be, the Commissioner or such Provincial Commissioner may by an Order (in this 15 section referred to as a Curfew Order) direct that no person or no such class or description of persons as may be specified in the Curfew Order, shall be out of doors within such area during the hours of darkness, except under the authority of a written permit granted by a police 20 officer or other officer specified in the Curfew Order
- (2) A Curfew Order shall be promulgated in such manner as shall, in the opinion of the Commissioner, or the Provincial Commissioner, as the case may be, be best fitted to bring it to the notice of the persons con-25 cerned and shall remain in force until varied or rescinded by an Order made by the authority which imposed it or by the Governor in Council as hereinafter mentioned
- (3) Every Curfew Order made by the Commissioner or a Provincial Commissioner shall, as soon as con-30 veniently may be, be placed before the Governor in Council, and the Governor in Council may, if he thinks fit, vary or rescind the Order
- (4) The variation or rescission of a Curfew Order shall be without prejudice to anything done under it 35 prior to such variation or rescission or to any proceeding in respect of any contravention of such order commenced prior to such variation or rescission
- (5) Any person who shall fail to comply with the provisions of a Curfew Order may be arrested without 40 warrant and shall be liable to a fine not exceeding one hundred shillings or to imprisonment which may extend to one month or to both such fine and imprisonment
- (6) In this section the expression "hours of darkness" means the period between six-thirty p m and six-thirty 45 a m, or such less period between those hours as may be specified in the Curfew Order

3. (1) Part VII of the principal Ordinance shall be re-Renumbering numbered as Part VIII

(2) Section 64 of the principal Ordinance shall be re-Ordinance numbered as section 65

MEMORANDUM OF OBJECTS AND REASONS

Experience has shown that it is desirable that there should be power, exercisable on occasion by order to impose a curfew in any area in the Colony where it appears to the Commissioner of Police, or the Provincial Commissioner concerned, that there is a reasonable apprehension that a riot, unlawful assembly, conceited breach of the peace or organized intimidation by threats of violence will take place This Bill will amend the Police Ordinance, 1948, so as to confer the necessary powers on the Commissioner of Police and Provincial Commissioners A curfew order may be made to apply to all persons within an area or to such class or description of persons within the area as may be specified in the order

A curfew order may only be made to have effect during the "hours of darkness", which expression is defined as the period between 630 pm and 630 am or such lesser period between those hours as the order may specify

Every curfew order must be promulgated and must be placed, as soon as conveniently may be, before the Governor in Council, who may vary or rescind such order

Penalties are provided for breaches of curfew orders

The Ordinance, if enacted, should give assistance to the forces of law and order, and added protection to law-abiding citizens against hooliganism or organized intimidation at night

No additional expenditure of public moneys will be incurred if the provisions of this Bill become law

MEMORANDUM OF OBJECTS AND REASONS

Section 18 of the Control of Hotels Ordinance provided for the Ordinance to continue in force until the 30th day of June, 1949 By a proviso to that section the Governor, with the approval of the Legislative Council, was empowered to declare by notice in the Gazetti, that the Ordinance should remain in force until a date to be fixed in the notice or until repealed. This power was exercised and the Ordinance was kept in force until the 30th June last. On the 10th May, 1950, Legislative Council approved of the Ordinance being kept in force until the 30th June, 1951 By an oversight, however, the notice required by the proviso to section 18 was not published. An Ordinance is, therefore, now necessary to give effect to the recommendation of Legislative Council that the Ordinance should remain in force till the 30th June, 1951

- (a) to advise, whether after consultation or otherwise, the Governor in Council, the Governor and any other person to whom powers and duties conferred by the Ordinance have been delegated by the Governor, as to the exercise of such powers and the performance of such duties,
- (b) as often as may be necessary—
 - (1) to consult licensees for the purpose of ascertaining details as to their future policy and programmes,
 - (11) to obtain, whether from licensees or other persons, statistics, forecasts and other information used for estimating future demands for electrical energy and to examine the methods used in obtaining or applying such statistics, forecasts, and other information,
 - (iii) to endeavour to secure agreement as to how future demands for electrical energy shall be met, and to inform the Governor in Council if such agreement is not reached or if it appears that no such agree ment will be reached,
- (c) to consider the practicability of extending the supply of electrical energy to any area and to advise the Governor in Council whether applications for a licence for the purpose should be invited and if so, the terms upon which any such licence should be granted,
- (d) to consult with licensees, local authorities, Government department, and other persons as to, and advise upon-
 - (1) the suitability of any type of installation, regard being had to the availability of any particular type of fuel, and to the relative cost of installing and working and maintaining the same,
 - (11) the desirability and practicability of importing bulk supplies of electrical energy from territories adjacent to the Colony,
 - (m) the safety of transmission lines and other equipment and apparatus and to advise the Governor in Council as to any special action necessary in relation thereto,
 - (iv) to advise the Governor in Council as to the making or amendment of regulations dealing with the safety of transmission lines and other equipment and apparatus,
 - (v) the suitability and fairness of the terms of standard contracts made by licensees with consumers and the adequacy of the powers of the Governor in Council or of the Governor, as the case may be, to ensure that the terms of such contracts are fair to consumers and give reasonable safeguards to licensees,
 - (vi) the desirability for any amendment of the Ordinance or regulations governing the supply of electrical energy,
- (e) generally to carry out investigations and to make recommendations to the Governor in Council, the Governor or to licensees affecting the general policy relating to the maintenance or development of the supply of electrical
