**A BILL ENTITLED
AN ORDINANCE TO AMEND THE EXCHANGE
CONTROL ORDINANCE, 1950**

ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

Short title.

No. 40 of 1950.

Minor amendments to the principal Ordinance.

1. This Ordinance may be cited as the Exchange Control (Amendment) Ordinance, 1952, and shall be read and construed as one with the Exchange Control Ordinance, 1950, hereinafter referred to as the principal Ordinance.

2. The provisions of the principal Ordinance set out in the first column of the Schedule to this Ordinance shall have effect subject to the minor amendments set out in relation thereto in the second column of the said Schedule.

Section 1 ..	By inserting after the words "currency other than sterling" in paragraph (a) of sub-section (4) the words "or East African shillings".
Section 2 ..	By substituting for the words "in accordance with sub-section (2)" in sub-section (3) the words "in accordance with sub-section (3)".
Section 4 ..	(a) By inserting after the words "in terms of sterling" where they occur in sub-sections (3) and (4) the words "or East African shillings". (b) By substituting for the words "in accordance with sub-section (2)" in sub-section (5) the words "in accordance with sub-section (3)".
Section 22 ..	By substituting for the words "other than sterling" in sub-paragraph (iii) of paragraph (d) of sub-section (1) the words "other than that of a scheduled territory and payable otherwise than within the scheduled territories".
Section 24 ..	By inserting after the words "payment in sterling" wherever they occur in sub-sections (1) and (2) the words "or East African shillings".
Section 27 ..	By inserting after the words "or payment in sterling" in sub-section (1) the words "or East African shillings".
Section 45 ..	By omitting the words "or otherwise to the prejudice of the efficient prosecution of any war in which His Majesty's Government in the United Kingdom may be engaged," which occur in sub-section (1).
Section 46 ..	(a) By inserting after the words "in sterling" wherever they occur in sub-section (4) the words "or East African shillings". (b) By omitting the words "are not in the Colony and" in sub-section (5).
Fifth Schedule	(a) By substituting for the words "to furnish to them" in sub-paragraph (1) of paragraph 1 of Part I the words "to furnish to the Member". (b) By omitting the word "summary" in the context "on summary conviction" in sub-paragraph (3) of paragraph 1 of Part II. (c) By substituting for the words "on indictment" in sub-paragraph (4) of paragraph 1 of Part II the words "by the Supreme Court". (d) By adding the following new sub-paragraph— (5) Where a body corporate is convicted by the Supreme Court of an offence punishable under this Part of this Schedule the Supreme Court may impose a fine of such amount as it thinks fit.

MEMORANDUM OF OBJECTS AND REASONS

This Bill will make a number of minor amendments to the Exchange Control Ordinance, 1950, which have been revealed to be necessary. The only amendment to which special attention need be invited is that whereby a new sub-paragraph is added to paragraph 1 of Part II of the Fifth Schedule. The intention in excepting out of the maximum penalties imposed under sub-paragraph (4) a body corporate was to enable a court to impose on a body corporate a fine unlimited in amount. The new sub-paragraph is added in order to make this perfectly plain.

It is not expected that any additional expenditure of public money will be incurred if the provisions of this Bill become law.
