**A BILL ENTITLED
AN ORDINANCE TO PROVIDE FOR THE RATES OF
INCOME TAX AND OF PERSONAL ALLOWANCES
AND FOR OTHER MATTERS RELATING THERE-
TO AND CONNECTED THEREWITH**

ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows —

1. This Ordinance may be cited as the Income Tax (Rates and Allowances) Ordinance, 1952, and shall, subject to the provisions of this Ordinance, be deemed to have come into operation on the 1st day of January, 1951

Short title and commencement

5 2. (1) This Ordinance shall be read and construed as one with the East African Income Tax (Management) Act, 1952 (hereinafter referred to as the principal Act) as if, for the purposes of the application of the principal Act and of this Ordinance to the Colony, the principal Act and this Ordinance 10 were one enactment, and the provisions of this Ordinance supplementary to the provisions of the principal Act

(2) The provisions of the First, Second and Third Schedules to this Ordinance shall apply to assessments for the year of income commencing on the 1st day of January, 1951, 15 and each subsequent year of income

3. Subject to the provisions of this Ordinance and of the principal Act—

20 (a) the personal allowances to which an individual shall be entitled under Part VI of the principal Act shall be at the rates set forth in the First Schedule hereto,

(b) the tax to be charged under Head A of Part VII of the principal Act shall be charged at the rates set forth in the Second Schedule hereto,

25 (c) the tax to be deducted under Head B of Part VII of the principal Act upon payment of debenture interest or mortgage interest shall be at the rates set forth in the Third Schedule hereto

4. No stamp duty shall be charged in respect of any declarations made under the provisions of section 4 of the 30 principal Act

5. The Income Tax Ordinance is hereby repealed

Provided that, notwithstanding such repeal, the provisions of that Ordinance relating to the rates of tax and of personal allowances shall continue to apply to income tax chargeable, 35 leviable and collectable under those enactments in respect of the years of assessment (as defined in those enactments) up to and including the year of assessment commencing on the 1st day of January, 1951, as if those enactments had not been repealed, and the continuity of the law relating to income tax 40 shall not be affected by the substitution of the principal Act and this Ordinance for those enactments,

FIRST SCHEDULE

RATE OF PERSONAL ALLOWANCES

The amount of the married allowance shall be £350

The amount of—

- (a) the primary child allowance shall be £120,
- (b) the secondary child allowance shall be £60

Provided that no such personal allowance shall be granted in any year of income in respect of any child who was entitled in his own right in that year of income to an income exceeding £75, and in determining the income, if any, of any child for the purposes of this proviso, no account shall be taken of any sum to which the child is entitled as the holder of a scholarship, bursary, or other similar educational endowment

The amount of the education allowance shall be—

(a) where the tuition fees charged in respect of the child did not exceed £2 a year	7 10
(b) where the tuition fees charged in respect of the child exceeded £2 but did not exceed £4 a year	22 10
(c) where the tuition fees charged in respect of the child exceeded £4 but did not exceed £8 a year	45 00
(d) where the tuition fees charged in respect of the child exceeded £8 but did not exceed £12 a year	60 00
(e) where the tuition fees charged in respect of the child exceeded £12 a year	75 00

Provided that—

- (i) no education allowance shall be granted unless—

- (a) the child was receiving education in such manner as may be approved by the Commissioner in consultation with the Director of Education, and

- (b) the individual claiming such allowance was charged tuition fees or tuition and boarding fees, in respect of the education of such child,

- (ii) in the case of a child under the age of 12 years during the whole of the year of income, the amount of the education allowance shall not exceed £45 or the tuition fees, whichever is the greater,

- (iii) where the person entitled to claim the education allowance pays boarding fees in addition to tuition fees, the amount of the education allowance shall be increased by one-third of the amount of such boarding fees, so, however, that in no case shall the amount of the education allowance exceed £75,

- (iv) where the boarding fees and tuition fees have not been charged separately to the individual claiming the education allowance, the Commissioner shall determine what portion of the amount charged shall be deemed to be in respect of boarding fees and what portion in respect of tuition fees,

- (v) for the purposes of determining the education allowance—

- (a) "boarding fees" includes the cost of boarding and lodging a child where such cost is paid by the individual claiming the allowance to another person in respect of a child who is, for the purpose of attending an educational establishment, necessarily living away from his normal place of residence,

- (b) "tuition fees" includes any expenditure directly incurred by the individual claiming the allowance upon the education of a child

The amount of the dependant allowance shall be £60

Provided that—

- (i) no dependant allowance shall be granted in any year of income in respect of any person who was entitled in his own right in that year of income to an income exceeding £150,

- (ii) where the dependant allowance is more than the amount expended on the maintenance of the person in respect of whom it is claimed, then only the amount so expended may be granted,

- (iii) where any person in respect of whom the dependant allowance is claimed is jointly maintained by the individual claiming such allowance and by any other person, whether or not such other person is liable to tax under the principal Act or is resident in the Colony, then the amount which may be granted shall be such an amount as bears the same proportion to the dependant allowance as the amount expended by

- 30 the individual claiming such allowance bears to the total amount expended for the maintenance of such person
- 30 The amount of the insurance allowance shall be the amounts of the premiums for insurance and the contributions to the approved pension scheme
- Provided that no insurance allowance—
- (i) shall be granted in respect of any amount in excess of one-sixth of the total income for that year of the individual claiming such allowance,
 - (ii) shall be granted in respect of any premium for an insurance other than an insurance for securing a capital sum on death, whether or not in conjunction with any other benefit,
 - (iii) shall be granted in respect of the excess of any premium for an insurance above an amount equal to 7 per cent of the actual capital sum assured, and in calculating any such capital sum no account shall be taken of any sum payable on the happening of any other contingency, or of the value of any premiums agreed to be returned, or of any benefit by way of bonus or otherwise which is to be or may be received either before or after death either by the individual paying the premium or by any other person, and which is not the sum actually assured,
 - (iv) shall reduce the amount of tax payable by the individual claiming such allowance—
- (a) where the amount of such premiums and contributions otherwise allowable does not exceed £200, by more than 25 per cent of such premiums and contributions,
 - (b) where the amount of such premiums and contributions otherwise allowable exceeds £200, by more than £50 in respect of the first £200 thereof and $12\frac{1}{2}$ per cent of the excess thereof over £200
- 31 The amount of the single allowance shall be £200
- Provided that where the total income of the individual claiming such allowance, other than an individual to whom section 27 of the principal Act applies, exceeds £200, the amount of such single allowance shall be reduced by one-quarter of the amount by which such total income exceeds £200
- 32 The amount of the age allowance shall be the least of the following three amounts—
- (a) the amount of the individual's earned income included in his total income for the year of income, or
 - (b) the amount by which the sum of any personal allowances granted to the individual under sections 26, 27, 29 and 31 of the principal Act or £200, whichever is the greater, exceeds the amount of his income, other than earned income, included in his total income for such year, or
 - (c) the amount of £200 less one-half of the excess of his total income for such year over the sum of any personal allowances granted to the individual under sections 26, 27, 29 and 31 of the principal Act and £800
- 33 The amount of—
- (a) the married old age allowance shall be £175
- Provided that where the total income of the individual claiming such allowance exceeds £350, the amount of such married old age allowance shall be reduced by one-half of the amount by which such total income exceeds £350,
- (b) the single old age allowance shall be £100
- Provided that where the total income of the individual claiming such allowance exceeds £200, the amount of such single old age allowance shall be reduced by one-half of the amount by which such total income exceeds £200
- 34 (2) The amount of the non-resident primary allowance shall be—
- (i) in the case of an individual who, if he were resident in the Territories, would be entitled to claim the single allowance, £160, or
 - (ii) in the case of an individual who, if he were a resident in the Territories, would be entitled to claim the married allowance, £245,
- together with, in either of such cases—
- (a) £60 in respect of each child for whom he would be entitled to claim any personal allowance under section 27 of the principal Act if he were resident in the Territories, and

(b) one-fifth of the amount of any earned income, whether or not accrued in, derived from, or received in, the Territories

Provided that the amount of the non-resident primary allowance shall be reduced by double the amount by which the total income from all sources, whether or not accrued in, derived from, or received in, the Territories, of the individual claiming such allowance exceeds the amount of such allowance prior to such reduction

34 (3)

The amount of the non-resident secondary allowance shall be—

(i) in the case of an individual who, if he were resident in the Territories, would be entitled to claim the single allowance, £100,

(ii) in the case of an individual who, if he were resident in the Territories, would be entitled to claim the married allowance, £155,

together with, in either of such cases—

(a) £40 in respect of each child for whom he would be entitled to claim any personal allowance under section 27 of the principal Act if he were resident in the Territories, and

(b) one-quarter of the amount of any income, other than earned income, whether or not accrued in, derived from, or received in, the Territories

Provided that—

(A) the amount of the non-resident secondary allowance shall be reduced by double the amount by which the total income from all sources, whether or not accrued in, derived from, or received in, the Territories, of the individual claiming such allowance exceeds the amount of such allowance prior to such reduction,

(B) where such total income of any individual includes any earned income not accrued in, derived from, or received in, the Territories, the amount of such earned income shall, for the purpose of computing the amount of the non-resident secondary allowance, be reduced by one-half or by the amount by which the earned income chargeable to tax is less than £250, whichever is the less

MEMORANDUM OF OBJECTS AND REASONS

By virtue of section 27 (1) (a) of, and item 5 of the Third Schedule to, the East Africa (High Commission) Order in Council, 1947, the East Africa Central Legislative Assembly has power to legislate for the East African Territories in regard to "Income Tax—administrative and general provisions (but not including the rates of tax and allowances)" Accordingly, the Central Legislative Assembly on the 25th April, 1952, passed the East African Income Tax (Management) Bill, 1952 This Bill, when in due course it comes into operation as the East African Income Tax (Management) Act, 1952, will repeal the existing law relating to income tax, except those provisions thereof which relate to the rates of tax and allowances, the latter being within the legislative jurisdiction of the Territorial Legislatures The Act will also contain the administrative and general provisions relating to income tax which will thereafter apply in place of the Territorial laws which it will repeal The Act, however, requires to be supplemented by Territorial Ordinances providing for the rates of tax and allowances This Bill is accordingly designed to make provision for the rates of tax and allowances to be applied in Kenya The Act and the Ordinance resulting from this Bill, and subsidiary legislation thereunder, will together constitute the Income Tax law of the Colony

The Bill will apply to assessments for the year of income commencing on the 1st day of January, 1951, and each subsequent year of income (*Clause 2*), but assessments in respect of previous years of income will continue to be governed by the existing law (*Clause 5*)

Clause 3 of the Bill prescribes the allowances and rates of tax, which are, for convenience, set out in the three Schedules to the Bill The First Schedule contains the personal allowances, the Second Schedule contains the rates of tax, and the Third Schedule contains the rates at which tax on debenture interest and mortgage interest will be deductible These rates of tax and allowances are the same as are at present in force in Kenya, with the exception of the education allowance laid down in the First Schedule, the rates of which are quoted in the Schedule at one hundred and fifty per centum of the prevailing figures This fifty per cent increase was contemplated when the maximum education allowance was raised by the Income Tax (Amendment) (No 3) Ordinance, 1951, from fifty pounds to seventy-five pounds, but the consequential increase in the graduated scale of education allowances, which have hitherto been contained in Rules made under the Ordinance, has not yet been made and will now accordingly be effected by this Bill

Clause 4 re-enacts in substance the exemption from Stamp Duty granted by section 4 (1) of the present Ordinance in respect of declarations of secrecy made by persons concerned in the administration of Income Tax

By virtue of *Clause 5* such provisions of the present Ordinance as are unaffected by the repealing provisions of the Act are repealed, thus completing the total repeal of the present Ordinance

No expenditure of public moneys will be incurred if this Bill becomes law, and the loss of revenue represented by the increase in education allowances mentioned above has in fact already received the sanction of the Legislative Council when the Income Tax (Amendment) (No 3) Ordinance, 1951, was passed in December, 1951
