## MEMORANDUM OF OBJECTS AND REASONS

The Penal Code (Amendment) Ordinance, 1952, recently passed by the Legislative Council and now in force, increased certain maximum monetary penalties prescribed by the Penal Code. The main purpose of this Bill is to increase certain maximum terms of imprisonment prescribed by the same Code. The need for revision of these maximum terms of imprisonment has been emphasized by a number of recent cases and by prevailing conditions in the Colony. The majority of the increases are shown in the Schedule to the Bill but in the following instances, the necessary amendments are effected by separate clauses of the Bill—

*Clause 4* which, in effect, increases the maximum penalty for offences under section 112 (conspiracy to defeat justice, and interference with witnesses) from two years to five years' imprisonment

*Clause 5* which increases the maximum penalty for offences under section 124 (false information to a public servant) from six months' imprisonment and a fine to three years' imprisonment

*Clause 8* which increases the maximum penalty for offences under section 333 (cattle-maiming and the like) from two years' imprisonment to fourteen years' imprisonment in the case of farm and other domestic animals and to three years' imprisonment in the case of other animals

In most instances, the proposed increases bring the maximum terms of imprisonment into line with the penalties for comparable offences under United Kingdom law

*Clauses 6 and 7* include in the offences described by sections 329 and 330 (setting fire, and attempting to set fire, to crops and growing plants) the destruction of, and serious or permanent injury to, such crops and plants and attempts thereat. The maximum penalty is fourteen years' imprisonment for the main offence and seven years' imprisonment for the attempt

The opportunity has been taken to include in the Bill two other amendments

Section 26 (2) of the Penal Code provides that no person under eighteen years of age shall be sentenced to death. This provision has been judicially construed as meaning that no person shall be sentenced to death if under the age of eighteen at the date when sentence is passed. It is considered, however, that the critical date in this respect should be the date of commission of the offence, as is the position in the United Kingdom, and *clause 2* of this Bill is designed to amend section 26 (2) of the Code accordingly

The amendment effected by *clause 3* is designed to include commissioned officers of Her Majesty's Forces serving in the Colony among those authorized to make a proclamation commanding rioters to disperse. At present, only magistrates, certain police officers and commissioned officers in the military forces of the Colony can perform this function

No additional expenditure of public moneys will be incurred if the provisions of this Bill become law

## GRASS FIRES (CONTROL) ORDINANCE

(Cap 185)

## NAKURU DISTRICT COUNCIL

## ORDER

IN EXERCISE of powers conferred by section 11 of the Grass Fires (Control) Ordinance, the Nakuru District Council hereby declares a state of danger in respect of the Nakuru District Council area

The burning of vegetation within the said Nakuru District Council area is hereby prohibited, except as hereunder stated, for a period of three months from 15th November, 1952, and anyone who burns vegetation contrary to the provisions of this order shall be guilty of an offence

Conditions—No burning whatsoever of vegetation is permitted without a permit signed by a Ward Member or Chairman of the appropriate Production Sub-committee or other such persons to whom authority is delegated by the Nakuru District Council

An additional permit is required from the Chairman of the appropriate Production Sub committee for the burning of crop residue

The normal hours of burning under permit shall be between the hours of 5 a.m. to 8 a.m. and 5 p.m. and 8 p.m. daily except Saturdays and Sundays. In special circumstances permits may be issued to burn outside the times specified above. Copies of all permits issued must be sent to the local Police Officer. No burning whatsoever is permitted on Saturdays or Sundays

A special permit is required for charcoal burning

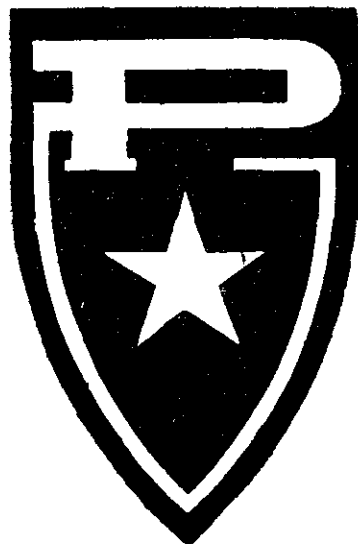

3 Applications should be submitted to the Special Commissioner and Acting Commissioner of Lands, Nairobi, through the District Commissioner, Kericho, stating the plot required in order of preference

4 Applications must be sent so as to reach the District Commissioner, Kericho, not later than noon on the 29th day of November 1952

5 Applications must not be sent direct to the Commissioner of Lands

6 Applicants must enclose with their applications their cheque for Sh 1,000 as a deposit, which will be dealt with as follows —

- (a) If the applicant is offered and takes up and pays for a plot within a period of seven days as required by Condition (a) (1) below the deposit will be credited to him,
- (b) If the application is unsuccessful, the applicant's deposit will be returned to him,

*(f) Additional Special Conditions in Respect of the Business-cum-Residential Plots in Schedule No 4*

1 The grantee shall use and permit to be used the land hereby granted for business purposes only, excepting dangerous and offensive trades but shall be at liberty to use the said land for the combined purpose of business and residence notwithstanding, provided that in the event of the said land being used for the said combined purpose, then not more than one-half of the area thereof shall be built upon otherwise not more than 90 per cent shall be built upon.

*(g) Additional Special Conditions in Respect of the Garage or Workshop Plots in Schedule No 5*

1 The plot shall be used for the purposes of a garage or workshop only. No residence will be permitted.

2 The grantee shall not at any time during the term of the grant erect any buildings to cover more than 90 per cent of the area of the plot.

*(h) Additional Special Conditions in Respect of the Light Industrial Plots in Schedule No 6*

4 The grantee shall not at any time during the term of the grant erect any buildings so as to cover more than 90 per cent of the area.

5 At no time during the term of the grant shall the plot or any portion thereof or any building erected on the plot be used for the purpose of carrying on any trade or business which has been or may be declared to be dangerous or offensive by notice in the Official Gazette.

6 A veranda may be erected within the road reserve with the previous consent of the Local Authority and must conform to a building line decided upon by such authority.
