**A BILL ENTITLED
AN ORDINANCE TO AMEND THE LIQUOR
ORDINANCE**

ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

Short title.

1. This Ordinance may be cited as the Liquor (Amendment) Ordinance, 1953, and shall be read and construed as one with the Liquor Ordinance, hereinafter referred to as the principal Ordinance.

Cap. 266.

Amendment of section 10 of the principal Ordinance.

2. Paragraph (a) of sub-section (13) of section 10 of the principal Ordinance is amended by inserting therein immediately after the words "the Kenya Police Force" appearing therein the words "the Kenya Police Reserve".

MEMORANDUM OF OBJECTS AND REASONS

The Liquor Ordinance was enacted before the Kenya Police Reserve was constituted and therefore the Kenya Police Reserve is not included in the list of services and organizations for the canteens and messes of which a Canteen Liquor Licence may be issued under section 10 (13) (a). The purpose of this Bill is to include the Kenya Police Reserve in that list.

No expenditure of public moneys will be involved if this Bill is passed into law.

6. In the consideration of tenders regard will be paid to the relative merits of the proposals and the financial sufficiency of the tenderer to undertake them.
