A BILL ENTITLED

AN ORDINANCE TO AMEND THE WILD ANIMALS **PROTECTION ORDINANCE, 1951**

ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows: —

This Ordinance may be cited as the Wild Animals Short title. 1. Protection (Amendment) Ordinance, 1953, and shall be read and construed as one with the Wild Animals Protection Ordinance, 1951, hereinafter referred to as the principal No. 18 of 1951. 5 Ordinance.

2. Paragraph (b) of sub-section (5) of section 7 of the Amendment of section 7 of principal Ordinance is amended by inserting next after the the principal words "in contravention of" the commas and words ", or Ordinance. fails to comply with.".

3. Section 13 of the principal Ordinance is amended by 10 🗎 substituting for sub-sections (1) and (2) thereof the following sub-section-

(1) Subject to the provisions of this section and of section 4 of this Ordinance, and to any directions issued by the Member under section 56 of this Ordinance, a 15 licensing officer may, in respect of any of the animals specified in the first column of the Fourth Schedule to this Ordinance, in his discretion grant to the holder of a full licence, on payment of the appropriate fee specified in the third column of the said Schedule, a 20 special licence:

Provided that—

(i) during the period of validity of any one full licence no special licence shall be granted in respect of more animals than the number respectively specified in the second column of the said Schedule in relation to each type of

MEMORANDUM OF OBJECTS AND REASONS

Since the coming into force of the Wild Animals Protection Ordinance, 1951, which makes provision for the preservation and control of wild animals in the Colony, a number of weaknesses have become apparent which this Bill seeks to remove.

Section 7 (3) of the Ordinance empowers a Game Warden, when issuing a permit to hunt in a controlled area, to attach conditions to the permit if he thinks fit, but the section does not make it an offence to fail to comply with such conditions. This is remedied by *clause* 2 of the Bill.

Clauses 3 and 7

The Member for Agriculture and Natural Resources is empowered, by section 57 (1) (a) of the Ordinance, to amend the 2nd, 3rd, 4th and 5th Schedules and may therefore add the name of any animal to Part I of the 4th Schedule (which specifies those animals which may be killed on Special Licence only) and insert in Part II thereof the fee payable for the Special Licence required to shoot it.

However, section 13 (2) of the Ordinance contains a list of the maximum number of special licences which may be granted to one person during the validity of a full licence; as this is part of the Ordinance proper any alteration to this list which may be necessary from time to time can only be effected by amendment to the Ordinance. *Clause* 3 of the Bill transfers the list to the 4th Schedule, so as to give the Member power to amend the list of animals to be shot on Special Licence only. The existing parts of the Schedule, together with the additional data now transferred, have been redrafted to group them together in tabular form, in order that the Schedule may be more readily understood. (*Clause* 7.)

Clause 4

The wording of paragraph (b) of the proviso to section 23, owing to the omission of a comma, gives a meaning directly opposite to that intended. This clause rewords the proviso in unambiguous terms,

Clause 5

The wording of the preamble to sub-section (2) of section 32 of the Ordinance has the effect of prohibiting the possession of game or trophies in respect of which an offence has at some time been committed. This wording goes too far since it renders unlawful the possession of game or trophies properly sold in accordance with section 33 (for example, confiscated trophies later sold by Government). Clause 5 removes the restriction by rewording the preamble to section 32 (2) and by deleting paragraph (d).

Clause 5 also adds a new sub-section to section 32 of the Ordinance, placing on a person charged with illegal possession of a game animal, trophy or game meat the onus of proving that it was lawfully obtained. This provision is considered essential if the trade in game trophies, especially ivory and rhinoceros horn, is to be adequately controlled, and its omission involves loss of revenue by depriving Government of a large number of valuable trophies properly belonging to the Crown. The principle of shifting the onus of proof in such cases is recognized in the legislation of other territories.

Clause 6 adds a new section 41A to the Ordinance empowering officers of the Game Department to erect road barriers for inspection purposes in order more effectively to administer the Ordinance,


