





Note 3.—S toten Road

In order to provide a road of access for use by the Board's tenants in the Sitoten area, $\pounds 6,000$ of the Board's funds were utilized. Cf this sum $\pounds 3,960$ was refunded by the Road Authority, the remainder being treated as the Board's contribution to the cost of the road. Steps are being taken to recover the balance, not only from the Board's tenants, but also from other users of the road.

Note 4.—1 oans to Farmers

As at date, 165 loans made to tenant farmers and assisted owners are outstanding. The majority of these loans are repayable over a period of from 30 to 45 years. The average loan per farmer is $\pounds 1,873$.

Note 5.— ivestock on Loan to Tenants

The Bo; rd's policy is that every tenant under the Settlement Scheme should engage in mixed farming. To assist certain tenants, a cattle stocking scheme was initiated in 1950 as follows. Cattle are loaned under an agreement, for a period not exceeding five years, interest at $4\frac{1}{2}$ per cent per annum being payable on the capita cost. At the end of the period, the tenant has the option to purchase the cattle at the original cost, or to return to the Bo; rd cattle to the value of the loan. As at date of these accounts, 14 tenants have been assisted under this scheme.

Note 6.—Livestock for Breeding at Konza

The Beard have inaugurated a three-year scheme for the breeding, by insemination, of higher grade heifers from their existing breed of half-breds, and for purchasing new stocks of Boran heifers for insemination to pure-bred bulls. Sales of threequar er-bred progeny to tenant farmers should be recommenced in 1954.

Note 7.- Survey Charges

The B_c ard endeavours to obtain survey of its farms as and when it is possible to do so. If a private surveyor is employed, only 75 per cent of his charges are paid till the Director of Surveys I as checked and approved the work. The amount shown is held ir suspense till then, after which allocation to the farms concerned is made. All costs of survey are recoverable eventually when the farms are sold.

Note 8.--Sundry Debtors

The Eoard has sold various farms to settlers outside its Tenant I arming Scheme. In some cases, the purchasers are permitted to retain 10 per cent of the purchase price pending survey and the issue of the grant of title. In all cases, the unpaid balances bear interest.

The irstalments of rent and/or interest on loans payable by tenants and assisted owners fall due on 30th September and 31st Ma ch in each year. A very large proportion of the total, therefore, became due on the day of account, and of the £32,611 shown, only £2,726 is overdue.

Note 9. –Sundry Creditors

In cases when the Board purchase farms for settlement, and the precise acreages of such farms are unknown, a proportion of the lost is withheld pending survey. The amount involved concerns 15 farms.

Note 10,---Prepayments

Certain tenant farmers have deposited sums to the credit of their accounts to provide for the payment of rent, etc., to fall due in the future.

Note 11.—Reserve for Administrative Expenditure

As the contribution by Government towards the Board's adminis rative expenditure covers the whole of the year 1953, an amount considered adequate for the remaining nine months has been reserved.

ACCOUNTS FOR THE YEAR ENDED 31ST MARCH, 1953

THE accounts of the Board's activities presented herewith are prepared in accordance with the regulations made by the Hon. the Member for Agriculture and Natural Resources under the provisions of the European Agricultural Settlement Ordinance, 1948, and subsequent amendments thereto.

The following notes are in amplification of the accounts and should be referred to as indicated thereon:—

Note 1.—Farms Leased to Tenants

Two hundred and three farms are leased to tenant farmers as at date. The amount shown consists of the lease valuations, plus the permanent improvements at cost erected thereon by the Board, on the totals of which the rent of the farms is calculated. Average investment per farm: £5,716.

Note 2.—Land Unoccupied

At date, 16 unoccupied farms are held by the Board and negotiations for their sale, or lease to tenants, are in progress. Of the 16, 13 are subdivisions of Mau Narok Estate recently purchased.

Note 1. .- Reserve for Waivure of Charges

In accordance with the terms of White Paper No. 1 of 1950, the Board approved periods of moratoria on rent and interest payments to certain tenants and assisted owners. Subject to certain safeguards which have been devised, payment of the sums a cruing as rent and interest during these periods can be waived, and during the year of account the sum of $\pounds 17,740$ was written off. Additional provision from surpluses has been made to meet the increased liability under this head.

Note 1:-Reserve for Bad and Doubtful Debts

During the year of account no bad debts were incurred. However, i_1 view of unsettled conditions generally it was decided to augment the sum reserved under this head.

Note 14.—Reserve for Repairs and Renewals

During the year of account an expenditure of £2,968 was incurred in repairing and/or renewing various farm buildings damag d or destroyed by fire or other causes for which no one could be held responsible. This figure also includes 25 per cent of the cost of one unsuccessful borehole, as the Government subsidy covered only 75 per cent of its cost.

Add tional provision from surpluses has been made to meet any lie bility under this head which may arise in future.



NOTICE OF SALE-PETROL STATION AND BUSINESS/RESIDENTIAL PLOTS-NAIROBI SOUTH

NOTICE is hereby given that the plots shown in the attached Schedules are available for alienation in the Nairobi South Estate, south of the Light Industrial Area in the neighbourhood of the Rifle Range. A description of the plots and the various uses for which they will be alienated are shown below.

2. Applications are invited for the direct grant of these plots. A plan of the plots may be seen at the Lands Department, Nairobi, or may be obtained by post on demand of Sh. 3, postage free, from the Survey Department, P.O. Box 1766. Nairobi.

3. Applications should be submitted to the Special Commissioner of Lands, P.O. Box 89, Nairobi, on or before noon on the 30th day of June, 1953, and envelopes should be clearly marked either "Application for Business-cum-Residential Plots, Nairobi South" or "Application for Petrol Station Site, Nairobi South".

4. Personal interviews will not be granted.

Conditions of Sale

1. In the case of the plots in Schedule A, the following types of businesses are considered to be essential, but applicants are at liberty to apply in respect of other businesses :—

Chemist, Dry Cleaner, Furniture Shop, Bakery, Electrical Fittings, and Hardware, Dairy, Stationery and Bookshop, Grocers, Greengrocers, Butcher, Draper, Confectioner, Tailor and Shoemaker.

2. Applicants may, if they wish, submit plans for the erection of up to three shops on each plot. It is intended to secure a continuous shopping frontage by this concession which should not be taken to imply that later proposals for the submission of plots would be considered. Applications to sub-let the shops would be sympathetically considered, but preference will be given to applicants proposing to use the plots for themselves. The type of business proposed in cases where sub-letting is requested would be carefully considered in the light of Condition No. 1 above.

3. Residence on each plot will be restricted to one flat for one family only, and having a maximum floor area equal to not more than 50 per cent of the area of the site. Separate access to the flat must be provided from the footway on the shop frontage.

4. Applicants must submit full written details of the type of development proposed. The minimum amount of capital available for and to be expended on the construction must be stated and must be supported by a Banker's reference. In the consideration of applications regard will be had to the relative merits of the proposed plans for construction and the financial sufficiency of the applicant to undertake such construction.

5. Whilst the wishes of applicants with regard to the location or size of plots will be taken into consideration, offers will be necessarily made in accordance with whatever plots may be available.

6. In the case of the plots for Petrol Service Stations in Schedule B, each tender should be accompanied by a statement containing a detailed description of the proposals of the tenderer for the development of the site. Proposals must be in accordance with the City By-laws and should be for a Petrol Service Station on modern lines with adequate provision on the site for standing vehicles for their re-fuelling off the road. In the case of Plot No. 209/3804, no access will be permitted to the Service Station from the through road on the north-eastern boundary of this plot. 3. The grant will be issued in the name of the allottee in accordance with the information supplied in the application which should contain full necessary details.

4. Fees for survey, as set out in the Schedule, will be payable on demand, together with fees in respect of the preparation and registration of the grant (Sh. 120) and the stamp duty payable in respect of the grant (approximately 2 per cent of the amount of stand premium and rent) and all other expenses, if any.

5. No building shall be erected on any plot unless plans (including block plans showing the position of the building), drawings, elevations and specifications thereof have been previously approved by the Local Authority and by the Commissioner of Lands, or such other person as he may appoint. 8. The grantee shall not at any time subdivide the plot.

9. The grantee shall not sell or transfer the plot nor enter into any mortgage charge (other than with the consent of the Commissioner of Lands for the raising of a loan for building purposes) or agreement of sale in respect thereof within ten years of the date of commencement of the grant.

10. Subject to the preceding condition, the grantee shall not at any time during the tenancy assign, mortgage, sub-let or part with the possession of the plot or any buildings thereon save with the prior approval of the Commissioner of Lands first having been obtained in writing.

11. (b) Any former applications by the applicant.

(c) The present circumstances of the applicant's business.

(d) The amount of capital available for immediate development of the plot.

(e) A certificate from the Labour Officer confirming his satisfaction with the proposed arrangements for the accommodation of African labour.

Applicants should, therefore, refer to all these matters and their applications should be accompanied by a banker's reference, indicating that the proposed capital expenditure is likely to be available. Applicants should also refer to any previous correspondence with the Commissioner in connexion with such plots. In cases where the applicant is carrying on light industrial business elsewhere, indication should also be given to the present locality of any enterprise which it is proposed to transfer to the new Light Industrial Area. This description of the present location should be sufficient to enable the present locality of the enterprise to be identified and, if necessary, inspected.

5. Applications must be deposited with the Special Commissioner and Acting Commissioner not later than noon on 30th June, 1953.

6. Every successful applicant (herein after referred to as the grantee) shall pay to the Commissioner of Lands within 14 days of notification that his application has been approved, the survey fees, the stand premium, the estimated cost of roads and drains, proportion of rent for 1953 as set out in the Schedule and stamp duty, which is approximately 2 per cent of the purchase price and annual rent. In default of payment within the specified period the allocation may be cancelled and the grantee shall have no further claim to the plot.

7. The grantee shall be responsible for the estimated proportionate cost of sewers and will be required to pay the same within 14 days of demand therefor. Failure to comply with this requirement will entail forfeiture of all rights to the plot and any moneys that have been paid in respect of the plot will be forfeited to the Crown.

8. The grant will be issued only in the name of the person by whom the application is made.

1. 5.6. The grantee shall not sell or transfer the plot nor enter into any mortgage charge or agreement to sell in respect of the plot, unless the consent of the Commissioner of Lands in writing has been previously obtained.

7. The grantee shall not subdivide the plot.

8. The grantee shall pay such taxes, charges, duties, assessments or outgoings of whatever description as may be charged, assessed, levied or imposed by any Government or Local Authority upon the land or the buildings erected thereon, including any contribution or other sum paid by the Government in lieu thereof.
