THE EMERGENCY REGULATIONS, 1952

(G.N. No. 1103 of 1952)

REGULATION 8D (5) (b)

DIRECTIONS

IT IS notified for information that, in pursuance of the provisions of paragraph (b) of sub-regulation (5) of regulation 8D of the Emergency Regulations, 1952, I have issued the following directions:—

1. Firearms delivered up to the Police under regulation 8D of the Emergency Regulations, 1952, shall be stored at the Civil Arms Depot, Gilgil, or at such other depots as the Commissioner of Police may determine.

2. The owner of a firearm stored as aforesaid may—

(a) once a month have access to his firearm for the purpose of cleaning or inspecting it:

Provided that such owner, on each such occasion, gives to the officer in charge of the depot not less than 48 hours' previous notice of his desire so to have access to his firearm and produces to the said officer in charge the receipt issued to him by the Police in respect of the said firearm;

(b) withdraw his firearm at any time if—

(i) he is in possession of written authority in that behalf granted by the appropriate Committee empowered under sub-regulation (6) of the said regulation 8D to grant exemptions from the provisions of that regulation, such authority having been obtained through the officer in charge of the Police Station at which the firearm was delivered up to the Police; or

(ii) he is not, by such withdrawal, acquiring possession of more than one firearm in contravention of the said regulation 8D; and

(iii) he is in possession of a valid arms licence issued under the Arms and Ammunition Ordinance (Cap. 302) in respect of that firearm; and

(iv) he has given to the officer in charge of the depot not less than 48 hours' previous notice of his desire so to withdraw the firearm;

(c) at any time exchange the firearm so stored for another firearm in his lawful possession if—

(i) he is in possession of a valid arms licence issued under the Arms and Ammunition Ordinance in respect of the firearm to be withdrawn; and

(ii) he has given to the officer in charge of the depot not less than 48 hours' previous notice of his desire to effect such exchange.

3. The Civil Arms Depot, Gilgil, and such other depots as aforesaid, will be open for the purposes aforesaid—

(a) on Mondays to Fridays, from 9 a.m. to 12 noon and from 2 p.m. to 4 p.m.; and

(b) on Saturdays, from 9 a.m. to 12 noon, excluding public holidays.
