AWARD OF COLONIAL POLICE MEDAL

HIS EXCELLENCY the Governor is pleased to announce that information has been received from the Secretary of State that Her Majesty the Queen has been pleased to approve the immediate award of the Colonial Police Medal for gallantry to—

ASSISTANT INSPECTOR WILLIAM ROBERT McGRATH BLACKWELL for conspicuous gallantry in the execution of his duty.

On 23rd November, 1952, Inspector Blackwell, when stationed at Thika, was informed of most serious trouble developing from a large mob collected in a neighbouring Police Station area at Kiruara Market in the Fort Hall Reserve. He collected hurriedly a party of one European Learner Inspector and 34 African Police and set out for the scene. On arrival at the scene he was confronted by some 2,000 people who had been worked up to a degree of frenzy and were in a very dangerous state. He disposed his police to proper advantage and himself arrested the ringleader, who was urging the crowd to violence. His action, however, enraged the crowd still further, and although he used every endeavour to quieten them they eventually rushed him and his small force; when they were within some few feet of his party he was compelled to open fire in order to protect his force and to restore order. After the fire had been opened the crowd lay down, but almost immediately they rose and charged on his police for the second time; it was consequently necessary to open fire once more, with the result that further casualties were inflicted on the crowd, part of which dispersed and order among the remainder was restored.

By his courage and coolness Inspector Blackwell undoubtedly saved his police party from destruction and by his careful fire control he minimized the number of casualties inflicted on a frenzied mob.

AWARD OF COLONIAL POLICE MEDAL

HIS EXCELLENCY the Governor is pleased to announce that information has been received from the Secretary of State that Her Majesty the Queen has been pleased to approve the immediate award of the Colonial Police Medal for gallantry to—

SENIOR KENYA POLICE RESERVE OFFICER PHILLIP BEVERLY for conspicuous gallantry in the execution of his duty.

On 30th/31st May, 1953, at about 2300 hours, S.R.P.O. Beverly in command of Section 12, Njoro Sub-district, carried out a raid in the vicinity of a farm where an armed gang of some 20 *Mau Mau* were reported.

On arrival at the group of huts to be searched, S.R.P.O. Beverly completed his dispositions to prevent escape and then advanced on one of the huts with two K.P.R. Officers. He called on the inmates to come out, but there was no response and the door was locked. S.R.P.O. Beverly placed his escort to cover him and regardless of personal danger knocked the door in and entered calling on the inmates to surrender. While searching them he was attacked and fired on by at least two of their number. Though wounded in the face, lung and shoulder, S.R.P.O. Beverly returned the fire and maintained an offensive action which resulted in the death of six terrorists and the capture of four more. His displayed the highest courage under fire, and though badly wounded continued the fight and was largely responsible for the destruction of the gang.

AWARD OF COLONIAL POLICE MEDAL

HIS EXCELLENCY the Governor is pleased to announce that information has been received from the Secretary of State that Her Majesty the Queen has been pleased to approve the immediate award of the Colonial Police Medal for gallantry to—

No. 7632 CONSTABLE MOHAMED ALI for conspicuous gallantry in the execution of his duty.

During the evening of 8th May, 1953, a very determined large-scale attack was made by a strong terrorist gang on Othaya Police Station in the South Nyeri Reserve.

No. 7632 Constable Mohamed Ali, who was off-duty asleep at the time of the attack, was the first man to turn out when the alarm was sounded, and in spite of heavy enemy rifle and Bren fire, he reached and manned his defence post, returning the enemy fire with coolness and good effect, and holding off the attack until all the men on the station had reached their posts.

Throughout the whole attack, the conduct and bearing of this constable was excellent. He remained calm and conserved his fire to obtain the best effect, setting a fine example to his colleagues. By this determined defence he assisted in breaking the enemy attack and inflicting heavy casualties on them.

Constable Mohamed Ali, who had only eight months' service with the Force, showed the greatest courage and behaved in an exemplary manner on this occasion. The enemy suffered severe losses and were eventually repulsed.

AWARD OF COLONIAL POLICE MEDAL

HIS EXCELLENCY the Governor is pleased to announce that information has been received from the Secretary of State that Her Majesty the Queen has been pleased to approve the immediate award of the Colonial Police Medal for gallantry to—

No. 2299 CONSTABLE MOHAMED AHMED for conspicuous gallantry in the execution of his duty.

This Constable was a member of a patrol of the Security Forces during the attack by *Mau Mau* terrorists on the Gattagiki School near Kandaredu on 9th May, 1953. On this occasion a gang of approximately 200 terrorists attacked the school. They were armed with probably some 20 rifles. A combined force of Military and Police engaged the gang, but during the ensuing action it was necessary for the Security Forces to withdraw and abandon their vehicles.

Early in the action this Constable was painfully wounded as a result of an enemy bullet striking his rifle and smashing two of his fingers. Although he was in very great pain he continued to fire until all his ammunition had been expended and he was ordered to retire.

He retained his rifle until he received medical attention and at all times he showed great zeal to return to the attack.

Throughout the action his behaviour was an excellent example to the other members of the police party, and undoubtedly his conduct contributed considerably to the success of the action.

AWARD OF COLONIAL POLICE MEDAL

HIS EXCELLENCY the Governor is pleased to announce that information has been received from the Secretary of State that Her Majesty the Queen has been pleased to approve the immediate award of the Colonial Police Medal for gallantry to—

No. 4511 CORPORAL KIPSANG ARAP KIPKOSIN for conspicuous gallantry in the execution of his duty.

This Corporal was a member of a patrol of the Security Forces during the attack by *Mau Mau* terrorists on the Gattagiki School near Kandaredu on 9th May, 1953. On this occasion a gang of approximately 200 terrorists attacked the school. They were armed with probably some 20 rifles. A combined force of Military and Police engaged the gang, but during the ensuing action it was necessary for the Security Forces to withdraw and abandon their vehicles.

During the action Corporal Kipsang displayed the finest qualities of leadership and bravery in organizing his section of constables while under fire, and during the withdrawal he maintained splendid control of his men and succeeded in ensuring that they retired in an orderly fashion.

Throughout the action he showed exceptional gallantry, an excellently calm and confident manner, and also assisted in removing a wounded constable from the scene.

AWARD OF COLONIAL POLICE MEDAL

HIS EXCELLENCY the Governor is pleased to announce that information has been received from the Secretary of State that Her Majesty the Queen has been pleased to approve the immediate award of the Colonial Police Medal for gallantry to—

KENYA POLICE RESERVE OFFICER MICHAEL ROBERT JOHN HUGHES for conspicuous gallantry in the execution of his duty.

At approximately 9.30 a.m., on 23rd April, 1953, K.P.R.O. Hughes was a member of a police patrol which encountered a *Mau Mau* terrorist gang numbering some 40 persons in the Eastern Mau Forest; this gang had previously murdered five Africans in most brutal circumstances. Apparently the gang observed the police patrol from a densely wooded ravine, and one of its members discharged a shotgun from a short range at R.P.O. Hughes, but failed to hit him; the officer immediately returned the fire and showing total disregard for his own safety, dived into the undergrowth in pursuit of the gang and found a terrorist lying dead. At this moment another terrorist discharged a pistol at K.P.R.O. Hughes from nearby and in spite of still being unable to see his attacker, he advanced with great courage through the undergrowth in the direction whence the shot had come; the terrorist again fired, but K.P.R.O. Hughes was able to shoot him dead. He then saw two more members of the gang armed with rifles running away from the patrol and he shot, wounded and captured both of them and recovered their arms.

Throughout the action this officer displayed total disregard for his own safety, courage of the highest order while under fire, and continued to attack the gang with energy and determination in most dangerous circumstances although he was seldom able to see his opponents.

AWARD OF COLONIAL POLICE MEDAL

HIS EXCELLENCY the Governor is pleased to announce that information has been received from the Secretary of State that Her Majesty the Queen has been pleased to approve the posthumous award of the Colonial Police Medal for gallantry to—

No. 4054 SERGEANT NTHENGE MAKAU
of the Kenya Police.

On 26th March, 1953, this Sergeant was on plain clothes duty in the Bahati Location of Nairobi on patrol with a uniformed constable; they had arrested three prisoners. He detailed the constable to check a nearby shop when members of a gang hidden in the vicinity attacked the Sergeant, who was then shot twice and wounded. Although his wounds were grave and subsequently proved mortal, Sergeant Nthenge returned the fire of his assailants. He subsequently succumbed to his wounds in hospital.

This Sergeant exhibited great devotion to duty, and although having been grievously wounded he continued to return the fire of his assailants until he collapsed.

AWARD OF COLONIAL POLICE MEDAL

HIS EXCELLENCY the Governor is pleased to announce that information has been received from the Secretary of State that Her Majesty the Queen has been pleased to approve the immediate award of the Colonial Police Medal for gallantry to—

SPECIAL POLICE OFFICER STANLEY DAVIDSON
for conspicuous gallantry in the execution of his duty.

As a result of information received to the effect that there was a large *Mau Mau* hideout in the forest to the west of Kinyona, "A" Company of the 4th K.A.R. was moved at 9 p.m. on 17th July, 1953, to investigate the report; attached to the Company was Mr. Davidson in his capacity as Field Intelligence Assistant.

The patrol proceeded into the forest until 2 a.m. when they rested until dawn. On approaching within one mile of the site of the hideout the leading troops surprised and killed two *Mau Mau* sentries; after continuing for a further distance of approximately half a mile through very dense forest, a terrorist outpost, comprised of some 15 men, was reached. This outpost was well concealed and its occupants armed with automatic weapons, rifles and a pistol. At this point Special Police Officer

Davidson, who was leading the patrol, came under the fire of a terrorist at a range of about 10 yards. The first shot struck the officer in the shoulder and knocked him down, but he at once rose, returned the fire and wounded the terrorist. Another shot was then fired at the officer, who was wounded in the groin and fell to the ground. However, he rose again and returned the fire with his automatic weapon. Further shots struck S.P.O. Davidson in the stomach and the hand, and the butt of his weapon was smashed. Nevertheless, he continued to struggle forward and struck one of his attackers over the head with his sub-machine gun. He then finally collapsed.

After this action, in which two terrorists were killed and a rifle and pistol recovered, S.P.O. Davidson was carried back to the forest edge on an improvised stretcher where he received medical attention; he was then transported to Nairobi. During the whole of this time, despite the rough journey through the forest on a stretcher and later in a Land Rover, and despite suffering great pain, he uttered no complaint.

AWARD OF COLONIAL POLICE MEDAL

HIS EXCELLENCY the Governor is pleased to announce that information has been received from the Secretary of State that Her Majesty the Queen has been pleased to approve the immediate award of the Colonial Police Medal for gallantry to—

No. 2578 CONSTABLE OKELO S/O SAKA
for conspicuous gallantry in the execution of his duty.

Constable Okelo s/o Saka was off duty on 28th June, 1953, and was cycling along Meru Road, Pumwani, at about 2 p.m. in plain clothes when he was called upon to stop by three Africans. He dismounted from his cycle when he was accused by these Africans of being "one of the people who repatriate Kikuyu to the Reserve". Almost immediately a shot was fired when he observed then that the three men who had stopped him were armed with pistols. One of them seized the constable's jacket and fired at him at point blank range, but the bullet fortunately grazed his scalp only. The constable immediately retaliated by punching his assailant, when another shot was fired at him from behind. This bullet also grazed the constable's scalp. In spite of his wounds Constable Okelo continued to endeavour to get to grips with his assailants and three more shots were fired at him during the general fracas that ensued, but fortunately they missed him.

Eventually a bystander raised the alarm and the assailants escaped; the constable was then taken to Pumwani Police Station where he made a report of the incident and gave a good description of his assailants. In spite of his wounds he returned to the scene with the officer in charge of the Police Station to explain to him in detail the circumstances of the incident; he was then removed to hospital for treatment.

Constable Okelo is 23 years of age and joined the Force eleven months ago; he did not leave the Training School until October, 1952, so he has under nine months' service with a regular formation. His conduct in attacking his assailants, in making a logical report at the Police Station and returning with the officer in charge to the scene in spite of his wounds is worthy of the highest recognition.

One of the assailants was subsequently shot by another police officer. He was carrying a .38 pistol.

for conspicuous gallantry in the execution of his duty.

On the evening of 16th October, 1952, Corporal Difu Ngodi was one of a small party of police which, under the command of a European Detective Inspector, was called to investigate a store-breaking in the old town of Mombasa. As the Detective Inspector's party arrived at the store situated in the Ndia Kuu Area, three Africans broke away through an underground drain, through which they had gained ingress to the store and commenced to run in different directions. A chase ensued, during which one of the fugitive Africans lunged with a knife at Corporal Difu, who was endeavouring to block his path. Corporal Difu avoided the thrust and continued in pursuit of his assailant through the maze of lanes and narrow streets of the Old Town.

In the meantime, the African turned into an alleyway, where the Detective Inspector blocked his way, seized and grappled with him but, after a short struggle, the African succeeded in escaping, after viciously stabbing and mortally wounding the Inspector. The African then started to run again but was intercepted by Corporal Difu who, after a long and violent struggle with his adversary, finally overpowered and disarmed him with the assistance of another police constable, who later arrived at the scene of the incident.

At the time when Corporal Difu finally disarmed and arrested the African he was fully aware that he was tackling a desperate man, armed with a knife, which had already been used by the store-breaker against himself and others in order to resist lawful arrest.

In acting as he did, Corporal Difu showed complete disregard for his own safety and courageous devotion to duty of a high order.

On 10th October, 1953, Constable Magige s/o Wambura, of the Mtende tribe, attached to Kihancha Police Station, was on duty in the Masai District when he saw cattle being illegally grazed there by two Watende and a boy. He endeavoured to seize the cattle and the herdsmen started driving them back towards the Utende country; Constable Magige had with him a complainant and also one prisoner, arrested for trespass. When the party arrived at the Utende border Constable Magige insisted that they must go to Kihancha Police Station; the herdsmen, however, refused to obey the order and while attempting to arrest one of them a *simi* was thrown at him and, in trying to effect his arrest, the constable slightly stabbed him with his bayonet. The other herdsmen then fired an arrow at the constable, which penetrated the brim of his hat and, observing that his assailant had further arrows and no doubt anticipating that a second missile might be fired at him, he shot this man dead. Having recovered the deceased's bow and quiver of 11 arrows, he continued to drive the cattle towards Kihancha but, after a little while he was overtaken by a hostile crowd of approximately 100 Watende, who were shouting war cries. One of the crowd then made ready to fire an arrow at Constable Magige, who again used his rifle and wounded the man slightly in his left hand.

It has been established that another member of the crowd then fired an arrow at the constable from behind, but he turned around, fired and wounded him in the right leg.

The cattle were successfully removed.

Constable Magige displayed exceptional devotion to duty, his restraint, cool-headedness and firmness in a most dangerous situation were most praiseworthy and his courage was of the highest order.
