They are also required to pay their passages to the United Kingdom and to deposit in advance the cost of their homeward passages. They receive maintenance payments from the Federation at the rate of £450 per annum, free of income tax.

*Qualifications*

(a) hold a degree or diploma in engineering issued by a recognized university faculty, institute or school;

(b) be able to profit from training in industrial—as distinct from academic—surroundings;

(c) be medically fit;

(d) speak and write English well;

(e) possess good character, initiative and a sense of responsibility;

(f) undertake to return and follow their profession in their own country.

(g) have recently graduated;

(h) have had not more than two years' industrial or practical experience;

(i) required general practical training in engineering.

(l) wish to secure specialized knowledge in a particular branch of engineering;

(m) provide letters from their employers supporting their applications and consenting to release them for the required period of training, if an award is made.

Maintenance payments start from the date of arrival in the United Kingdom and end on the date of departure, provided that this takes place within a reasonable time of completion of training. These payments are made by the Federation monthly in advance.

## REPORT BY THE CONTROLLER AND AUDITOR-GENERAL ON THE ACCOUNTS OF THE AFRICAN TEACHERS PENSIONS FUND FOR THE YEAR ENDED 31st DECEMBER, 1958

The Board of Management of the Fund was established on 1st October, 1958, by Gazette Notice No. 3572 of 2nd October, 1958. Previous to the establishment of the Board of Management executive work was undertaken by the Chairman and the Secretary.

2. During the period covered by this report and in previous periods of account, pensions were granted to persons who did not come within the definition of a teacher given in the African Teachers Service (Contributory Pensions Fund) Regulations, 1957. A wider definition of a teacher which would have covered the persons concerned is now given in the African Teachers Service (Contributory Pensions Fund) (Amendment) Regulations, 1959, published as Legal Notice 157 in the Kenya Gazette Supplement of 21st April, 1959.

3. The actuarial valuation of the Fund required by Regulation 32 of the African Teachers Service (Contributory Pensions Fund) Regulations, 1957, has not yet been made. Reference to this omission has been made in my previous reports on the accounts of the Fund.

4. In accordance with a resolution passed by Legislative Council on 1st November, 1955, Government guaranteed to pay into the fund the appropriate contribution in respect of the past service of teachers admitted to the pension scheme either in one sum or by instalments over a period of years when the Government Actuary's calculation based on revised numbers and salaries had been made. No payment to the fund has yet been made.

5. Section 5 (3) of the Regulations provides that the Government will be reimbursed with a sum representing the expenses incurred by Government in the administration of the Regulations as assessed annually on 31st December, by the Director in consultation with the Secretary to the Treasury. As far as I am aware the amount charged in the accounts and paid to Government has not been agreed as required by the Regulations. Also certain expenditure incurred by Government has not been reimbursed and this matter is under correspondence with the Chairman.

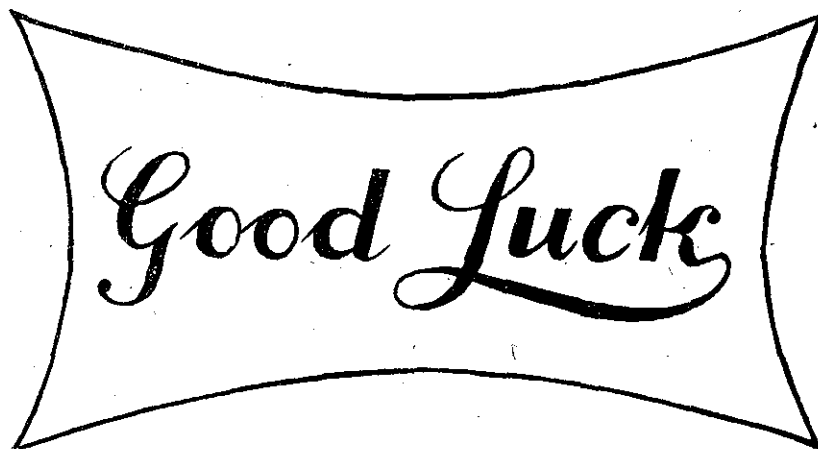
