Explanatory note—The use of spinning lures will continue to be permitted on the lower section of the Nyamindi River as an experiment to remove from the river the few remaining large trout. Stocking with fingerlings has been carried out, but as these have not yet reached catchable size and large fish are still being taken on artificial lures the river will remain open until 30th June, 1960. Fly fishing will continue as usual in the upper section of the river.

(2) Small animals (sheep, goats, pigs, calves under six months old and foals under three months old)—except pigs, and calves under three months old, carried by specified pig trains—will be charged as large animals on the basis of six small animals or part thereof equal one large animal, and all references to the charging of large animals throughout this tariff shall apply accordingly to the charging of small animals

(6) Pigs and calves under three months old, carried by specified pig trains will be charged one quarter of the cattle wagon head rate subject to a minimum charge of Sh 1/80 per head
