AMENDMENTS TO TARIFF BOOK NO. 3 (PARTS I AND II) THE East African Railways and Harbours give notice that Tariff Book No. 3 (Parts I and II) is amended as follows with effect from 1st February, 1963:—

Part I

### PAGE 50. SECTION 90

Delete the section in its entirety and insert :--

### 90. Motor-cars and Motor Scooters Accompanying

Passengers 1. Motor-cars privately owned, on wheels, accompanying passengers, will be carried at the rates quoted in paragraphs 2 (a) and 2 (b) below, provided that—

- (a) the owner consigns the car between the same points as those for which one valid first or two valid second-class passenger tickets (single or return as the case may be), paid for at the standard rates detailed in sections 70 and 74, are produced at the time of booking;
- (b) the car may be carried in an open railway wagon on those sections of the journey requiring rail transit;
- (c) the Administration reserves the right to load other traffic in the same wagon. Sole use of a wagon will not be guaranteed;
- (d) the Administration does not undertake to despatch the car by any particular train or ship nor can any specified time of arrival at destination be guaranteed;
- (e) the carriage of accompanied motor-cars is at owner's risk and in all cases an owner's risk consignment note must be completed and signed by the sender;
- (f) these arrangements are subject to the general conditions attached to the carriage of motor-cars.

2. The rates charged will be as follows:-

(a) Single journeys.—The full Scale "A" rates as set out in section 340 of Part II of this Tariff Book will be charged and charges must be paid by the consignor at the time of booking. Between Nairobi Station and Mombasa Station only (or vice versa) accompanied motor-cars will be carried at Scale "A" rates less 20 per cent. This rate does not apply to unregistered cars.

(b) Return journeys.—Accompanied motor-cars will be carried at  $1\frac{1}{2}$  times the Scale "A" rates. Charges for both the forward and return journeys must be paid by the consignor at the time of booking for the forward journey.

3. Charges will be based on passenger mileages calculated in accordance with section 310 by the actual route travelled, provided that, if at the Administration's convenience, a car booked at accompanied car rates over part of its journey by train or lake steamer does not accompany the passenger, charges may be recalculated at Scale "A" rates on goods mileages for that portion of the journey for which the car is not accompanying the passenger.

4. Motor scooters (including bicycles with motor attachments and mopeds) accompanying passengers will be carried between certain stations at the reduced rates given in section 340 (7) of Part II of this Tariff Book, provided that—

- (a) the owner holds a valid return first- or second-class passenger ticket between the two points concerned;
- (b) the reduced rates apply to return journeys only. Single journeys and journeys between points other than those specified will be charged at ordinary parcels rates;
- (c) the carriage of accompanied motor scooters is at owner's risk and in all cases an owner's risk consignment note must be completed and signed by the sender.

Scale "A" rates are applicable to all vehicles exceeding 13 ft. 4 in. in length overall, vehicles of 13 ft. 4 in. or less if consigned in quantities of less than three and also to passengers' cars consigned under the Accompanied Car Scheme.

Scale "B" rates are applicable to all vehicles the length of which has been confirmed as not exceeding 13 ft. 4 in. by reference to the manufacturer's Handbook of Instructions, or other documentary evidence supplied by the manufacturer's agent in East Africa, when consigned in quantities of three or more. Vehicles which have been modified to reduce their length to 13 ft. 4 in. or under will not be accepted at Scale "B" rates.

Cars consigned under the Accompanied Car Scheme do not qualify for Scale "B" rates.

The charges for vehicles to which Scale "A" rates apply will be increased by 75 per cent if the length of the vehicle necessitates the use of a bogie wagon. The increase will apply to rail and marine services. Assistance in loading and unloading vehicles on wheels will be undertaken free of charge at the sole risk of the owner.

(b) Motor-cars, vans, buses, lorries chassis and undercarriages in a completely knocked down condition, securely packed in cases:—

Charges as for vehicles at Scale "B" will apply irrespective of the dimensions of the vehicles. The rates only apply to complete vehicles. The number of vehicles in cased consignments must be declared by the consignor on the consignment note.

2. Vehicle parts or equipment which are separately consigned will be charged separately in accordance with the General Classification of Goods.

3. Motor vehicles consigned at Scale "A" or Scale "B" rates are only accepted at owner's risk conditions of carriage.

4. Motor-cars consigned to race meetings approved by the Automobile Association of East Africa and the Administration will be carried at full Scale "A" rates on the forward journey and a reduction of 50 per cent will be granted on the return journey. This concession will also apply to motor-cars loaded on trailers consigned to race meetings.

5. Details of the concession rate for tractors for agricultural purposes are given in section 198 of Part I of this Tariff Book.
