LAW EXAMINATION FOR ADMINISTRATIVE OFFICERS

1. It is notified for general information that the next Law Examination for Administrative Officers will be held on 13th, 14th and 15th June 1966.

2. The examination will consist of the following two sections, of three and two parts each, respectively:—

Section I

- (i) The Penal Code.
- (ii) The Criminal Procedure Code.
- (iii) The Law of Evidence.

Section II

- (i) The Civil Procedure Code.
- (ii) The Local Acts.

Note.—The Local Acts to be studied are specified in paragraph 5 below.

Administrative Officers will be required to take the Acts listed under Category "A" while candidates from the Judicial Department will be required to take Acts listed under Category "B". Private candidates may choose to sit for either Category.

3. Candidates may appear for both sections or for either section at a time, but must pass each section as a whole to record a pass. Officers who possess a Law Degree of an accredited University are only required to pass Part (ii) of Section II.

4. Exemption in part of the examination may be applied for by those officers who have passed the Kenya Police Law Examination "B" or a comparable Examination for Administrative Officers in another territory.

Provincial Planning Officer (Four Posts), Ministry of Economic Planning and Development (No. 75/66)

Salary scale.—£1,839 to £1,989 or £1,442 to £1,710. PENSIONABLE.

Preference will be given to Honours Graduates or those with a Master's degree of an approved University with Economics as one of their major subjects and must have worked for a minimum of five years in Government or in a large business organization. Successful candidates will be posted to Provincial Headquarters and will work in close co-ordination with Provincial Commissioners and Provincial Heads of Departments. Their duties will include co-ordination of development plan preparation and implementation at provincial, district and locational levels. Consideration will be given to appointing on the scale £1,442 to £1,710 other applicants who do not qualify for appointment on the scale £1,839 to £1,989 provided they possess approved basic qualifications and have worked in Government or in a large organization for a minimum of three years.

Chief Executive Officer (Principal Land Consolidation Officer), Ministry of Lands and Settlement (No. 76/66)

Salary scale.—£1,839 to £1,989. PENSIONABLE.

Applicants should be serving Government Officers of at least District Officer rank or equivalent, with not less than five years' service, of which a minimum of three years must have been in a senior administrative post. Fluency in Swahili is essential, and experience of Land Consolidation work in the field is highly desirable; candidates without such experience will only be considered in the event of their other qualifications being of an exceptionally high order. A knowledge of African customary law in relation to land would be an advantage, as would also some survey experience.

**State Counsel, Office of the Attorney-General (No. 77/66)*

Salary scale.—£804 to £1,710. PENSIONABLE or AGREEMENT.

Applicants must be barristers or solicitors, with at least three years' professional experience since qualification, and should have had considerable experience of Court work and the preparation of civil and criminal cases.

Commandant, National Youth Service (Four Posts), Ministry of Labour (No. 78/66)

2. A plan of the plots may be seen at the Public Map Office situated in the Lands Department Building, City Square, Nairobi, or at the Office of the District Commissioner, Laikipia, or may be obtained from the Public Map Office, P.O. Box 30089, Nairobi, on payment of Sh. 3 post free.

3. Applications should be submitted to the Commissioner of Lands, Nairobi, through the District Commissioner, Laikipia, stating the plot required in order of preference.

4. Applications must be sent so as to reach the District Commissioner, not later than noon on the 22nd day of March 1966.

5. Applications must not be sent direct to the Commissioner of Lands.

6. Applicants must enclose with their applications their cheque for Sh. 1,000 as a deposit, which will be dealt with as follows:—

- (a) If the applicant is offered and takes up and pays for a plot within a period of seven days as required in paragraph 5 below, the deposit will be credited to him.
- (b) If the application is unsuccessful the applicant's deposit will be returned to him.
- (c) If the application is successful and the applicant fails to take up and pay for the plot offered to him within a period of 14 days as required in paragraph 5 of the General Conditions, the Commissioner of Lands may declare the deposit forfeited and the applicant shall have no further claim thereto.

General Conditions

1. The ordinary conditions applicable to township grants of this nature except as varied hereby shall apply to this grant.

2. The grant will be made under the provisions of the Crown Lands Act (Cap. 280 of the Laws of Kenya) and title will be issued under the Registration of Titles Act (Cap. 281).

3. The grant will be issued in the name of the allottee as stated in the letter of application.

4. The term of the grant will be for 99 years from the first day of the month following the notification of the approval of the grant.

5. Each allottee of a plot shall pay to the Commissioner of Lands within 14 days of notification that his application has been approved, the initial estimated amount for the construction of roads and drains to serve the plot, the assessed stand premium and proportion of annual rent, together with the survey fees payable in respect of the preparation and registration of the grant (Sh. 225) and the stamp duty in respect of the grant (approximately 2 per cent of the stand premium and annual rent). In default of payment within the specified time the Commissioner of Lands may cancel the allocation and the applicant shall have no further claim to the grant of the plot.

Special Conditions

1. No buildings shall be erected on the land nor shall additions or external alterations be made to any buildings otherwise than in conformity with plans and specifications previously approved in writing by the Commissioner of Lands and the Local Authority. The Commissioner shall not give his approval unless he is satisfied that the proposals are such as to develop the land adequately and satisfactorily.

2. The grantee shall within six months of the commencement of the term submit in triplicate to the Local Authority and the Commissioner of Lands plans (including block plans showing the positions of the buildings and a system of drainage for the disposal of sewage, surface and sullage water), drawings, elevations and specifications of the buildings the grantee proposes to erect on the land and shall within 24 months of the commencement of the term complete the erection of such buildings and the construction of the drainage system in conformity with such plans, drawings, elevations and specifications as amended (if such be the case) by the Commissioner:

Provided that if default shall be made in the performance or observance of any of the requirements of this condition it shall be lawful for the Commissioner of Lands or any person authorized by him on behalf of the President of the Republic of Kenya to re-enter into and upon the land or any part thereof in the name of the whole and thereupon the term hereby created shall cease but without prejudice to any right of action or remedy of the President or the Commissioner in respect of any antecedent breach of any condition herein contained.

3. The grantee shall maintain in good and substantial repair and conditions all buildings at any time erected on the land.

4. Should the grantee give notice in writing to the Commissioner of Lands that he/she is/are unable to complete the buildings within the period aforesaid the Commissioner of Lands shall (at the grantee's expense) accept a surrender of the land comprised herein:

Provided further that if such notice as aforesaid shall be given (1) within 12 months of the commencement of the term the Commissioner of Lands shall refund to the grantee 50 per centum of the stand premium paid in respect of the land, or (2) at any subsequent time prior to the expiration of the said building period the Commissioner of Lands shall refund to the grantee 25 per centum of the said stand premium. In the event of notice being given after the expiration of the said building period no refund shall be made.

5. The land shall not be used for the purpose of any trade or business which the Commissioner of Lands considers to be dangerous or offensive.

6. The grantee shall not subdivide the land.

7. The grantee shall not sell, transfer, sublet, charge or part with the possession of the land or any part thereof except with the prior consent in writing of the Commissioner of Lands: no application for such consent (except in respect of a loan required for building purposes) will be considered until Special Condition No. 2 has been performed.

8. The grantee shall pay to the Commissioner of Lands on demand such sum as the Commissioner may estimate to be the proportionate cost of constructing all roads and drains and sewers serving or adjoining the land and shall on completion of such construction and the ascertainment of the actual proportionate cost either pay (within seven days of demand) or be refunded the amount by which the actual proportionate cost exceeds or falls short of the amount paid as aforesaid.

9. The grantee shall from time to time pay to the Commissioner of Lands on demand such proportion of the cost of maintaining all roads and drains serving or adjoining the land as the Commissioner may assess.

10. Should the Commissioner of Lands at any time require the said roads to be constructed to a higher standard the grantee shall pay to the Commissioner on demand such proportion of the cost of such construction as the Commissioner may assess.

11. The grantee shall pay such rates, taxes, charges, duties, assessments or outgoings of whatever description as may be imposed, charged or assessed by any Government or Local Authority upon the land or the buildings erected thereon, including any contribution or other sum paid by the President of the Republic of Kenya in lieu thereof.

12. The President of the Republic of Kenya or such person or authority as may be appointed for the purpose shall have the right to enter upon the land and lay and have access to water mains, service pipes and drains, telephone or telegraph wires and electric mains of all descriptions whether overhead or underground, and the grantee shall not erect any buildings in such a way as to cover or interfere with any existing alignments of main or service pipes or telephone or telegraph wires and electric mains.

Special Conditions in Respect of Plot for Shop combined with Residence

1. The land and building shall only be used for the purposes of a shop combined with residence.

2. The buildings shall not cover more than 50 per centum of the area of land or such lesser area as may be prescribed by the Local Authority.

Special Conditions in Respect of Dairy Plot

1. The land and building shall only be used for dairy purposes. Residence for a caretaker not exceeding 100 sq. ft. will be permitted.

2. The building shall not cover more than 90 per centum of the area of land or such lesser area as may be laid down by the Local Authority.

THE INDUSTRIAL COURT

CAUSE No. 40 OF 1965

Parties:—

The Kenya Chemical Workers' Union
and
Refractories Limited

Issues in dispute:—

- (a) Wages.
(b) Annual Paid Leave.

1. The Parties were heard in Nairobi on 5th November 1965, 13th January and 8th February 1966, and relied on their written and verbal submissions. Refractories Limited called three witnesses on the issue of the wage standstill under the Tripartite Agreement.

GENERAL BACKGROUND

2. The Kenya Chemical Workers' Union shall hereinafter be referred to as the Claimants and Refractories Limited shall hereinafter be referred to as the Respondents.

The Respondents have had dealings with the Claimants since late 1961 and the current negotiated agreement on terms and conditions of service dates from 1st February 1964. Clause 17 of this agreement refers to the date of implementation and duration and is set out in full hereinbelow in the Court's Ruling on the Wages issue (Issue in Dispute (a)). The Claimants submitted their demands in March 1965, and had listed 22 items. Negotiations were held and eventually as a result of deadlock on the wage issue resort was made to conciliation through the Ministry of Labour. The Respondents having notified the dispute to the Ministry of Labour on 27th July 1965. The information to the Ministry of Labour referred to 2 items in dispute in addition to the wage issue. In conciliation the 2 other items—leave travel allowance and uniforms—were resolved leaving in issue the Claimants' demand for an increase in the annual leave entitlement.

At the hearing on 5th November 1965, arguments were put forward by the Parties on the application of the Tripartite Agreement to the present dispute. A further opportunity was afforded to the Parties to address the Court on this issue on 13th January 1966. On the 19th day of January 1966, the Court made the following preliminary ruling:—

"The issues were referred to the Industrial Court for settlement in accordance with the provisions of the Trade Disputes Act, 1965. The Parties were heard in Nairobi on 5th November 1965, when the Court comprised of the President, Vice-President Mr. Ochwada and Mr. John Watts. Arguments were put forward by the Parties on the application of the Tripartite Agreement to the present dispute and the Court adjourned to consider its decision on this preliminary point. In the meantime the Court having given a ruling on the Tripartite Agreement in the Oil Industry dispute *vide* Cause No. 39 of 1965, it gave the Parties a further opportunity of addressing the Court. Before the Court could be reconvened Mr. Ogutu on behalf of the Claimants objected to Mr. Watts sitting on the Court although he had in the first instance agreed to him sitting. The reason for his objection was that his Union had dealings with Mr. Watts' employers. In these circumstances the President asked the other Vice-President Mr. Omolo Agar to sit in the Court in place of Mr. Watts. The Parties agreed to this.

The resumed hearing took place on 13th January 1966, and the Respondents called three witnesses. Two witnesses, Col. Glover and Mr. Boyd, testified to the effect that Mr. Ogutu had persistently refused to sign an agreement which included in the duration clause provision giving practical effect to the wage standstill benefit under the Tripartite Agreement. Col. Glover also informed the Court that the Claimants had given him an assurance that they would abide by the Tripartite Agreement and because of this assurance no mention of it was made in the agreement which was signed between the Parties on 3rd April 1964, giving it effect from 1st February 1964. The Respondents also drew the Court's attention to their submission in Cause No. 6 of 1964 showing the difficulties they had experienced with this particular Union.

The Claimants on the other hand maintained that the current agreement between the Parties was concluded after commencement of the Tripartite Agreement and the Parties had contracted themselves out of it. They also produced a letter dated 11th March 1965, addressed by the Managing Director to them which is quoted below:—

'Dear Sirs,

Workers' Demands

Thank you for your letter of 9th March received this morning, regarding your attached list of new proposals for 1965.

Mr. Dodds of the F.K.E. is unfortunately away in Mombasa and will not be returning until Saturday so it will be at least Monday or Tuesday of next week before I shall be able to discuss your proposals with him. I note that you have given four days' notice for a reply which includes a weekend, whereas if you remember paragraph 17 of our

present agreement you will remember that you yourself proposed that you would give us two months' notice of any new proposals so as not to have any argument with regard to back pay.

As soon as I can see Mr. Dodds and we have come to some arrangement I will let you know at the earliest possible moment.'

Ruling

The facts are that an agreement relating to wages and terms and conditions of service was concluded between the Parties and signed on 3rd April 1964, with the effective date as from 1st February 1964. It may well be that the negotiations between the Parties were pending prior to the coming into operation of the Tripartite Agreement. Clause IV of section (d) of the Tripartite Agreement makes it plain that claims already being processed at 23rd January 1964, must be resolved, but only in the context of clause (i) of section (b) which provides for the revision to be subject to the standstill period of 12 months (now 14 months). Notwithstanding the conditions quoted above the Parties to this dispute signed an agreement on 20th May 1964, during the life of the Tripartite Agreement, and, being aware of its implications, yet made provision in the terms and conditions of the agreement for the variation, termination or amendment of their agreement. The relevant clause reads as follows:—

'17. Date of implementation and duration

This agreement shall be effective from 1st February 1964, and shall remain in force for a period of 12 months from that date and thereafter until it is amended by mutual agreement between the Company and the Union provided that the party desiring to amend the agreement shall give two months' prior notice of their intention and shall set out in detail the amendments or alterations desired. The Union undertakes to make its best endeavours to give notice of amendments or alterations it may propose two months before 31st January 1965, so that no question of back-dating need arise.'

It is remarkable that, whereas other agreements concluded during the life of the Tripartite Agreement are specific in their intention to extend their life by the period of the standstill, this agreement is specific in its intention to consider a variation to terms and conditions of service.

In these circumstances the Court finds that the agreement between the Parties overrides any verbal or other undertakings given by the Claimants confirming that they would honour the Tripartite Agreement.

The Court rules, therefore, that in this particular dispute and without prejudice to its effect on any other agreement, the Parties hereto are entitled to negotiate on wages and other conditions of employment.

As the Respondents have not met the Claimants' memorandum in great detail they are given 10 days from the date hereof to amend and submit a further memorandum. The hearing shall resume after the receipt of such further memorandum from the employers on a mutually convenient date."

After the Respondents had submitted a supplementary memorandum the Court concluded the hearing of this dispute on 8th February 1966.

MAIN SUBMISSIONS ON BEHALF OF THE CLAIMANTS

3. (a) *Wages*.—The Claimants submitted that the current wage rates were not based on Grades and as Grading was not an issue in dispute they expected the Court to grant an increase to all employees. They suggested that any increase given by the Court on the current minimum wage of Sh. 219 consolidated should be awarded to all employees on their current wages. The Claimants submitted that the present rates of pay did not offer adequate remuneration to the employees and that there was room for substantial improvements. They urged the Court to consider that they were still a long way off from their declared target of a minimum wage of Sh. 350 per month for the lowest-paid worker. They pointed out that before Kenya achieved her Independence, African workers had lived on starvation wages and had been exploited for nearly 70 years. It was only natural that these workers since Independence should try to raise their standard of living. The Claimants stated that the three East African Governments had laid emphasis on the need for a high-wage economy, social security and old age pension schemes.

School fees, taxes and the cost of living had risen in the last three years. The Claimants submitted that a single worker needed, for his bare necessities, a sum of Sh. 245 per month, and a worker with a family required Sh. 498 per month. The Claimants put forward the following points for the Court's consideration and suggested that these should be taken into account when wages were assessed:—

- (a) *Food*: to enable the employee and his family to get enough food every day to replace the energy used in living and working;
- (b) *Clothing*: enough clothes for an employee and his family to appear decently dressed with proper protection from the weather;
- (c) *Housing*: housing of a standard under which the employee and his family could live under healthy and hygienic conditions;

(d) Security;

(e) Education: an employee, his wife and children should be afforded the opportunity to develop talents and ability to the fullest extent.

The Claimants stated that the Respondents had at no time pleaded their inability to pay but had all along sought refuge behind the wage standstill clause in the Tripartite Agreement. The Claimants strongly refuted the Respondents' allegation that they had not embarked on negotiations in the true spirit of maintaining good industrial relations. They submitted that out of the 22 items put forward only two had been referred to the Industrial Court, all the others having been either dropped or settled.

(b) Annual Paid Leave.—The Claimants demanded that an employee who had completed one year or more of service with the Respondents, but less than four years, should be entitled to 21 working days' paid leave annually excluding any gazetted holidays which might fall during the leave period, and that an employee who had completed four years' service with the Respondents should get 28 working days' leave annually. The present leave entitlement they submitted was 21 consecutive days' leave annually. They argued that their demands were based on the numerous other agreements which they had negotiated with various employers during the last six months. Their demand would also be in line with the leave entitlement being enjoyed by workers in the chemical industry at present.

MAIN SUBMISSIONS ON BEHALF OF THE RESPONDENTS

4. *(a) Wages.*—The Respondents very strongly put forward the view that there had been no genuine or adequate negotiations on the wage issue between them and the Claimants and that when the Court gave its Ruling on the preliminary point, the Claimants' General Secretary had rejected the opportunity of starting negotiations with them on this issue and had stated that no useful purpose would be served by having the matter referred back for negotiation. The Respondents stated that they had been quite willing to *(a)* submit additional memorandum and *(b)* conduct negotiations on the issue of wages. The Respondents drew the Court's attention to its award in Cause Nos. 12 of 1965 and 17 of 1965 where the Court had criticized the Parties for failing to negotiate genuinely.

The Respondents submitted that the current negotiated agreement made provision for a minimum wage of Sh. 219 per month and that if the Claimants' demand was taken on its face value they appeared to be seeking a raise of just over 40 per cent. The Respondents were faced with the Claimants' demands which had not been supported by arguments, facts or figures and which had not been tested in negotiation. The Respondents drew the Court's attention to a quotation from a book by H. W. Davey on contemporary collective bargaining which quotation is set out below:—

"The seven principal criteria usually cited by employers to Union leaders in justifying their respective agreements in wage negotiations are:

- (1) The minimum necessities of the workers.
- (2) Changes in the cost of living.
- (3) The maintenance of take-home pay in the face of reduction in hours.
- (4) Changes in the productivity of labour.
- (5) The ability (or inability) of the employer to pay.
- (6) The alleged effect of higher or lower wages upon consumer purchasing power and employment.
- (7) The wages paid in other industries and places."

The Claimants had made no submissions under any of these headings.

The Respondents submitted that if an award was made in these circumstances the most important precept so far safeguarded by the Court was likely to be destroyed. They requested the Court not to offer any benefits to the Claimants as any beneficial award would deal a death blow to industrial relations. They stated that nothing could be more harmful than the evolution of a system whereby a Union merely tabled a demand before an employer and without bargaining, argument or the tabling of data and statistics immediately took that figure to an arbitration tribunal.

The Respondents stated that as they had expended a considerable sum of money by engaging 20 per cent additional staff, equitably they were entitled to say to the Court that the money which could have been granted to the employees by way of a wage increase had been expended in succouring members of the community who were less fortunate than the Respondents' employees. Therefore, no money was available until 1st April 1966, and it was the view of the Respondents that the Court should make its award on the current wage level.

(b) Annual Paid Leave.—The Respondents submitted that the current clause on leave entitlement was generous. It also contained a proviso which established that where a gazetted public holiday fell within the leave period then the number of holidays so involved should be added to the leave entitlement. The Respondents stated that a review of the recent agreements by the Claimants showed nothing comparable to the demand made by them. They stated that the four agreements which the

Claimants had entered into with the British Standard Portland Cement Company Limited at Mombasa, the Pyrethrum Marketing Board, the East African Portland Cement Company Limited and the Magadi Soda Company Limited bore no parallel to the present dispute as these were all large employers of labour. The Respondents with only 65 employees involved in the production of bricks could not be deemed to be on a par with these companies.

AWARD

5. The Court has very carefully considered the submissions made by the Parties especially the Respondents' allegation against the Claimants for not having had negotiations in the true spirit of maintaining industrial relations. This submission has some merit and under normal circumstances the Court might have upheld it. In the present case, however, the history of negotiations is that out of 22 items originally demanded by the Claimants only two have found their way to the Industrial Court.

It is quite possible that some of these 22 demands were frivolous but the fact is that at the meetings which took place between the Parties and, subsequently, during conciliation that all but two of these were disposed off. On the issue of wages the Respondents' stand was that they were entitled to the wage standstill benefit under the Tripartite Agreement and, therefore, refused to enter into any negotiations on this issue. The matter came to the Industrial Court on 7th September 1965, and a Ruling on this preliminary point was given on the 19th day of January 1966.

It was in these circumstances, when the Claimants' General Secretary stated that no useful purpose would be served by entering into further negotiations with the Respondents, that the Respondents were allowed to file a supplementary memorandum. The Court finds that to refer the matter back for negotiations or to make a nil award would be unfair to the workers. Had the circumstances been different and the Claimants had refused to negotiate genuinely then they would have come under severe criticism.

The Court, therefore, makes the following award:—

(a) Wages.—All employees shall get an increase of Sh. 26 per month on their present wages.

(b) Annual Paid Leave.—Nil award.

6. *Effective date and duration.*—This award shall be with effect from 1st February 1966, and shall remain in force for a period of 12 months.

- (a) Wages.*
- (b) Working Hours.*

- (d) Notice on Probation.*
- (e) Gratuity Payment.*
- (f) Effective Date.*

1. The Parties were heard in Nairobi on 4th February 1966, and relied on their written and verbal submissions.

GENERAL BACKGROUND

2. The Kenya Chemical Workers' Union shall hereinafter be referred to as the Claimants and Vijay Trading Company Limited shall hereinafter be referred to as the Respondents.

The Respondents were first approached by the Claimants in August 1965, for recognition. Discussions ensued and the Parties agreed on a recognition agreement in draft form on 26th October 1965. When the draft recognition agreement was submitted to the Claimants' General Secretary he made certain amendments and sent it back to the Respondents with whom it rests at present. So although a recognition agreement has been agreed upon it has not yet been signed.

There is a record of meetings having taken place between the Respondents and the Claimants' representatives on 26th, 27th, 28th October and 4th November 1965. At all these meetings D. Choto of the Federation of Kenya Employers was the Chairman. Various items were discussed and agreement was

reached on most of them. On 6th November 1965, the Claimants reported the existence of a trade dispute to the Minister for Labour. The issues in dispute were stated to be seven and a Conciliator was appointed on 13th November 1965. Following conciliation six items were left in dispute and these have been referred to the Industrial Court. The Parties signed the Notification of Dispute Form "A" on 14th December 1965, in accordance with the Trade Disputes Act, 1965.

MAIN SUBMISSIONS ON BEHALF OF THE CLAIMANTS

3. (a) *Wages*.—The Claimants stated that they did not wish to pursue their wage demands based on a grading system and suggested that there should be only two categories of workers, semi-skilled and unskilled. They demanded a wage of Sh. 450 per month consolidated for semi-skilled workers and a wage of Sh. 360 per month consolidated for unskilled workers. They submitted that the Respondents' offer of Sh. 155 per month, excluding house allowance, was not adequate. They submitted that these rates did not offer adequate remuneration to the employees and that there was room for further increases on these present rates. They urged the Court to consider that they were still a long way from their declared target of a minimum wage of Sh. 350 per month for the lowest-paid worker. They pointed out that before Kenya achieved her Independence, African workers had lived on starvation wages and had been exploited for nearly 70 years. It was only natural that these workers since Independence should try to raise their standard of living. The Claimants stated that the three East African Governments had laid emphasis on the need for a high wage economy, social security and old age pension schemes. School fees, taxes and the cost of living had risen in the last three years. The Claimants submitted that a single worker needed, for his bare necessities, a sum of Sh. 245 per month and a worker with a family required Sh. 498 per month. The Claimants urged the following points for the Court's consideration and suggested that these should be taken into account when wages were assessed:—

- (a) *Food*: to enable the employee and his family to get enough food every day to replace the energy used in living and working;
- (b) *Clothing*: enough clothes for an employee and his family to appear decently dressed with proper protection from the weather;
- (c) *Housing*: housing of a standard under which the employee and his family could live under healthy and hygienic conditions;
- (d) *Security*.
- (e) *Education*: an employee, his wife and children should be afforded the opportunity to develop talents and ability to the fullest extent.

In order to achieve the above, workers should be paid higher wages. The Respondents had not pleaded at any stage their inability to meet the cost of the Claimants' demands.

The Claimants also pointed out that at one stage the Respondents had offered them a Sh. 200 per month consolidated wage but that they did not accept it as it was not up to the figure they expected. The Claimants also stated that some of the negotiations which were alleged to have been carried out between them and the Respondents, in fact, were not carried out by the Claimants' representatives and that the people concerned in these negotiations were the employees of the Respondents who had no official status in the Claimants' Union. The Court should, therefore, disregard these negotiations to that extent.

(b) *Working Hours*.—The Claimants submitted that they wanted the present 45-hour week reduced to 42 hours as out of all the employers with whom they had negotiated and concluded agreements only four were still on a 44-hour week. The Claimants had at no stage refused to work hard and long hours but they expected to be paid wages which were commensurate with the amount of work done.

(c) *Sick Leave*.—The Claimants demanded 120 days' sick leave in any one period of 12 months, 60 days on full pay and 60 days on half pay. These demands they reduced, during the hearing to 30 days' sick leave on full pay followed by 30 days on half pay. They also dropped their demand for sick leave with pay during the probationary period. They submitted that their demands were in line with the current sick leave being paid in the country by the majority of employers.

(d) *Notice on Probation*.—The Claimants submitted that all employees who were on probation should be subject to one week's notice on termination of their employment or pay in lieu of such notice. This again they submitted was a fair and reasonable demand and requested the Court to endorse it.

(e) *Gratuity Payment*.—The Claimants demanded the following gratuity scheme which would cease on the implementation of the National Social Security Fund:—

(1) On completion of one to five years' service an employee should be paid a gratuity of one month's pay for each completed year of service;

(2) An employee who had completed five years' service but less than 11 years should be paid a gratuity of 1½ months' pay for each completed year of service, and that this should be increased to two months' pay in case of those employees who had completed 11 years' service or more.

They submitted that the National Social Security Fund did not make any provision for the past services rendered by employees, unlike the Tanzania legislation which catered for the past services of employees. They also pointed out that the President of the Republic had stated that the existing Provident Fund Schemes should not be wound up and that these would not be affected by the National Scheme. In these circumstances they requested the Court to award on the lines demanded by them.

(f) *Effective Date*.—The Claimants submitted that the effective date for the Court's award should be from 1st September 1965, and that the award should remain in force for a period of ten months from that date. Subsequently, during the hearing, they suggested that the commencement date should be 1st December 1965, with a duration period of 12 months. This they submitted would be equitable and fair.

MAIN SUBMISSIONS ON BEHALF OF THE RESPONDENTS

4. (a) *Wages*.—The Respondents stated that they were a small family business engaged in the manufacture of inks and hair oil. Their products were marketed below reasonable prices in order to appeal to the indigenous population. The Tanzania ban had affected 40 per cent of their products and competition was so keen that it was impossible to increase their sales in Kenya and Uganda. They also drew the Court's attention to the benefits in respect of which an agreement had already been reached, and submitted that many of these were higher than should normally be expected in a first agreement with a small company.

The Respondents submitted that their employees were unskilled workers carrying out very simple tasks of mixing and packing the various components, and that there were no skills involved. The Claimants had originally demanded a consolidated minimum wage of Sh. 250 per month and before the Court they had increased their demand to Sh. 360 per month. In the Notification of Dispute Form "A" they had demanded Sh. 300. In these circumstances the Respondents requested the Court to disregard these varying requests and to refer to the negotiations. The latest position reached in negotiations was the Claimants' demand of a basic minimum wage of Sh. 165 per month excluding house allowance which had already been agreed at Sh. 35 per month. The Respondents had raised their minimum scales to Sh. 150 per month. It was unfortunate that both Parties had refused to move after having reached this position. The Respondents submitted that Sh. 157/50 per month plus Sh. 35 house allowance was a fair wage considering all the circumstances.

(b) *Working Hours*.—The Respondents submitted that the present working hours were 45 per week and that the Claimants had failed to justify their case for reducing them. Although the Respondents had offered 44 hours per week during negotiations they now withdrew this offer. They pointed out that Government leaders were continually exhorting workers to work harder in order to build and develop the country's economy.

(c) *Sick Leave*.—The Respondents had originally offered 15 days on full pay and 15 days on half pay in each year. They submitted that bearing in mind that this was their first agreement with the Claimants and that workers at present had no entitlement to sick pay they would have been perfectly entitled to make no further offer. However, they had gone further and had offered 21 days' sick leave on full pay and 21 days on half pay and requested the Court to make an award based on this.

(d) *Notice on Probation*.—The Respondents submitted that both Parties had agreed to a three months' period of probation but could not reach agreement on the notice period. In their view a 24-hour notice to discharge unsuitable workers during the probation period was reasonable as many similar agreements existed in the country.

(e) *Gratuity Payment*.—The Respondents very strongly resisted this demand by the Claimants and submitted that there was no need at this stage for the employer to be burdened with this new responsibility as the National Social Security Scheme had already started. The Respondents were a small company trading on a small profit margin which had not enabled them to build up any reserve to deal with past services. It was to meet this position that the Government had introduced a National Social Security Fund Scheme. The President's statement on existing Provident Fund Schemes had no relevance to the present demand of the Claimants for past services. All

Unions had very strongly come out for the winding up of the existing schemes and it was only when they were told that it would not be in their interests to wind up these schemes that they had come out with this demand of gratuity pay for previous services.

(f) *Effective Date.*—The Respondents submitted that as this was their first agreement there was no question of having to take into consideration the ending of existing terms. It was usual in such cases for the agreement or award to date from the month in which the agreement or the award was read or announced. They had originally suggested an effective date of 1st February 1966, but during the hearing suggested to the Court an effective date of 1st January 1966, with a duration period of 12 months. They requested the Court to award on these lines.

AWARD

5. The Court has very carefully considered the submissions and arguments put forward by the Parties in making the following award:—

(a) *Wages.*—The Court awards that all employees shall get a wage increase of Sh. 15 per month on their present wage which together with a house allowance of Sh. 35 per month will constitute a new consolidated monthly wage.

(b) *Working Hours.*—The Court awards 44 working hours per week.

(c) *Sick Leave.*—The Court awards that after three consecutive months' service, an employee shall be entitled to sick leave up to a maximum of 21 days with full pay and thereafter to a maximum of 21 days with half pay in each period of 12 months' continuous service, subject to the employee producing a certificate of incapacity, covering each period of sick leave claimed, signed by a medical practitioner or person acting on his behalf in charge of a dispensary or medical aid centre:

Provided that an employee shall not be eligible for such leave in respect of any incapacity due to gross neglect on his own part.

(d) *Notice on Probation:*—

The Court awards that—

- (i) the services of an employee during the first month of probation may be terminated by either party giving 24 hours' notice;
- (ii) the services of an employee during the 2nd and 3rd month of probation may be terminated by either party giving one week's notice or pay in lieu thereof.

(e) *Gratuity Payment.*—The Court awards that on completion of four years' continuous service, an employee shall be entitled to ten days' pay for each completed year of service by way of gratuity to be based on the employee's salary at the time of the termination of his service. The effective date will be the date when the employee's contract of service commenced with the Respondents.

This part of the award shall cease with the implementation of the National Social Security Scheme in so far as this benefit shall then be provided for by the National Scheme. Employees shall, however, continue to benefit under this award for services rendered up to the date of the implementation of the National Scheme. For example, if an employee retires after eight years of service, having rendered five of them after the commencement of the National Scheme, then he shall be provided for the first three years on the basis of this award and the remaining five years will be subject to the National Scheme.

(f) *Effective Date.*—This award shall be with effect from 1st January 1966, and shall remain in force for a period of 12 months from that date.
