Senior Local Government Financial Officer (Four Posts), Ministry of Local Government (No. 104/66)

Salary scale.—£1,390 to £1,598. PENSIONABLE or AGREEMENT.

Applicants must possess at least the Intermediate Examination of a recognized professional accounting body (preferably the Institute of Municipal Treasurers and Accountants) and must have not less than three years' experience in local government accounting since qualifying. Duties are of a senior nature involving the assessment of the financial position of local authorities and the carrying out of audits and inspections. In respect of the latter the officers appointed will be gazetted as Inspectors and will be required to accept full responsibility for the conduct of audits and production of the relevant reports.

Accountant Grade I, Ministry of Health (No. 105/66)

Salary scale.—£1,390 to £1,598. PENSIONABLE or AGREEMENT.

Applicants should preferably be civil servants with not less than seven years' (four years if they possess a professional accounting qualification) experience of Government accounting work in a responsible position, some of which must have been as an Accountant Grade II, a thorough knowledge of the Exchequer system, Financial Orders and regulations, ability to advise on financial matters, prepare final accounts, control staff and conduct all correspondence on accounting matters. Candidates who are not civil servants will be considered provided they possess a professional accounting qualification and have not less than five years' accounting experience since qualifying.

Senior Instructor in Hygiene and Sanitation, Ministry of Health (No. 106/66)

Salary scale.—£1,390 to £1,598. PENSIONABLE or AGREEMENT.

Applicants must possess a Diploma in Health Inspection for Overseas Appointments plus a Certificate for Meat and Other Foods or any other recognized qualification issued by the Royal Society for Health, and must have considerable experience in a senior post. Duties include teaching of trainee Health Inspectors and Health Assistants, supervision of teaching staff and general administration.

Head of General Service, Voice of Kenya, Ministry of Information and Broadcasting (No. 107/66)

Salary scale.—£1,390 to £1,598. PENSIONABLE or AGREEMENT.

Applicants should possess either a degree in Arts of an approved university or a high level of artistic training with an acceptable qualification. Experience in broadcasting administration would be an advantage but is not essential if the candidate has the necessary high educational qualifications. Applicants should have a wide interest in current affairs and be fluent in spoken and written Swahili and English. Knowledge of journalism, mass communication, radio programme production, script writing and ability to control staff will be great assets. Duties consist of running a radio service, programme planning and supervision and direction of a team of radio producers.

Local Government Financial Officer, Ministry of Local Government (No. 108/66)

Salary scale.—£1,096 to £1,348. PENSIONABLE or AGREEMENT.

Applicants must possess the Intermediate Examination of a recognized professional accounting body (preferably the Institute of Municipal Treasurers and Accountants) and must have not less than one year's experience in local government accounting since qualifying and also a knowledge of auditing practice and procedure. The work involves auditing and inspection of the accounts and records of local authorities and applicants must be prepared to travel. Ability to control staff, conduct correspondence and compile reports is essential.

Senior Statistical Officer, Ministry of Economic Planning and Development (No. 109/66)

Salary scale.—£1,096 to £1,348. PENSIONABLE or AGREEMENT.

Applicants should have had several years' experience in an executive capacity in a large statistical organization and preference will be given to suitably experienced candidates who possess a degree in Economics, Agricultural Economics or a related subject. The successful applicant will be required to take charge, under the general direction of professional officers, of all aspects of the execution of large-scale field surveys, to control a large field staff together with junior executive officers, implement arrangements for the collection of statistical data by field staff and supervise the basic analysis of the data collected.

**Teacher/Technical Instructor (Farm Machinery), Agricultural Department (No. 110/66)*

Salary scale.—£630 to £1,075. AGREEMENT only.

Applicants should possess a Diploma in Agricultural Engineering and be thoroughly conversant with the theory and practice of maintenance and use of all types of tractors and farm implements. Should a candidate possess a degree in Agricultural Engineering he would be eligible for appointment on the scale £804 to £1,710. The post is at the Large Scale Farmers Training College, Thomson's Falls.

Bursar, Agricultural Department (No. 111/66)

Salary scale.—£850 to £1,060. AGREEMENT only.

Applicants must have a thorough knowledge of Government accounting, stores accounting and personnel procedures. Wide experience in a large educational institution is desirable and ability to control staff and conduct correspondence essential. The successful applicant will be responsible for the collection of fees, purchasing of equipment and stores, upkeep and security of buildings, grounds, furniture and vehicles. Experience of a residential institution would be advantageous as he will be responsible for the general administration of a residential hostel. He will be required to give a limited number of lectures on basic mathematics in addition to farm accounts and book-keeping. The post is at the Large Scale Farmers Training College, Thomson's Falls.

Community Development Officer (Four Posts), Community Development Department (No. 112/66)

Salary scale.—£850 to £1,348. PENSIONABLE or AGREEMENT.

Applicants should be between 25 and 35 years old and possess a degree or diploma of an approved university in Social Science or an equivalent qualification in a related field. Applications from candidates with lesser qualifications (but with a minimum of Cambridge School Certificate) will be considered only if the candidate can produce evidence of approved recent training and at least five years' service in Community Development in East Africa. Successful candidates will be posted to any district in Kenya to work in conjunction with a County Council to initiate and administer social development projects and serve as Executive Officer to the County Community Development Committee.

Sports Officer, Community Development Department (No. 113/66)

Salary scale.—£700 to £1,060. PENSIONABLE or AGREEMENT.

Applicants should have considerable experience in the organization of sports, particularly in the promotion of football, athletics and boxing, and should have experience in sports and recreational activities and training within districts. The successful applicant, who must have administrative ability, will be required to take over the work of fostering and organizing sports and the provision of courses in provinces.

Audit Officer (One Post), Examiner of Accounts (Three Posts), Ministry of Local Government (No. 114/66)

Applicants must be civil servants, preferably of Cambridge School Certificate standard of education, with at least three years' practical experience of Government accounting work or with a good knowledge of commercial or local government accounting principles. They should also possess auditing experience and must be able to supervise junior staff and write clear and concise audit notes and be prepared to travel.

**Housekeeper, Kenyatta National Hospital, Ministry of Health (No. 115/66)*

Salary scale.—£600 to £820. PENSIONABLE or AGREEMENT.

Applicants should have had considerable experience in large-scale catering and requisitioning of supplies and should be fluent in Swahili and English. A Domestic Science qualification would be an advantage. The successful candidate will be responsible for catering in the Resident Medical Officers' Mess and the Ismail Rahimtulla Wing of the hospital, including requisitioning of supplies, supervision of kitchen staff and general housekeeping duties.

*Local Government Financial Officer (Trainee) (Two Posts),
Ministry of Local Government (No. 116/66)*

The minimum educational qualification required is a Cambridge School Certificate with credits in English Language and Mathematics or a General Certificate of Education with passes in those subjects. Possession of a book-keeping certificate would be an advantage. The minimum training period is five years if all examinations are passed at the first attempt. Selected candidates will be appointed on temporary terms at a commencing salary of £268 in the scale £236 to £364. They will be required to pass the Royal Society of Arts Intermediate Examination in Book-keeping and Commercial Law before commencing a course of study for a recognized professional accountancy examination. On passing the Royal Society of Arts Examination trainees will be eligible for promotion to the scale £460 to £500 and on passing the Intermediate Examination of the professional accounting body for appointment on probation as Local Government Financial Officer on the scale £1,096 to £1,348.

*Statistical Assistant (Trainee) (Three Posts), Ministry of
Economic Planning and Development (No. 117/66)*

The minimum educational qualification required is a Cambridge School Certificate with credits in English Language and Mathematics or a General Certificate of Education with passes in those subjects but candidates will also be required to sit for a qualifying examination before interview for final selection. The training period is two years and trainees will be required to attend a nine months' course at the E.A. Statistical Training Centre in Dar es Salaam commencing in July 1966, provided that they are successful in obtaining the award of a United Nations Fellowship to the centre. Trainees will be appointed on temporary terms at a salary of £268 in the scale £236 to £364, but there will be the normal deduction from this if a United Nations Fellowship is awarded. On successful completion of the course at the Training Centre, and subject to satisfactory service, trainees will be eligible for advancement to the scale £460 to £500. They will then be given practical experience of work in various sections of the Statistics Division for a period of a year, at the end of which period, provided their work is satisfactory, they will be eligible for appointment on probation as Statistical Assistant, scale £670 to £820. There are prospects of promotion to higher grades.

THE INDUSTRIAL COURT

CAUSE No. 3 OF 1966

Parties:—

The Kenya Union of Commercial Food and Allied Workers
and

East African Breweries Limited

Issue in dispute:—

Compliance or non-compliance with the Agreement in respect of medical reimbursement for wives of employees.

1. The Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the Claimants and the East African Breweries Limited shall hereinafter be referred to as the Respondents.

2. The Parties were heard in Nairobi on 7th March 1966, and relied on their written and verbal submissions.

GENERAL BACKGROUND

3. On 21st February 1966, the Parties entered into an Agreement on terms and conditions of employment, and with the exception of Wages Schedule all clauses were back-dated to 1st November 1965. Clause 12 (ii) of this Agreement provides:—

"(ii) The Association will pay the expenses of medical treatment by an Approved Medical Authority in respect of a wife, as registered with the Association, of an established employee:

Provided that—

Such expenses in no case shall exceed the amount which would be levied by a Government Hospital in conformity with the Rules made under the Employment Act (as at 30th August 1965, as specified hereunder).

One wife only to be registered as eligible for the scheme. Claims in respect of Dental, Ocular or Maternity cases be excluded.

The Association reserves its right after consultation with the Union to amend or cancel this subclause in the event of substantial and unacceptable increases in the medical fees as above, or in the event of a National Scheme being introduced which materially alters employers' liability under the existing law.

The fees referred to as at 30th August 1965, are:—

Kenyatta (including Infectious Disease Section) and Coast Hospitals—Sh. 20 per admission.

All District Hospitals—Sh. 15 per admission.

These fees are in respect of any period of admission and cover operation fees, drugs and other care and treatment.

Children up to the age of 16 years—Free.

For out-patients—No fee."

Some time after the commencement of this Agreement, the Group Personnel Relations Manager of the Respondents issued a Circular No. 44. In this circular he stated that a photograph of the employee's wife should be affixed on the Form of Identification in respect of the Medical Reimbursement Scheme for Wives of Employees. On 23rd November 1965, the Claimants' General Secretary took strong objection to this circular. He stated that at no time during the negotiations had the question of photographs been discussed and felt that the Respondents were trying to introduce something new without having consulted them. On 25th November 1965, the Claimants reported the existence of a trade dispute to the Ministry of Labour and Social Services. The Permanent Secretary confirmed, after consultation with the Tripartite Committee, that the issue in dispute was one which could best be dealt with by a discussion between the Parties with the help of an officer of his Ministry. A meeting was arranged to this effect on Friday, 10th December 1965. As the issue could not be resolved, the Parties signed and submitted the Notification of Dispute Form to have the issue determined by the Industrial Court in accordance with the Trade Disputes Act, 1965.

MAIN SUBMISSIONS ON BEHALF OF THE CLAIMANTS

4. The Claimants submitted that on 17th August 1965, a lengthy discussion had taken place on the Medical Reimbursement Scheme and that the discussion had been resumed on 31st August 1965, on which day agreement had been reached. During all these negotiations, administrative difficulties in operating such a scheme had been considered, but at no stage had the Respondents mentioned the affixing of photographs on the "cards" for the purpose of registration. The Claimants stated that they felt very strongly that the introduction of these photographs was not part of their Agreement with the Respondents. Furthermore, they submitted that the Respondents were the only members of the Brewing Group who were trying to impose this system on the Claimants' members as they had got these "cards" printed without consulting anybody.

The Claimants pointed out that there already was a Medical Scheme in operation for certain other employees of the

Respondents, including Management, for which the Respondents did not require photographs for identification. The Claimants stated that photographs were now being required from their members because the majority affected were Africans and the Respondents alleged that there was a possibility of the scheme being abused. The Claimants submitted that they thought it was about time that foreigners began trusting the indigenous people of this country. There were several other medical schemes in this country, they stated, but no photographs had to be produced for identification purposes for these schemes and, up to date no complaints of abuse had been voiced on these schemes.

The Claimants asked that each employee should register his wife with the Respondents and that only the registered wife would participate in the scheme. The relevant clause provided for amendment or cancellation of the scheme in consultation with the Claimants, and this could easily be invoked if the Respondents could prove that the scheme was being abused. The Claimants objected to their members' wives' photographs being kept by Personnel Department staff where anybody could see them. In these circumstances, the Claimants requested the Court to find that the Respondents had not complied with clause 12 (ii) of their current Agreement.

MAIN SUBMISSIONS ON BEHALF OF THE RESPONDENTS

5. The Respondents submitted that the issue in dispute was not a trade dispute as it was clear that the provision of a benefit to a third party could not become part of the contract of service unless it could be made enforceable to ensure that there was no deviation from the canon "To create a contract there must be a common intention of the parties to enter into legal obligations". Further emphasized by "A contract of service is performable only by the parties thereto".

The Respondents drew the Court's attention to the actual wording of the agreed clause as follows:—

"The Association will pay the expenses of medical treatment by an Approved Medical Authority in respect of a wife."

This clause they submitted could be taken as having two main ingredients, firstly, the obligation of the Association to pay, expressed in the words "will pay the expenses" and then the obligation on the part of the employee to establish the latter part of the quotation "in respect of a wife". They submitted that the Claimants and their members had an obligation to ensure that the lawful wife of an employee was registered and that there must be a positive and continuing means of identification; failure to do so must render the provision unenforceable and therefore a nullity.

The Respondents submitted that a trade dispute did not lawfully exist as the Claimants had by their voluntary actions prevented this matter from becoming a lawful trade dispute. They stated that the Claimants should not rely on the argument that agreement in the Joint body was in itself adequate as it was clear by their subsequent actions that they had frustrated the Respondents from making effective provision for the benefit to become an enforceable part of the employees' terms of service. The Claimants' action subsequent to the agreement had made the agreed benefit incapable of implementation by the Respondents and, therefore, at no stage could it be deemed to have become part of the employees' terms of service and their contract of employment.

The Respondents submitted that the Claimants had frustrated the performance of the contract by rendering it impossible for them to comply with its terms and that two propositions sprang from this situation:—

- (1) that the Claimants by their actions in refusing to facilitate the lawful and continuing identification of the "wife" frustrated the contract made with the Respondents to grant such benefits to wives and thus the Respondents were relieved of any obligations to provide such treatment; and
- (2) by their action in frustrating that particular agreement they rendered it a nullity therefore it at no stage since August 1965, became an identifiable and enforceable part of the employees' contract of service or terms of labour thus it could not be the subject of a trade dispute within the meaning of that term as defined in the Act.

The Respondents submitted, without prejudice to the above, that it was their prerogative to decide in what manner the registration of an established employee's wife should take place and that they had in exercise of this prerogative decided that identification by photograph was the best one under the circumstances. The Respondents, therefore, requested the Court to confirm that their action in requiring photographs was within clause 12 (ii) of the Agreement and that they had not failed to comply with the current Agreement which existed between them and the Claimants.

AWARD

6. The Court has very carefully considered the submissions made by the Parties in coming to its conclusions.

The Court overrules the Respondents' submission that the issue concerning the treatment of an employee's wife is not a trade dispute.

The definition of a "Trade Dispute" in the Trade Disputes Act, 1965, is as follows:—

"means any dispute or difference between employers and employees, or between employees and employers, connected with the employment or non-employment, or with the terms of the employment, or with the conditions of labour, of any person, and includes an apprehended trade dispute."

The reimbursement of wives' medical treatment forms part of the current terms and conditions of employment of an employee and appears in Clause 12 (ii) of this Agreement. It is a part of the employee's benefits which he receives or should receive from the Respondents and therefore it becomes a trade dispute within the definition in the Trade Disputes Act, 1965, if there is any dispute relating to it.

The current Agreement between the Parties in clause 12 (ii) provides as follows:—

"12 (ii) The Association will pay the expenses of medical treatment by an Approved Medical Authority in respect of a wife, as registered with the Association, of an established employee."

As the Respondents have accepted to pay the expenses of medical treatment by an Approved Medical Authority in respect of a wife, as registered with the Association, of an established employee, the Court finds that how this registration of employees' wives is carried out is an important ingredient of this Agreement. But as the Agreement is silent on this point it is obvious that the Parties did not at any time direct their attention on how the registration may be carried out. The Court cannot accept that the Claimants have no say on this issue. This issue has been conceded by the Respondents and therefore all arrangements pertaining thereto should be carried out in consultation with the Claimants.

In these circumstances, without going into the merits of identification by photograph, the Court directs both Parties to get together at an early date and work out a satisfactory method of carrying out registration, a point which they neglected in the first agreement. Until such an agreement is reached, the Medical Reimbursement Scheme, in respect of employees' wives, cannot come into force.

THE INDUSTRIAL COURT (Second Division)

CAUSE NO. 10 OF 1966

Parties:—

Transport and Allied Workers' Union
and

International Aeradio (East Africa) Limited

Issue in dispute:—

Whether or not any agreement reached between the Parties, on terms and conditions of service in their current negotiations should take effect from 1st January 1966, or 1st June 1966, in view of the fact that the Industrial Court gave an award in June 1965, the duration of which was left open.

1. The issue in dispute was referred to the Industrial Court for settlement by the Minister for Labour in accordance with the provisions of the Trade Disputes Act, 1965.

The Parties were heard in Nairobi on 4th March 1966.

GENERAL BACKGROUND

2. Transport and Allied Workers' Union shall hereinafter be referred to as the Claimants and International Aeradio (East Africa) Limited shall hereinafter be referred to as the Respondents. The Respondents come under the Schedule of Essential Services in the Trade Disputes Act, 1965. The current dispute between the Claimants and the Respondents is over the effective date of their new agreement. The Claimants are the sole negotiating body recognized by the Respondents to represent all their unionizable workers in both their Communications and Printing departments. Both Parties appeared before the Court in Cause No. 13 of 1965.

MAIN SUBMISSIONS ON BEHALF OF THE CLAIMANTS

3. The Claimants submitted that any agreement reached out of current negotiations between them and the Respondents should take effect from 1st January 1966. To support this argument they pointed out that on 25th January 1965, they had submitted a memorandum of proposals on terms and conditions of service to the Respondents for negotiation and that any agreement reached as a result of negotiation should have been back-dated to 1st January 1965, in accordance with the provisions of their previous agreement. This, however, had not taken place as the Respondents had refused to negotiate on wages and the matter had been referred to the Industrial Court (Cause No. 13 of 1965).

The President of the Industrial Court had ruled that wages and other conditions of employment were open to negotiation, but once again, the Claimants stated, no agreement had been reached so the matter had been referred to the Industrial Court for settlement. On 28th October 1965, the Court's Award had been published. The Award was with effect from 1st June 1965, but no period of duration was given.

It was the Claimants' further submission that as the Court had not given any duration period to the Award that the Court was aware that the agreement between the Claimants and the Respondents would come to an end on 31st December 1965. At least, they stated, that had been their interpretation of the Award.

With this in mind, they stated that on 23rd December 1965, they had submitted a memorandum on revised terms and conditions of service to the Respondents. The Respondents had replied that "We will inform you as early as it will be convenient for us to meet you in the new year". At the subsequent meeting which had been held on 4th February 1966, the Claimants submitted that they had been surprised to hear the Chairman (Managing Director) state that negotiations could begin in May but no new agreement could be considered before 1st June 1966.

The Claimants requested the Court to award that the new agreement between them and the Respondents should be with effect from 1st January 1966.

MAIN SUBMISSIONS ON BEHALF OF THE RESPONDENTS

4. The Respondents submitted that as the Court's Award in Cause No. 13 of 1965 was with effect from 1st June 1965, without stating the duration of the agreement, they were entitled to consider that the duration should be in accordance with normal practice, which was not less than 12 months from the effective date of the Award. Neither Party had made any submissions on the duration of the Award nor had "duration" been an issue in dispute in Cause No. 13 of 1965.

On 28th October 1965, the Award in Cause No. 13 of 1965 was published and only a few months later the Claimants commenced putting pressure on them to negotiate a new terms of service agreement. The Respondents contended that this attitude was quite unreasonable and without precedent in industrial relations in Kenya. They stated that there was no history at all of any agreements being negotiated in as short a period as this.

The Respondents referred to previous agreements between them and the Claimants and pointed out that the Recognition Agreement had been signed in 1962. The first wages and conditions of service agreement was dated December 1962 and was for a period of 12 months. The next agreement applied from December 1963 and was for a period of two years with a proviso that either party could give two months' notice in writing after 12 months had expired. Notice had been given by the Claimants in February 1964, and the latest agreement had been signed on 20th May 1964. This also, was for a period of two years with the same proviso that either Party could give notice of alteration after 12 months had expired, the notice being that of two months.

The Respondents submitted that they were entitled to a similar type of agreement as that freely negotiated between the Parties and that the agreement should remain in force for not more than two years from 1st June 1965, and that notice of intention to seek alteration in the whole or in part may be given by either Party to the agreement on or after 1st June 1966, by giving two months' notice.

AWARD

5. The Court having given full consideration to the submissions of the Parties, awards as follows:—

The Claimants' submission that any agreement reached out of current negotiations between them and the Respondents should take effect from 1st January 1966, on the ground that their previous practice was that an agreement was for 24 months with an opener clause of two months' notice after the first 12 months, must fail in that the new effective date in their previous agreement was left open and could be any date after the first 12 months.

The Respondents' submission that because the Court's Award in Cause No. 13 of 1965 was with effect from 1st June 1965, without stating a duration period, they were, therefore, entitled to consider that duration should be in accordance with normal practice, which was not less than 12 months from the effective date must also fail, as this has not been the case in their previous agreements, and the effective date of any new agreement was a matter for negotiations between the Parties.

The Parties having failed to agree on an effective date of a new agreement the Court awards that any new agreement between the Parties shall come into effect on 1st April 1966.
