THE TRADE DISPUTES ACT, 1965

Senior Education Officer (Two Posts), Ministry of Education (No. 118/66)

Salary scale.—£1,839 to £1,989. PENSIONABLE or AGREEMENT.

Applicants should be professionally trained honours graduates of approved universities with considerable teaching experience, preferably up to Higher School Certificate level, and with a thorough knowledge of boarding school organization and administration. The vacancies are initially for the Headmasters of Homa Bay Secondary School and the Friends' School, Kamusinga, but the officers appointed are liable to transfer anywhere in Kenya.

Purchasing Officer (Supernumerary), Ministry of Works, Communications and Power (No. 119/66)

Salary scale.—£850 to £1,060. PENSIONABLE or AGREEMENT.

Applicants should be not less than 24 years old and should possess a B.Com. or similar degree of an approved university or an equivalent professional qualification. Experience in an executive capacity in a large stores organization is desirable and preference will be given to applicants who have gained such experience in a Government or Local Government organization, who have a sound knowledge of general supplies and are conversant with the law governing contracts and purchasing. Duties include locating and selecting sources of supply, interviewing suppliers' representatives, arranging discussions on sources of supply and costing, obtaining tenders, preparing contract documents for the supply of materials, conducting negotiations arising from this, inspection and examination, quality control, dealing with stores accounts, disposing of scrap and surplus materials and all general duties relating to this work.

Trade Officer Grade II (Two Posts), Ministry of Commerce, Industry and Co-operative Development (No. 120/66)

The minimum educational qualification acceptable is a Cambridge School Certificate Division II, but preference will be given to candidates possessing one or more of the following:—an approved degree with Commerce or Economics as a principal subject, a recognized qualification in accountancy or book-keeping or considerable commercial experience. Successful candidates will be required to undergo a short period of training in Nairobi before being posted to Provinces as District Trade Development Officers. Duties include supervising the traders' loans scheme, promoting the development of African traders and industrialists by training them in simple accounting and commercial practice and assisting the Provincial Trade Development Officer in the co-ordination and implementation of various development schemes instituted to promote economic expansion and increased Africanization of the economy. There are good prospects of promotion to higher grades.

Land Ranger, Ministry of Lands and Settlement (No. 121/66)

Salary scale.—£700 to £1,060. PENSIONABLE or AGREEMENT.

Applicants should be of at least Cambridge School Certificate standard of education and preferably between 25 and 35 years old. Willingness to travel and ability to deal with members of the public on matters affecting the ownership and development of land are essential. CAUSE NO. 5 OF 1966

Parties:—

The Kenya Timber and Furniture Workers' Union
and

The Furniture Manufacturers' Group of the Federation of
Kenya Employers

Issue in dispute:—

Rates of Wages.

1. The Parties were heard in Nairobi on 14th March 1966 and relied on their written and verbal submissions. At the hearing the Parties requested the Court to determine the effective date of the Court's Award.

2. The Kenya Timber and Furniture Workers' Union shall hereinafter be referred to as the Claimants and the Furniture Manufacturers' Group shall hereinafter be referred to as the Respondents.

GENERAL BACKGROUND

3. The Claimants obtained recognition from the Respondents on 16th December 1963, but until recently, the Parties had not produced any signed agreement regulating the terms and conditions of employment of the Respondents' employees. On 26th April 1965, the Claimants lodged demands relating to wages and fringe benefits with the Respondents. Meetings were held, following the receipt of the Claimants' demands, on 21st and 27th April 1965. At these meetings, agreement was reached and recorded on the following:—

Hours of Work.
Overtime.
Rates for Overtime.
Probationary Period.
Termination of Employment.
Warning Clause.
Workmen's Compensation.
Certificate of Service.
Annual Leave.
Gazetted Holidays.
Religious Holidays.
Maternity Leave.
Sick Leave.
Safari Allowance.
Protective Clothing.
Redundancy.
Supply of Milk.
Duration of Agreement.

However, the next series of meetings which took place on 15th May, 11th and 25th June 1965, all resulted in disagreement over one issue: whether or not wages should be calculated on the basis of an hourly rate or a monthly rate. On this issue there was complete disagreement and on 3rd July 1965, the Claimants declared a trade dispute and a Conciliator was appointed. Further meetings were held during August and September and eventually compromise was reached, at a meeting held on 2nd November on this issue. Following this agreement the first discussion took place as to the actual rate of wages, but once again negotiations could not proceed as there was no agreed job classification.

At a meeting held on 29th December 1965, a job classification was agreed which resulted in five groups for general labourers and carpenters with various Trade Test Certificates and a sixth group dealt with clerical staff. No agreement could, however, be reached on the actual rates of wages to be applied to the various groups and the Parties referred the matter to the Industrial Court on 12th January 1966, in accordance with the Trade Disputes Act, 1965.

MAIN SUBMISSIONS ON BEHALF OF THE CLAIMANTS

4. The Claimants submitted that the Respondents had used delaying tactics since December 1963, which was the reason for the absence of an agreement between them. Even the present dispute before the Court the Claimants pointed out, was on account of the initiative taken by them.

The Claimants stated that they had submitted the following demands to the Respondents on 26th April 1965:—

As against these demands, the Respondents had made very poor counter offers ranging from Sh. 175 for Group I to Sh. 300 for Group V and in Clerical Grades from Sh. 200 to Sh. 300. The Claimants stated that these offers were totally inadequate and that they were not prepared to accept them for the following reasons:—

- The Furniture Manufacturers had for a very long time paid extremely low wages;
- the Court's Award would result in the first agreement between them and they expected wages for their members to be brought in line with the general wage level in the country;
- the cost of living had gone up considerably;
- it was shameful that the Furniture Manufacturers paid only the Nairobi Statutory Minimum Wage to their employees.

The Claimants submitted that a single employee needed at least Sh. 242 per month to meet his bare necessities. They also drew the Court's attention to the fact that their members who had obtained technical skills, some had obtained Trade Test Certificates, after about four years' training, deserved higher wages for the extra skills they had acquired. In these circumstances, the Claimants requested the Court to make an award on the lines demanded by them. Finally, the Claimants requested the Court to back-date the award to 1st May 1965, as they put the entire blame for the delay in negotiations on the Respondents who had employed delaying tactics.

MAIN SUBMISSIONS ON BEHALF OF THE RESPONDENTS

5. The Respondents submitted that they were a Group which had been formed originally by six Furniture Manufacturers late in 1964, in an attempt to form a Group which would cover all Furniture Manufacturers in Kenya. Unfortunately the majority of companies had been most reluctant to join and it was only with a lot of persuasion that eventually, late in 1965, that this Group had been increased to its present strength of 19 companies, all of whom were in business in Nairobi. They pointed out that these 19 companies formed a minority of the Furniture Manufacturers in Kenya who appeared to number more than 60. The Respondents stated that they hoped the Claimants would make proper efforts in recruiting workers in the other companies who were not yet members of the Group.

The Respondents submitted that no agreement could be reached on the actual rates of wages for each Group because the Claimants barely moved from their original high demands, and that they, therefore, were not able to continue negotiations. The Respondents made it clear that their offers during negotiations had not been final and that they would certainly have moved up if the Claimants had given any indication of reducing their unrealistic demands.

The Respondents stated that, except for one issue, negotiations for all terms of service had been satisfactorily concluded and that it had been agreed during the discussions that a consolidated rate should be paid, i.e. taking into account housing allowance and leave travelling allowance, so that a clean wage could be determined. The Respondents submitted that the Furniture Industry in Kenya, was, in the main, composed of smaller units employing four to ten people, but that there were some units which employed 50 or more people. The small units had, up to now, largely been employing general labour at the general minimum rate laid down by Government

for the area in which their businesses were located. In making their offer on wages the Respondents stated that they had also taken into account the various factors concerned and the effect which large wage increases could have upon these smaller units.

The principle of a higher-wage economy was accepted by the Respondents but it was considered that at this time in the economic development of the country, the most important single factor was to provide the maximum amount of employment. If wages were increased unrealistically a lot of the Furniture Manufacturers would have to close down, and others would introduce automatic machines. This would result in further unemployment. In these circumstances the Respondents submitted that their offers were fair and reasonable and worthy of being confirmed by the Court.

On Effective Date, the Respondents submitted that if the Court's Award were made effective as from 1st April or 1st May 1966, and remained in force for a period of 12 months, they would be prepared to terminate the agreement on fringe benefits, which was for two years, on the same date as the wage award expired. They strongly rejected the Claimants' submission that they had been responsible for any delay in bringing negotiations to a speedy conclusion.

AWARD

6. After careful consideration of all the arguments put forward by the Parties, the Court awards the following minimum rates for the various groups:—

This Award shall be effective as from 1st April 1966, and shall remain in force for a period of 12 months from that date.

The Respondents' offer of terminating the agreement on fringe benefits also on the same date as this Award has been taken into consideration and that agreement, therefore, shall also expire when this wage Award ends.

THE INDUSTRIAL COURT

CAUSE No. 8 OF 1966

Parties:—

The Kenya Chemical Workers' Union
and

The London Fumigation Company (Kenya) Limited

Issue in dispute:—

Interpretation of clause 3 (b) of the Recognition Agreement as to whether the meeting between the Company and local officials was authorized to negotiate within the terms of the recognition and negotiation procedure agreed between the Company and the Union on 5th November 1963.

1. The Parties were heard in Nairobi on 10th March 1966 and relied on their written and verbal submissions.

2. The Kenya Chemical Workers' Union shall hereinafter be referred to as the Claimants and The London Fumigation Company (Kenya) Limited shall hereinafter be referred to as the Respondents.

GENERAL BACKGROUND

3. The Parties entered into an agreement relative to recognition and negotiating procedure on 5th November 1963. Clause 3 (b) of this Agreement deals with collective claims and reads as follows:—

"3. (b) Collective Claims

These shall mean any claims for alteration to terms of service regarding matters specified in clause 2 (a) of this Agreement, which may affect all employees or any group of employees of The London Fumigation Co. (K) Ltd.

(i) such claims shall be raised in writing with the Management by the Union's General Secretary or his authorized representative;

Note.—Clauses (ii), (iii) and (iv) are not relevant to the dispute.

(v) the Committee shall regulate its own procedure and elect its own Chairman. All agreements jointly reached shall be committed in writing and signed by both parties."

On 15th October 1965, the Branch Secretary of the Claimants' Mombasa Branch, which played a prominent part in all negotiations with the Respondents, wrote a letter to the Respondents' Manager making claims in respect of wages and other conditions of service; this letter was copied to the Claimants' General Secretary. The Respondents replied to this letter on 18th October 1965, not to the Branch Secretary but to the Claimants' General Secretary in Nairobi; there is no record of a copy of this letter having been sent to the Branch Secretary at Mombasa.

Subsequently, a meeting took place on 9th November 1965, between the Claimants, Mombasa Branch representatives and the Respondents, and although there is a record of what transpired at this meeting, there is no record that any agreement had been reached and signed.

On 1st December 1965, the Claimants' General Secretary wrote a letter to the Respondents objecting to this meeting of 9th November 1965, and stating that he would not be bound by any decisions taken at this meeting. The Respondents maintained that the meeting of 9th November 1965, was properly constituted and convened. A dispute having arisen on this issue, the Parties referred the matter to the Industrial Court on 29th January 1966, in accordance with the Trade Disputes Act, 1965.

MAIN SUBMISSIONS ON BEHALF OF THE CLAIMANTS

4. The Claimants submitted that the meeting of 9th November 1965, was outside the scope of clause 3 (b) of the Recognition Agreement as the demands were not submitted by their General Secretary or his authorized representatives. They stated that collective claims could only be submitted by the National General Secretary or his accredited representative who must be a person authorized by the National General Secretary to act on his behalf, and that such transfer of authority and responsibility must be communicated to the Respondents by the National General Secretary to avoid further confusion or doubt. The Claimants submitted that there was no evidence to prove that such authority had been given to the Branch Secretary to embark on collective negotiations with the Respondents.

In these circumstances, the claimants requested the Court to find that the meeting convened on 9th November 1965, between the Respondents and local officials was not authorized to negotiate within the terms of their recognition and negotiating procedure Agreement. And also that the Respondents should be ordered to accept the demands as submitted by the National General Secretary on 18th December 1965.

MAIN SUBMISSIONS ON BEHALF OF THE RESPONDENTS

5. The Respondents submitted that in so far as Mombasa affairs were concerned, the Claimants' Branch Secretary in Mombasa was, in fact, the authorized representative of the General Secretary in that area. The General Secretary was normally resident in Nairobi and only travelled to Mombasa as and when required. He had at no time notified them that the Mombasa Branch Secretary had no authority to act for him, nor did the General Secretary denounce any negotiations carried out by the said Branch Secretary.

The Respondents submitted that the first claim made by the Claimants was by letter from the Branch Secretary, Mombasa, dated 15th March 1965, making claims for increased wages; this resulted in a wage increase of Sh. 25 to all staff as from 1st May 1965. On 15th October 1965, another letter was received from the Branch Secretary, Mombasa, making certain claims in respect of conditions of service and of wages. After an exchange of correspondence a Negotiating Committee meeting was held on 9th November 1965. The Respondents pointed out that it was significant to note that up to this stage the Claimants' General Secretary had made no attempt to inform them that the Branch Secretary had no authority to deal with them, even although this had been the third of a series of meetings.

The Respondents drew the Court's attention to a letter from the Claimants' National General Secretary dated 1st December 1965, in which he made strong objection to the level of the wage offers made by them but that even at that stage he had not stated that his representative had no authority to meet them.

The Respondents requested the Court to confirm that the present wording of the Recognition Agreement authorized them to accept claims, provided that they were in writing and submitted by the Claimants' General Secretary or by his authorized representative. They submitted that there was no clause in the Recognition Agreement which made it necessary for them to have prior consent from the National General Secretary before they could accept claims or negotiate with his authorized representative in Mombasa.

AWARD

6. The Court has no doubt that the Claimants' Branch Secretary in Mombasa had in the past, on various occasions, conducted negotiations with the Respondents on behalf of the Claimants and their General Secretary. In these circumstances, the Respondents had ample justification for accepting the Branch Secretary as the authorized representative of the General Secretary.

On 15th October 1965, when the Branch Secretary wrote to the Respondents listing various demands, the Respondents, instead of replying to him, wrote to the General Secretary as follows:—

"Dear Sir,

This is to acknowledge receipt of your letter of 15th October from your Branch Secretary and to advise you that its contents are being carefully studied.

When we have had the opportunity of considering the various points raised we will communicate with you again."

This was the right thing to do but it appears that having followed the correct procedure up to this point, the Respondents erred in holding a meeting in November 1965, with the Branch Secretary and his two colleagues, in the absence of the General Secretary or a letter from him authorizing the Respondents to negotiate with the Branch Secretary. It was the duty of the

Respondents, after having written the above letter to the General Secretary, to inform him and request his participation in further negotiations. Therefore, the Court finds that the meeting in question did not take place in accordance with clause 3 (b) of the Recognition Agreement.

Further, the Court finds that even if the meeting were found to have been held properly and in accordance with the Recognition Agreement, the results of the meeting would in any case be ineffective as clause 6 (v) was not complied with. This clause states—

"(v) the Committee shall regulate its own procedure and elect its own Chairman. All agreements jointly reached shall be committed in writing and signed by both parties."

Considering all these aspects the Court awards that the meeting in question was not authorized to negotiate as provided in clause 3 (b) of the Recognition Agreement.
